Advocacy: the voice of small business in government

United States

The United States' 26.8 million small businesses provide economic opportunities to diverse groups of people and bring innovative products and services to the marketplace.* This profile from the Office of Advocacy compiles the latest facts and figures on the status and role of small business in the country. (Note that a small business is defined here as one with fewer than 500 employees.)

• The United States had 6.0 million small employers in 2006, representing 99.7% of the nation's employers and 50.2% of its private-sector employment.

- The health care and social assistance industry was the state's largest small business and overall employer in 2006 (Table 1).
- Small businesses created 78.9% of the nation's net new jobs from 2004 to 2005 (Table 2).
- The United States' real gross domestic product increased by 2.0% in 2007. Growth in the New England, the Rocky Mountain, Mid-Atlantic, and Southwest regions was above the national average; growth in the Great Lakes, Southeast, and Far West regions was below the national average; and the Plains region grew at the national level.
