Section 342 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, signed into law by President Obama on July 21, 2010, requires the establishment of an Office of Minority and Women Inclusion ("Office") at each Federal financial services agency to be responsible for matters relating to diversity in management, employment and business activities. Among other duties, the Director of each Office is charged with developing and implementing "standards and procedures to ensure, to the maximum extent possible, the fair inclusion and utilization of minorities, women, and minority-owned and women-owned businesses in all business and activities of the agency at all levels, including in procurement, insurance, and all types of contracts."

We write today to request an update on what steps you have taken and are taking to establish the Office and select the Director of the Office in your agency. We understand that some agencies may be limiting applications to employees currently employed by the agency or drafting the job description in such a way that it could be interpreted to limit applicants to those who are currently employed within the agency. If applications are being limited to inside employees, please explain your justification(s) for doing so. Also, what efforts are being made to advertise and promote the position outside of your agency?

We are also interested in the proposed organizational structure of these Offices, including the number of staff proposed for each Office.

We look forward to your prompt response.
