A Usability and Eye-Tracking Evaluation of the Economic Census Web Site

Abstract

In August 2008, the U.S. Census Bureau Statistical Research Division (SRD) conducted usability testing to evaluate the newly designed Economic Census (Econ) Web site. The testing evaluated the success and satisfaction of seven externally recruited participants with the Web site. Usability testing revealed several usability problems, including lack of visibility for the top navigation bar, non-informative information on the main page and multiple confusing ways to retrieve data. Recommendations were provided to the Econ team. This report provides a complete summary of the findings of this usability evaluation. Recommendations are provided to improve the usability of and satisfaction with the Economic Census Web site.

Executive Summary

In August 2008, the U.S. Census Bureau Statistical Research Division (SRD) conducted usability testing to evaluate the newly designed Economic Census Web site. The testing evaluated the success and satisfaction of externally recruited participants with the Web site. Testing took place at the U.S. Census Bureau Usability Laboratory in Suitland, MD.

Purpose. The primary purpose of the usability testing was to identify elements of the user interface design that were problematic and lead to less effective, less efficient and less satisfying experiences for people using the Web site.

Method. Seven participants were recruited externally through a database maintained by the Usability Lab. Participants were knowledgeable in navigating the Internet and using a computer, and all were unfamiliar with the Economic Census Web site. Each participant sat in a small room, facing one-way glass and a wall camera, in front of an LCD monitor equipped with an eye-tracking machine. The test participant and test administrator were not in the same room. The sessions were audio and video recorded, and tracking of the participants' eye movements were recorded during the usability tests.

While completing the ten tasks, participants were encouraged to think aloud and to share what they were thinking about the tasks. If at any time the participant became quiet, the test administrator reminded the participant to think aloud. The participant's narrative allowed the test administrator to gain a greater understanding of how they completed the tasks and to identify issues with the Web site. The test administrator noted any behaviors that indicated confusion.

After completing all tasks, the participants completed a Satisfaction Questionnaire then answered debriefing questions. Overall, each usability session ran about 60 minutes.

Results. The full report provides complete descriptions of each finding and recommendations for usability issues. The following section highlights issues and recommendations to resolve them.

1. Most participants, most of the time, missed the top navigation bar altogether. This led to a longer, less efficient route of finding information. **Recommendation:** Adjust colors in top navigation to have greater contrast. Make the navigation bar wider and include a white bar in between the header and top navigation. Make the lines in between the links more pronounced, perhaps in a different color. From the start, highlight Main on the top navigation.
2. The information on the main page is not informative enough to guide the user in an efficient manner. **Recommendation:** Organize information on the Main page according to novice users. Have a tutorial for first time users that details how to get data and information. Add a definitions link to common terms. Add a Search function, specific to the Economic Census Web site. Introduce another "layer" above the present structure that is less detailed and more over-arching.
3. There are multiple ways to get data that are confusing. **Recommendation:** Combine the "Using American FactFinder," "Get Data," and "Getting Data" links into one link.
4. There is hardly any information on the Methodology page that discusses the Methodology. **Recommendation:** Add more details about how 2007 Economic Census data was collected and processed.

5. The Contacts by Industry do not seem organized in a systematic way. **Recommendation:** Alphabetize the list of contacts.

Plan for Usability Test

1.0 Introduction

In preparation for the launch of the new Economic Census Web site, the Census Bureau Statistical Research Division (SRD) conducted usability testing to evaluate the newly designed site. The testing evaluated the success and satisfaction of the test participants with the Web site developed by the Economic Census team in the Economic Planning and Coordination Division (EPCD). Participants attempted to complete tasks supported by the Web site but developed specifically for the usability test. The findings and recommendations found in this study are designed to inform the designer on areas of satisfaction as well as areas where the participants struggled using the Economic Census Web site.

1.1 Background

The user interface is an important element to the design of a Web site. For a Web site to be successful, the user interface must be able to meet the needs of its user in an efficient, effective, and satisfying way. The present study was designed to examine the user interface of the Economic Census Web site, which is scheduled to be launched on October 31, 2008. Users of the Web site must be able to successfully navigate throughout the interface to find the appropriate information in an efficient and effective manner.

Two expert reviews were conducted prior to this usability test plan. One was conducted in February 2008 (Morgan, Beck, Trofimovsky & Murphy, 2008) and the other in July 2008 (Romano & Murphy, 2008). Changes to the Web site were made based on recommendations from both expert reviews.

1.2 Purpose

The primary purpose of the usability testing is to identify elements of the user interface design that are problematic and lead to less effective, efficient and satisfying experiences for people using the Web site.

1.3 Usability Goals

The usability goals for this study were defined in three categories: user accuracy, efficiency, and satisfaction. In this plan, these goals reflect the extent to which the user-interface was expected to support user performance and satisfaction.

Goal 1: To achieve a high level of accuracy in completing the given tasks using the Economic Census Web site. The user should be able to successfully complete 75 percent of the given tasks.

Goal 2: To achieve a high level of efficiency in using the Economic Census Web site. The user should be able to complete the tasks in an efficient manner taking four minutes or less to complete each task. In addition, the user should look at the AOIs five minutes or less into the study.

Goal 3: To experience a moderate to high level of satisfaction from experience using the Economic Census Web site. The overall mean of the Satisfaction Questionnaire ratings should be well above the mean (5 or above on a nine-point scale, where 1 is the lowest rating and 9 is the highest rating). The same should be true for the individual Satisfaction Questionnaire items.

1.4 Scope

All user interactions with the Economic Census Web site are within the scope of the usability evaluation. The user interface design was not tested for compliance with the Section 508 regulations at

this time. However, since this is a government Web site, before the Web site becomes available for use, it must comply with Section 508 regulations unless a waiver has been granted.

1.5 Assumptions

- Participants were external, non-federal employees who were recruited via the SRD Usability Lab database.
- Participants had at least one year of prior Internet and computer experience.
- Participants had prior knowledge of how to navigate a Web site.
- Participants did not have extensive prior experience using the Economic Census Web site.

2.0 Method

2.1 Participants and Observers

Eight participants were recruited externally through a database maintained by the Usability Lab. One participant was removed from the analysis due to inexperience navigating through the Internet observed during the usability testing. The remaining participants were considered knowledgeable in navigating the Internet and using a computer. All were unfamiliar with the Economic Census Web site. Prior to beginning the tasks, the participants were briefly informed about the purpose of the study and the uses of data that are collected during the study. Observers from the Econ team were invited to watch the usability tests on television screens in a separate room from the participant and test administrator. At the end of each test session, the test administrator and observers had the opportunity to discuss the findings from that session and compare them to findings from other sessions. See Table 1 for participant demographics.

2.2 Facilities and Equipment

Testing took place at the Usability Lab at the U.S. Census Bureau in Suitland, MD, Room 5K509.

2.2.1 Testing Facilities

The participant sat in a small room, facing one-way glass and a wall camera, in front of an LCD monitor equipped with an eye-tracking machine that was on a table at standard desktop height. The test participant and test administrator were not in the same room. During the usability test, the test administrator was in the control room on the other side of the one-way glass. The test administrator and the test participant were able to communicate via microphones and speakers.

2.2.2 Computing Environment

The participant's workstation consisted of a Dell OptiPlex GX150 personal computer with a Pentium IV processor and 512 MB of RAM, a Tobii LCD monitor equipped with cameras for eye tracking, a standard 101/102 key quiet keyboard, and a PS2 IntelliMouse with a wheel. The operating system was Windows XP.

2.2.3 Audio and Video Recording

Video of the application on the test participant's monitor was fed through a PC Video Hyperconverter Gold Scan Converter, mixed in a picture-in-picture format with the camera video, and recorded via a Sony DSR-20 digital Videocassette Recorder on 124-minute, Sony PDV metal-evaporated digital videocassette tape. Audio for the videotape was picked-up from one desk and one ceiling microphone near the test participant. The audio sources were mixed in a Shure audio system, eliminating feedback, and fed to the videocassette recorder.

2.2.4 Eye-Tracking

Tracking of the participant's eye movements was recorded during the usability test. Using the ClearView 2.0 software program, the Tobii eye-tracking device monitored the participant's eye movements and recorded eye gaze data. This type of eye tracking required the calibration of each eye. Data collected from the eye tracking device included eye gaze position, timing for each data point, eye position, and areas of interest. Areas of interest (AOIs) were defined prior to the usability evaluation as areas that are of particular interest to the evaluator. For this study, in collaboration with the sponsor, we identified the following AOIs: (1) top orange navigation bar, (2) left navigation, and (3) main AFF link: Get Economic Census Data. See [Appendix A](#).

2.3 Materials

2.3.1 General Introduction

The test administrator read some background material and explained several key points about the session. See [Appendix B](#).

2.3.2 Consent Form

Prior to beginning the usability test, the participant completed a consent form. See [Appendix C](#).

2.3.3 Questionnaire on Computer Use and Internet Experience

Prior to the usability test, the test participant completed a questionnaire on his or her computer use and Internet experience. See [Appendix D](#).

2.3.4 Tasks and Task-based Goals

Members of the Economic Census team, as well as members of the Census Bureau's Usability Lab, created the tasks and the task-based goals. The tasks were designed to capture the participant's interaction with and reactions to the design and functionality of the Economic Census Web site. See [Appendix E](#).

2.3.5 Satisfaction Questionnaire

Members of the Usability Lab created the Satisfaction Questionnaire, loosely based on the Questionnaire for User Interaction Satisfaction (QUIS, Chin, Diehl, and Norman, 1988). In usability tests at the Census Bureau, typically 10 to 12 items are used that are tailored to the particular user

interface being evaluated. In this study, the Satisfaction Questionnaire included 10 items worded for the Economic Census Web site. See [Appendix F](#).

2.3.6 Debriefing Questions

After completing all tasks, the participant answered debriefing questions about his/her experience using the Econ Web site. See [Appendix G](#).

2.3.7 Payment Voucher

Upon completion, the participant signed and dated a payment voucher. See [Appendix H](#).

2.4 Procedure

Each test participant separately reported to the usability lab at the U.S. Census Bureau. Upon arriving, the test participant was seated in the testing room. The test administrator greeted the participant and read the general introduction. Next, the participant read and signed the consent form. After signing the consent form, the test participant completed the Questionnaire on Computer Use and Internet Experience. During this time, the test administrator left the task questions and Satisfaction Questionnaire on the desk beside the participant and left the testing room to do a sound check in the control room. Upon completion of the questionnaire, video recording began, and the participant's eyes were calibrated. Calibration consisted of the participant looking at a dot moving around the computer screen and took approximately fifteen to twenty seconds. Once calibration was complete, the eye tracker began recording data.

Following calibration, the participant completed the Economic Census Web site tasks. At the start of each task, the participant read the task aloud. While completing the tasks, the participants were encouraged to think aloud and to share what they were thinking about the tasks. If at any time the participant became quiet, the test administrator reminded the participant to think aloud. The participant's narrative allowed the test administrator to gain a greater understanding of how they completed the tasks and to identify issues with the Web site. At the conclusion of each task, the participant stated their answer to the task aloud. During the task, the test administrator noted any behaviors that indicated confusion, such as hesitation, backtracking and frowning. After completing all tasks, the eye tracking device was stopped, and the participant completed the Satisfaction Questionnaire.

After the participant completed the Satisfaction Questionnaire, the test administrator returned to the testing room where the test participant answered the debriefing questions. This was an opportunity for a conversational back and forth exchange where the test administrator remained neutral. At the conclusion of the debriefing, the video recording was stopped. Overall, each usability session ran about 60 minutes.

2.5 Performance Measurement Methods

2.5.1 Accuracy

After each participant completed a task, the task was rated as a success or a failure. In the context of usability testing, successful completion of a task means that the design supported the user in reaching a goal. Failure means that the design did not support task completion. A successful task involved the test participant successfully navigating the user interface to identify the correct piece of information on the Web site based on the task objective. If the participant struggled to find the information, but eventually arrived at the correct response, this was marked as a success. A failure was recorded when

the user interface presented obstacles to the participant's attempts to identify the correct piece of information.

The average accuracy score is divided into two different means: (1) accuracy across the participants and (2) accuracy across the tasks. Prior to the usability study, the sponsor and the Usability Lab set an overall accuracy goal of 75 percent across the participants.

2.5.2 Efficiency

After all usability tests were complete, an average time taken to complete each task was calculated. In addition, time to look at the AOIs was calculated. An average across all participants was calculated for each of the three AOIs.

2.5.3 Satisfaction

After completing the usability session, each participant indicated his/her satisfaction with the Web site using the tailored ten-item Satisfaction Survey. For example, participants were asked to rate their overall reaction to the site by circling a number from 1 to 9, with 1 being the lowest possible rating and 9 the highest possible rating. From the Satisfaction Survey data, we report ranges and mean scales values for the various rated attributes of the Web site. We also identify below-mean values, which indicate that problems exist even when the overall mean is acceptable or better.

2.5.4 Eye Tracking

Eye tracking captures exactly where people look as they navigate through a Web site. We can look at an individual's pathway through a site as well as accumulate data and show the common pathways through a Web site. Eye tracking measures include fixations, gazes, scanpaths and hotspots. A fixation is an instant where the eyes are relatively still. Fixations last 218 milliseconds, on average (Poole & Ball, 2005). Although the meaning of differing lengths of fixations is a matter of discussion among experts, there is some evidence for the following interpretations (Poole & Ball, 2005). During an encoding task, such as looking at a Web page, higher fixations indicate an area of interest and/or that the target may be complex and difficult to understand. During a search task, higher fixations indicate greater uncertainty in identifying the target object and/or the length of fixation indicates processing time. For the purposes of this usability test, the tasks fall into both the encoding and search categories. The analysis of high number of fixations will be specific to the given task.

A gaze is the total number of fixations in a given area across all subjects. Gazes indicate which areas are getting the most attention (Poole & Ball, 2005). We were able to see the exact gazes of the individual participants, as well as a mean across all participants. Here, we identify gazes for predetermined AOIs.

A scanpath shows the search – fixate – search sequence. In a task involving searching, a straight scan path is optimal with short fixation time at the target; a longer-lasting scanpath demonstrates less effective searching, and a long-length scan path is an indication of inefficient searching (Poole & Ball, 2005).

A hot spot is an area of the screen where people spend a few moments looking. Hot spots can be examined individually or can be collapsed across participants for a mean image that displays the average of all hot spots for all the participants together. Hot spots taken together form a heat map with a range in color from green (short amount of time fixating) to red (long amount of time fixating). Here, we examine predefined AOIs and determine whether or not these areas are hot spots.

2.5.5 Identifying and Prioritizing Usability Problems

To identify design elements that caused participants to have problems completing the task objectives, the test administrator recorded detailed notes during the usability session. To reinforce notes recorded during the usability session, the test administrator used the videotape recordings to refresh memory and to confirm findings. By noting participant behavior and comments, the test administrator in cooperation with additional usability staff members, inferred the likely design element that caused the participant to experience difficulties. The usability issues were grouped into categories based on priority. The findings and recommendations of these issues are presented below.

The usability team assigned each problem a priority code, based on its effect on performance, as follows:

- *High Priority* – These problems bring the test participant to a standstill. He or she is not able to complete the task.
- *Medium Priority* – These problems cause some difficulty or confusion, but the test participant is able to complete the task.
- *Low Priority* – These problems cause minor annoyances but do not interfere with the flow of the tasks.

3.0 Results and Recommendations Based on Usability Testing

Results from the usability testing are discussed below. The quantitative data, usability findings, and eye-tracking data are presented. See [Appendix I](#) for raw behavioral data and eye tracking data.

3.1 Participant Accuracy

The overall accuracy score was 56 percent. Accuracy scores ranged from 30 percent to 90 percent across users and from zero to 86 percent across tasks. Although some questions included wording that provided hints to users, the accuracy scores were still not in line with the 75 percent accuracy goal. It appears that participants struggled the most with tasks # 7, #8 and #9. For task #7, no participants completed the task accurately. For task #8, one participant completed the task successfully, and for task #9, three participants completed the task successfully. See Table 2 for user accuracy scores, [Appendix E](#) for the complete tasks and [Appendix I](#) for raw behavioral data.

As can be seen in the raw data in [Appendix B](#), there was no clear trend in performance for tasks #7, #8 and #9. This suggests that there is no clear path that participants followed to get to the desired information. Participants clicked back and forth and searched around the site rather than finding an obvious route to the desired information. In fact, tasks #7 and #8 had the highest amount of back button hits (21 and 40, respectively) and task #10 had the highest number of attempts (three participants; 43 percent) at using Search [which does not exist- the Search on this Web site is specific to North American Industry Classification System (NAICS) codes].

3.2 Participant Efficiency

The average time to complete each task was 2.63 minutes, which is within the set goal of 4 minutes or less. The users were able to complete the tasks in an efficient manner. However, only 39 responses (56 percent) were correct and included in this calculation. See Table 3 for detailed times to complete each task and [Appendix E](#) for a complete list of the tasks.

Table 4 reports the time that elapsed before looking at each AOI. For the top navigation, four participants looked at the area in the first task, one looked at it in the second task, one in the third task and one in the sixth task. The average time elapsed before participants looked at the top navigation was 6 minutes 39 seconds.

For the left navigation, four participants looked in that area in the first task, one looked at it in the second task, one in the fourth task and one in the seventh task. The average time elapsed before participants looked at the left navigation was 6 minutes 1 second.

For the main AFF link, four participants looked in that area in the first task, one looked at it in the second task, one in the fourth task and one in the sixth task. The average time elapsed before participants looked at the main AFF link was 5 minutes 25 seconds. Each of these results was not within the set goal of looking at the AOI within five minutes from the start of the study.

3.3 Participant Satisfaction

The average satisfaction score was 5.93, which is above the mean, but not *well* above, which was the goal set for the Web site. Although the means were quite high for satisfaction by question, some individual participant mean ratings were quite low. Ratings below the mid-point of the scale indicate issues that may affect other users. It is well known that users tend to give higher satisfaction ratings than might be expected from their accuracy scores (Andre & Wickins, 1995; Beck & Murphy, 2008; Malakhoff, 2007). Thus, it is not surprising that the satisfaction scores are closer to the set goal than the accuracy scores are. 3.4 Eye Tracking Findings

3.4.1 Gazes

A gaze is the total number of fixations in a given area across all tasks. Tables 6, 7, and 8 show the gazes for each of the three AOIs. Participants looked at the left navigation the most, followed by the top navigation, and then the main AFF link. The top navigation was looked at 293 total times across all participants across all tasks, with a range of five to 49 across tasks and a range of one to 97 across participants. The left navigation was looked at 742 total times across all participants across all tasks,

with a range of zero to 236 across tasks and a range of four to 337 across participants. The main AFF link was looked at 134 total times across all participants across all tasks, with a range of one to 54 across tasks and a range of four to 54 across participants. These results demonstrate that participants do not always look at the important AOIs and often miss the main AFF link altogether. Furthermore, there are inconsistencies across participants demonstrating that participants have different ways of approaching the Web site.

3.4.2 Hot Spots

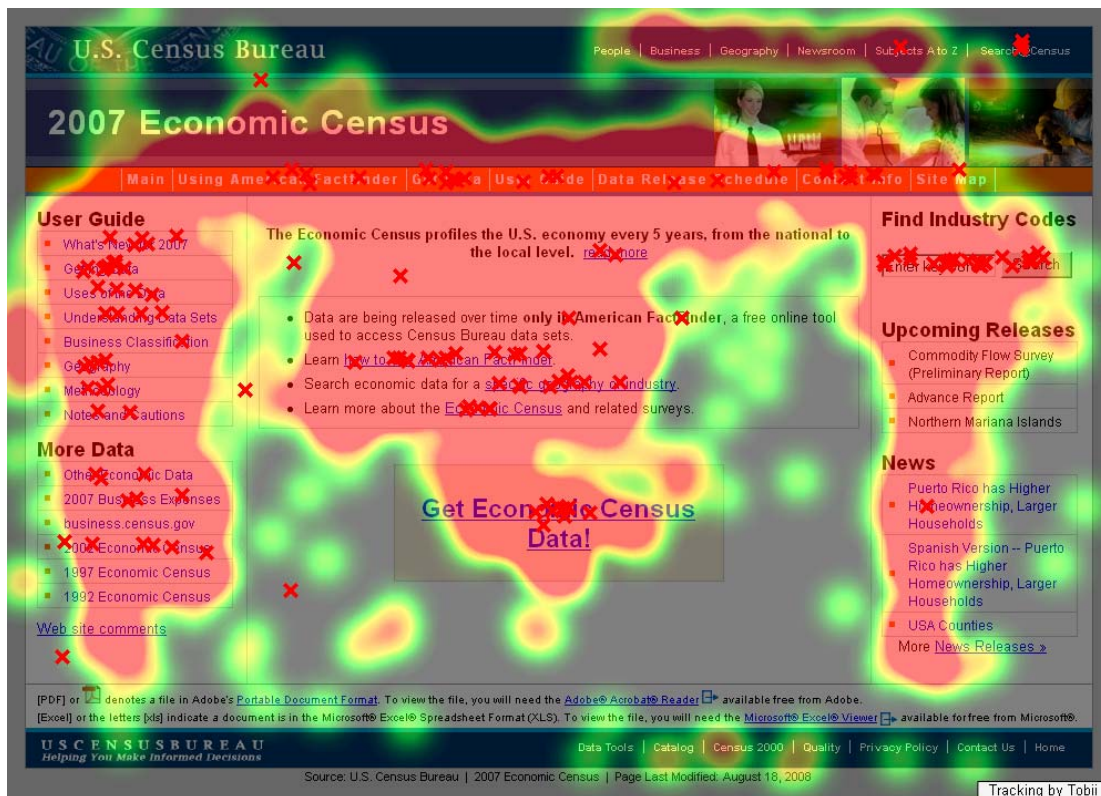


Figure 1. Heat Map for All Participants Across All Tasks.

The hot spot data indicates areas where participants spent some time looking. Figure 1 shows the heat map for all participants across all tasks. The reds and the oranges indicate longer fixation times, while the green indicates shorter fixation times. As can be seen, no important piece of information on the Main page of the Web site was overlooked.

3.5 Positive Findings

1. Most participants commented that the layout of the Web site was clear. Participants liked the consistency of the top navigation and the left navigation.
2. Six out of seven participants responded positively to the color scheme, noting that the colors were good and “easy on the eyes.”
3. Most participants commented that the Economic Census Web site had a good layout. Some commented that even when things were not obvious, it was easy to back up and try again.
4. Participants were quickly able to locate the Contact Information.
5. Six out of seven participants were quickly able to figure out how to sort rows on a data set.

3.6 Usability Problems

Reasons for the performance deficits are discussed in the list of usability violations that follows. The usability problems are prioritized from high to low in terms of their effect on participant performance. The usability issues deal primarily with difficulty in locating certain pieces of information within the Web site. Fixing the high and medium priority problems as they occur throughout the Web site should result in improvement in the participants’ performance using the Web site and improved satisfaction.

[Appendix I](#) contains the raw data collected from the usability test from which we derived the findings and recommendations.

3.6.1 High Priority Issues

Testing identified two high priority usability issues. These issues caused participants to struggle to the point that they were unable to recover and complete the task successfully.

3.6.1.1 Top Navigation Bar

Most of the time most participants missed the top navigation bar altogether. Once they scrolled over and noticed the change in color, they then were able to use the navigation buttons. This led to a longer, less efficient route of finding information. For example, task #4 requires the user to click on the “Data Release Schedule” link in the top navigation bar. Of the five participants who successfully completed the task, only one was able to do so immediately. Four of the five were able to complete the task, but only after many attempts and searches all over the Web site. As can be seen in the eye tracking data in [Appendix I](#), four out of six participants¹ did not look at the top navigation for task #4. In fact, the mean time across participants to look at the top navigation was six minutes and 39 seconds (range 3 seconds – 25 minutes and 21 seconds). See [Section 3.4.1](#) of this report for detailed data of when participants first looked at the top navigation.

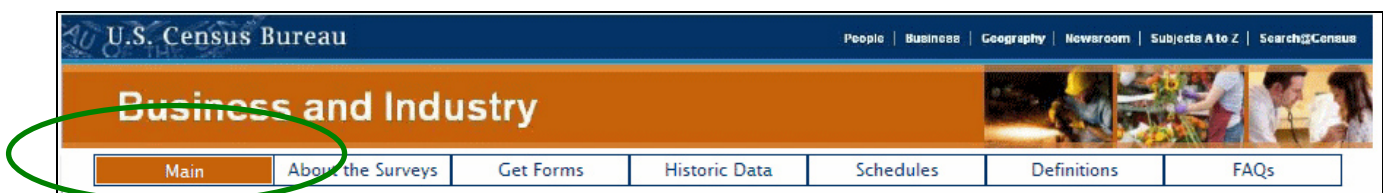


Figure 3. Example of Main Link Highlighted in Top Navigation.

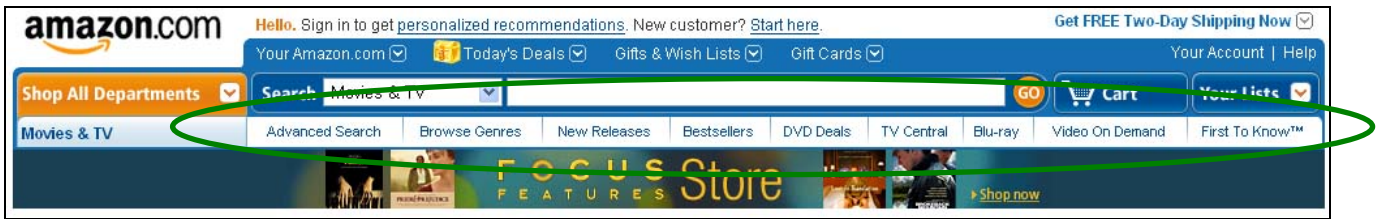


Figure 4. Example of Words in Top Navigation in a Contrast Color.

Recommendation: Adjust colors in top navigation to have greater contrast. Figures 2, 3 and 4 display contrasting colors in the top navigation. Make the navigation bar wider and include a white bar in between the header and top navigation. As it is now, the top navigation looks like it is part of the header; white space would separate the two. See Figures 2 and 3 for examples of white space between the header and top navigation. Make the lines in between the links more pronounced, perhaps in a different color. Figures 2, 3, and 4 display pronounced lines in between the links. From the start, highlight Main on the top navigation. This will bring attention to the top navigation bar and inform users that they are currently on the Main page. See Figure 3 for an example.

3.6.1.2 Information on the Main Page

The information on the main page is not informative enough to guide the user in an efficient manner. Oftentimes, users are able to complete tasks, but only after searching the Web site and using the back button frequently. As can be seen in the raw data in [Appendix I](#), participants used the back button frequently for many of the tasks, and many participants attempted to use the Search function on more than one occasion. Four out of seven participants looked for a glossary of terms. Jumping around the Web site was frustrating for many participants as users generally want to get information in the fewest possible steps (Lynch & Horton, 2001, p. 22) Furthermore, in debriefing, many participants stated that they felt that it was easy to find information, but only after they were on the right track and had searched around.

Recommendation: Organize information on the Main page according to novice users. Perhaps have a tutorial for first time users that details how to get data and information. Add a definitions link to common terms. Add a Search function, specific to the Economic Census Web site. Figure 4 displays a Search bar that is specific to the site. It is located in the upper right corner, where users expect to find it, and it is clearly marked so that users know that they are searching the site and not the NAICS codes. Introduce another “layer” above the present structure that is less detailed and more over-arching. When the user clicks on options, go into specific details. For example, begin with the Main page, then a Pathway page, followed by the Information page (Redish, 2007, p.114). Users typically read only a few words of a page before deciding if it has what they are looking for (Redish, 2007, p.102), so keep the information clear and concise.

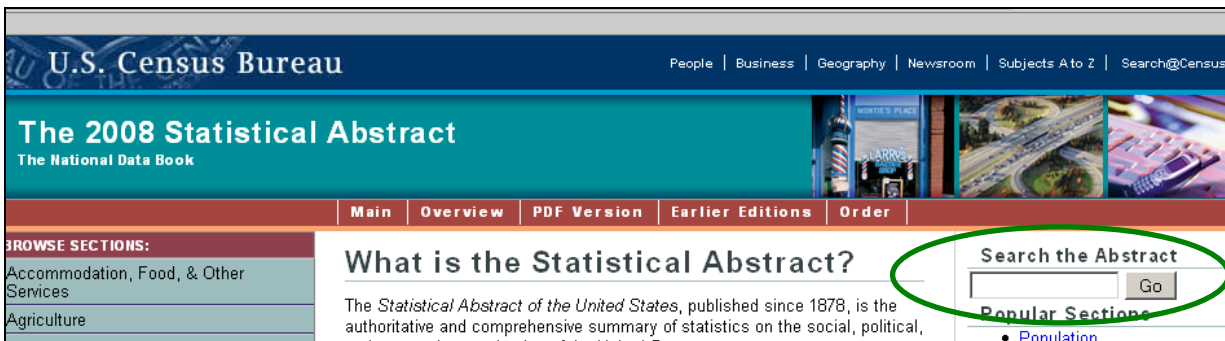


Figure 5. Example of Search Bar Specific to the Site.

3.6.2 Medium-Priority Issues

These issues caused participants to struggle; however, the participant was eventually able to overcome the issue and complete the task successfully.

3.6.2.1 Multiple Ways to Get Data

The “Get Data” link in the top navigation takes users off the Economic Census Web site to the American FactFinder Web site. Of the six times in this study that the link was clicked, participants

were confused and hesitant about what they should do next. Most did not realize that they had been taken off the Economic Census Web site. In fact, people expect that the list of links at the top of the page will keep them on the same Web site and not take them to another site (Redish, 2007, p.258). Furthermore, the “Getting Data” link on the left navigation takes users to a different place - to specific information about the Economic Census.

Recommendation: Combine the “Using American FactFinder,” “Get Data,” and “Getting Data” links into one link. For example, eliminate the “Using American FactFinder” link from the top navigation, and when users click on “Get Data” on the top navigation, the first page will be the one that currently is under “Using American FactFinder.” This page gives information about how to get data, how to manipulate data, how to save data, etc. The first link on the “Using American FactFinder” page takes users off the Economic Census Web site onto the American FactFinder Web site. This route of getting data while gaining information from the Web site is more consistent with what users expect (Redish, 2007), as they are not expecting to be taken off the Economic Census Web site when they click on “Get Data.” In addition, add a link on this page that specifies how to find codes that are relevant for Economic Census data, presently the page that a user gets by clicking on the “Getting Data” in the left navigation. Then, from there, users can find more information about codes, or if they are expert users, they can go right on to AFF. Both the top navigation and left navigation links should have the same name.

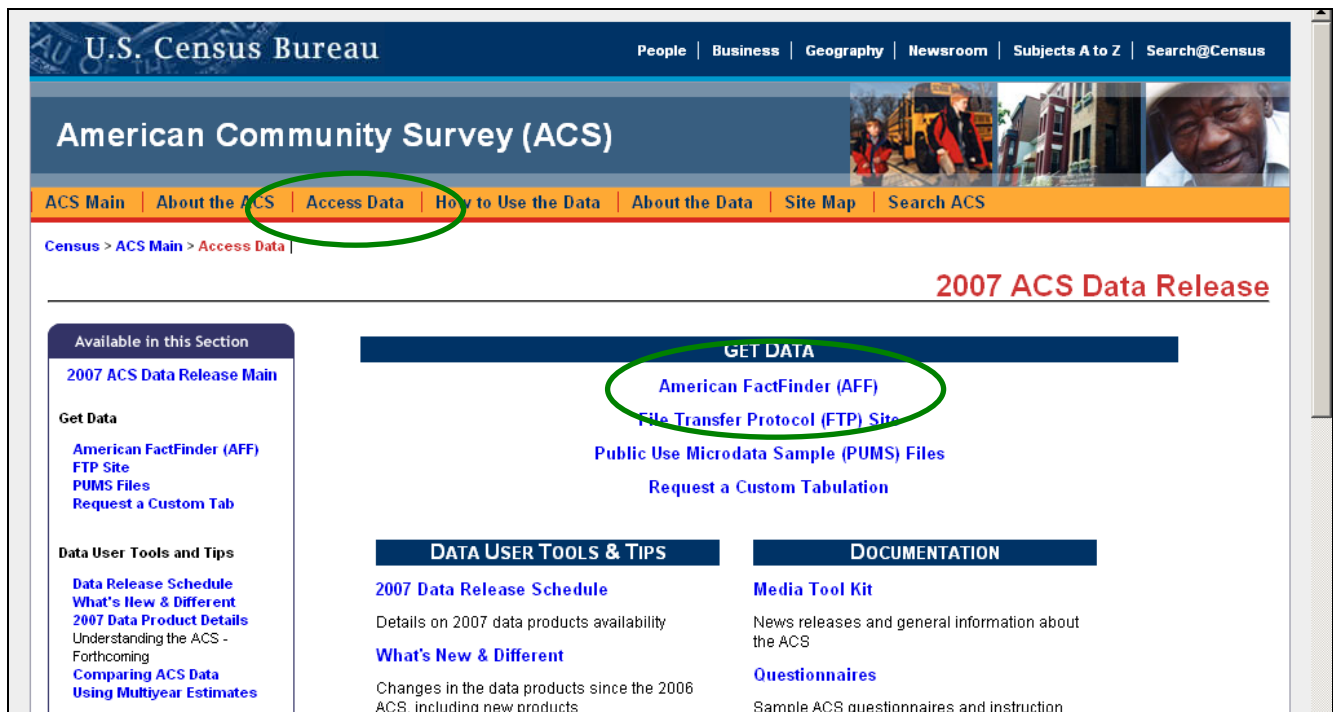


Figure 6. Example of Intermediary Page Before Going to American FactFinder.

American Community Survey (ACS) uses a similar route for users to get data. See Figure 6. We do not recommend following the exact layout that ACS currently uses, but rather use this as a template for an intermediary page between “Get Data” and American FactFinder. Include on this page the two lines that are currently at the top of the “Using American FactFinder” page that introduce American FactFinder.

3.6.3 Low-Priority Issues

These problems caused minor annoyances but did not interfere with the flow of the tasks.

3.6.3.1 Methodology Section

The first sentence on the Methodology Web page claims that, “This methodology section contains general information about how the 2007 Economic Census was collected and processed.” However, there is hardly any information on the Web page that discusses the Methodology, which is what it claims to do. See Figure 5 for the present design. When participants arrived at the page, they wanted to continue forth to find more information.

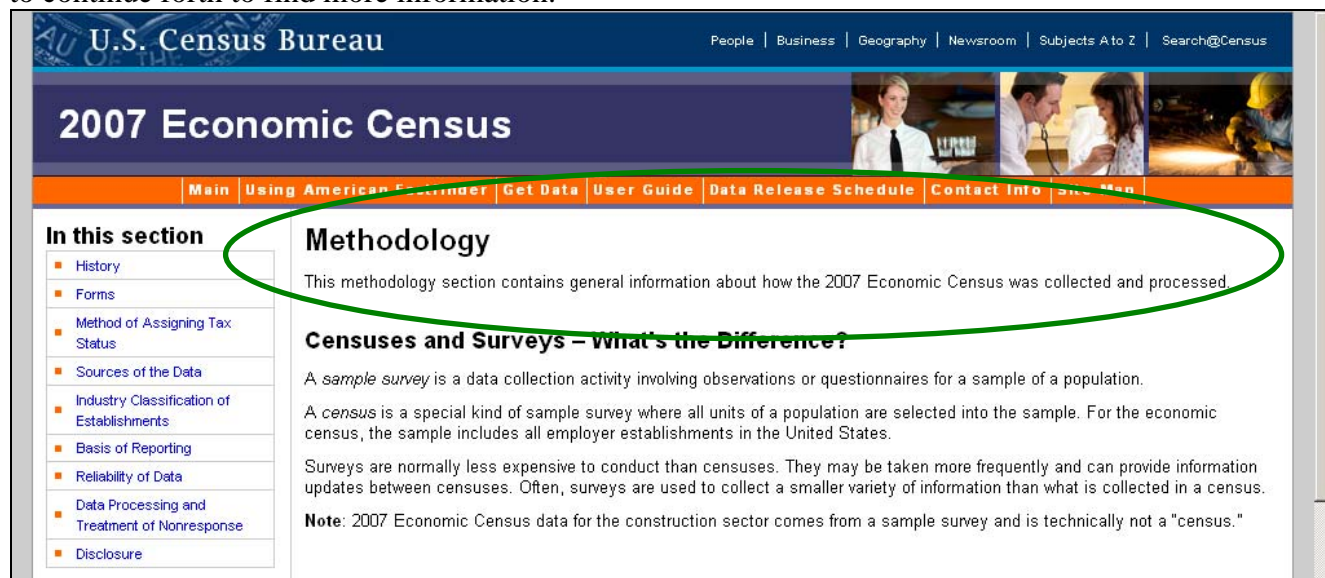


Figure 7. Current Methodology Page.

Recommendation: Add more details about how 2007 Economic Census data was collected and processed. A user who is seeking this information will want more details than are presently on the page.

3.6.3.2 Contacts by Industry

Presently the Contacts by Industry do not seem organized in a systematic way. This did not prevent most participants from finding the information. However, as most lists in our environment are alphabetized, users would expect this contact list to be too.

Recommendation: Alphabetize the list of contacts. Users tend to use previous knowledge to make inferences and expectations about the physical world and so would expect that this list would be in alphabetical order (Forsythe, Grose & Ratner, 1998, p.27). Although this did not lead to user difficulty in this study, alphabetizing the list may prevent future users from taking more time than is needed to find the contact information or from giving up altogether.

4.0 Conclusions

Overall, the software user interface supported the participants well in six of the ten tasks (as measured by an accuracy of 71 percent or better). We recommend implementing the recommended changes for the high priority issues first, and then the medium and low priority issues, if time permits. Upon completion of all changes, we recommend conducting further usability testing to evaluate whether the changes to the user interface support users in achieving their goals at the Economic Census Web site.

We request feedback from the design team on their decisions about implementing our recommendations.

Appendix B

General Introduction.

Thank you for your time today. My name is (Test Administrator). I work here in the U.S. Census Bureau Usability Lab, and I will be working with you today. When potential users such as you have difficulty with something, we have an opportunity to fix it.

First, you will complete 10 tasks using the Economic Census Web site. Then, at the end of the session, you'll fill out a questionnaire about your experience during the session. The entire session should last about an hour.

Before we start, there is a form I would like you to read and sign. It explains the purpose of today's session and your rights as a participant. It also informs you that we would like to videotape the session to get an accurate record of your feedback. Only those of us connected with the project will review the tape and it will be used solely for research purposes. Before we start, I want to tell you that you can't make a mistake or do anything wrong here. Difficulties you may run into reflect the design of the Web site, not your skills or abilities. This product is intended for people like you. Where it works well, that's great. But if you have a problem using parts of it, do not blame yourself.

Your experience with the site is an essential part of our work. We are going to use your comments and data as well as comments and data from the other participants to give feedback to the developers of the site. Your comments and thoughts will help the developers make changes to improve the site. I did not create the site, so please do not feel like you have to hold back on your thoughts to be polite. We are not evaluating you or your skills, but rather you are helping us see how well the site works. Please share both your positive and negative reactions to the site. And remember, there are no right or wrong answers.

In addition to the tasks I am about to give you, we are also going to do some eye tracking to record where you are looking on the screen. It will be very simple. In a moment we will do a very short simple task that will allow the computer to find your eyes.

I am going to give you 10 tasks to work on. Your comments are very important to us. I'd like you to tell me your impressions and thoughts as you work through the tasks. So give me your open impressions, both good and bad of what you see and what you experience on the site.

While you are working, I'd like you to think aloud. In other words, I'd like you to tell me what you are thinking, describe the steps you are taking, what you are expecting to see, why you are doing what you are doing, what you are going to do, and why. Tell me why you clicked on a link or where you

[Do Calibration]

Now that we have your eyes calibrated, we are ready to begin. For the next 60 minutes, I will ask you to work on the 10 tasks. We will begin each task by having you read the task question out loud. As you work, remember to talk to me about what you are thinking and feeling. Once you have found the information you are looking for please state your answer aloud.
