## SIX-MONTH CLUB UPDATES

Below you will find the current list of Six-Month Club members. This update supersedes the list currently found in the Carrier Information Guide on Page 18 as well as the CLP Bulletin date April 16, 2008. You may also find the updated list on CBP.gov. The additional or reinstated countries are below in blue text. The following countries are no longer part of the Six- Month Club: Bangladesh, Botswana, Cuba, Ecuador, Eritrea, Kuwait, Laos, Oman, Senegal, Syria, Tanzania.

Visitors traveling to the United States are required to be in possession of passports that are valid for six months beyond the period of their intended stay in the United States. Citizens of the countries listed below are exempt the six-month rule and need only have a passport valid for their intended period of stay.
