#### **SUBJECT**

#### **Price Changes for Check Collection;** Super High-Dollar Group Sort Product and **Expansion of the High-Dollar Group Sort Culls**

#### DETAILS

The Federal Reserve Bank of Dallas is announcing changes to check collection service charges, effective July 3, 2000.

Also, effective July 3, 2000, the Dallas and San Antonio Offices will begin offering a new group sort, Super High-Dollar Group Sort (SHDGS). The SHDGS allows the Dallas and San Antonio Office local depositors the option to clear large dollar items with improved availability. All Other Fed High Dollar Group Sort endpoints will be included in the SHDGS with immediate availability.

The SHDGS fee is \$21.50 per cash letter and \$0.25 per item for Dallas and \$25.50 per cash letter and \$0.35 per item for San Antonio. Deposit deadlines are 10:00 p.m. in San Antonio and 11:00 p.m. in Dallas, Monday through Thursday. This service is currently being offered at the Houston Office.
