(a) Individual estimates are fully interacted for premium and Medicare Advantage effects. CBO estimates that the President's Medicare proposals would not affect savings targets for the Independent Payment Advisory Board (IPAB).

(b) The Administration estimates that the 10-year cost of freezing Medicare's payment rates for physicians' services would be \$370 billion, which reflects the gross cost to the Medicare program. (The President's budget shows that gross cost.) Under current law, beneficiaries pay about 25 percent of the cost of Part B. CBO's estimate incorporates savings from the collection of additional premiums under the budget proposal. The Administration includes those higher receipts as part of its baseline. For comparison purposes, this memorandum entry displays CBO's estimate of the gross cost of freezing Medicare's payment rates for physicians' services for 10 years—that is, before taking into account changes in premium collections.
