SUBJECT: Management Authority for Military Health System Automated Information System Acquisitions

References: (a) Department of Defense (DoD) Instruction 5000.02, "Operation of the Defense Acquisition System," December 8, 2008

- (b) Department of Defense (DoD) Directive 5000.01, "The Defense Acquisition System," May 12, 2003
- (c) Chairman of the Joint Chiefs of Staff Instruction 3170.01G, "Joint Capabilities Integration and Development System, 1 March 2009

The purpose of this memorandum is to establish on oversight and management structure policy for acquisitions within the Military Health System (MHS). This policy applies to all MHS automated information systems (AISs) funded with the Defense Health Program Appropriation. AIS is defined in Enclosure 3, Table 1 of reference (a).

In accordance with references (a), (b), and (c), attachment 1 defines the acquisition category (ACAT) and the corresponding Milestone Decision Authority (MDA) as it relates to MHS acquisition programs. An acquisition program is a directed, funded effort that provides a new, improved, or continuing materiel, weapon or information system, or service capability in response to an approved need. An ACAT designation shall only be assigned after approval of the appropriate capabilities documentation establishing the need for a new acquisition program. This is typically done after completing the Joint Capabilities Integration and Development System (JCIDS) process resulting in an approved Initial Capabilities Document by the Joint Requirements Oversight Council. ACAT designations shall generally be determined based upon an assessment of acquisition cost, complexity, and risk. Potential ACAT programs shall not be artificially divided into separate entities for the purpose of qualifying as a lower ACAT level. The TRICARE Management Activity (TMA) Component Acquisition Executive (CAE) shall resolve any question of program or potential program classification below the ACAT IA level and shall maintain a list of all MHS ACAT programs. This list shall be the authoritative source of MHS ACAT programs. TMA CAE is the approval authority for MHS acquisition program names and acronyms.

TMA CAE shall be notified when an increase in approved acquisition program cost or a change in acquisition strategy results in reclassifying a formerly lower ACAT program to a higher ACAT level. ACAT level changes shall be reported as soon as the program is anticipated to be within 10 percent of the next ACAT level. ACAT level reclassification to ACAT IA shall occur upon designation by the Under Secretary of Defense for Acquisition, Technology, and Logistics (USD(AT&L)). ACAT level reclassification to ACAT III shall occur upon designation by TMA CAE. Program Executive Officer (PEO) or Direct Reporting Program Manager (DRPM) requests for reclassification of an ACAT IA or III program to a lower ACAT level shall identify the reasons for the reduction in ACAT level. The ACAT level reduction shall become effective upon approval of the request by USD(AT&L) or TMA CAE.

To ensure clear lines of responsibility and reporting, each MHS acquisition program will have only one designated MDA: USD(AT&L), Assistant Secretary of Defense (Networks and Information Integration), or TMA CAE. TMA CAE shall be the MDA for all MHS ACAT IAC programs; this cannot be further delegated. Unless delegated in writing by TMA CAE, MDA for MHS ACAT III and below programs shall be TMA CAE. MDA delegation for MHS ACAT III and below programs shall be a flag or general officer or member of the Senior Executive Service. MDA delegation shall not be reassigned or redelegated. All MDA delegation requests for MHS ACAT III programs and below shall be submitted to TMA CAE.

All MHS acquisition programs, regardless of ACAT, shall be managed by a Program Manager (PM) who shall be accountable to the MDA for credible cost, schedule, and performance reporting. The PM title shall only be used for those designated individuals with responsibility for and authority to accomplish program objectives for development, production, and sustainment to meet the validated user's operational needs consistent with the relevant capability development process (e.g., JCIDS). Upon designation by TMA CAE, a PM will be given budget guidance and a written charter that delineates authority, responsibility, and accountability for accomplishing approved acquisition program objectives. PM designation will be made no later than program initiation; usually this is Milestone B. A PM will report directly to either a PEO or TMA CAE. A PM reporting directly to TMA CAE shall be referred to as a DRPM. In no case, shall there be more than two levels of review between a PM and MDA as depicted in attachment 2.

The minimum Defense Acquisition Workforce Improvement Act (DAWIA) certification level for ACAT IA and III programs is Program Management – Level III. DAWIA certification level for ACAT IV programs is Program Management – Level II.

TMA CAE shall assign acquisition program responsibilities to a PEO for any MHS acquisition program that is determined by TMA CAE to require dedicated executive management. TMA CAE shall designate all PEOs through a written charter

that delineates authority, responsibility, and accountability for assigned program objectives. A PEO shall report directly to TMA CAE. A PEO shall be dedicated to executive management and shall have no other Component responsibilities unless waived by USD(AT&L). The minimum DAWIA certification level for a PEO is Program Management – Level III.

TMA CAE reviews and accepts transfer of acquisition program responsibility from sources external to TMA. TMA CAE reviews and approves the transfer of management responsibility for acquisition programs between PEOs and PMs. TMA CAE reviews and approves the merger of Program Management Offices (PMOs) for acquisition programs between PEOs and PMs. Termination of a PMO or a program occurs after program management responsibility for all assigned programs has been satisfactorily completed or when directed by USD(AT&L), ASD(NII), or TMA CAE. The PM is responsible for preparing the termination plan. TMA CAE approval is mandatory to terminate an acquisition program.

A TMA Acquisition Review Board (ARB) is being instituted as the venue to conduct reviews for ACAT programs at major milestone and decision points and to review certain Acquisition of Services categories. Decisions resulting from the review will be documented in an Acquisition Decision Memorandum. In compliance with reference (a), the AMB shall meet at least annually as the Configuration Steering Board to review all requirements changes and any significant technical configuration changes for all MHS ACAT IA and III programs in development that have the potential to result in cost and schedule impacts to the program.

This policy is effective immediately. It takes precedence over and cancels any existing Assistant Secretary of Defense (Health Affairs) or TMA issuances conflicting with this policy.

<sup>&</sup>lt;sup>3</sup> AIS is defined as a system of computer hardware, computer software, data or telecommunications that performs functions such as collecting, processing, storing, transmitting, and displaying information. Excluded are computer resources, both hardware and software, that are: (a) an integral part of a weapon or weapon system; (b) used for highly sensitive classified programs (as determined by the Secretary of Defense); (c) used for other highly sensitive information technology programs (as determined by the ASD(NII)/DoD CIO); or (d) determined by the USD(AT&L) or designee to be better overseen as a non-AIS program (e.g., a program with a low ratio of RDT&E funding to total program acquisition costs or that requires significant hardware development).
