The mission of the Customs and Border Protection Air and Marine is to protect the American people and Nation's critical infrastructure through the coordinated use of integrated air and marine forces to detect, interdict and prevent acts of terrorism and the unlawful movement of people, illegal drugs and other contraband toward or across the borders of the United States. To accomplish this mission, men and women of CBP Air and Marine not only need great character, honesty and self-motivation but must also possess technical skills to meet mission operations. Serving as a CBP Marine Interdiction Agent means you are part of the world's largest law enforcement air & marine force that is deeply dedicated to protecting and securing our nation.

### Big Job, Big Responsibility

As part of an elite group of Marine Interdiction Agents, you will patrol oceans, lakes, and rivers to prevent the illegal entry of weapons of terror, interdict illegal narcotics and prevent the entry of undocumented aliens. You will command various vessels in some of the most demanding situations. You will conduct covert and overt operations against terrorist activities and operate with some of the Nation's top law enforcement agencies. You will deploy to natural disaster areas to help those in need. You will operate at night and in adverse sea conditions. You may even provide maritime security at the Nation's largest events, such as the Super Bowl.

## Are You Ready for the Job?

You must meet the following minimum requirements to successfully gain consideration for entry-level employment

- U.S Citizen
- Successfully complete a thorough background investigation and drug test
- Pass a standardized physical
- Marine/law enforcement experience preferred
- U.S. Coast Guard Marine license to qualify for higher pay grades
- Appointed before reaching your 40th birthday
