Develop interagency relationships with pol/mil officers in DoD/OSD, JCS, NSC, DoS, US Embassies abroad, and other USG agencies, as appropriate, to advance USG interests. Develop short- and long-term strategic goals and identify opportunities to partner with other agencies to optimize resources. Analyze historical data and assess current demands, requirements, strategic policy, and objectives in order to forecast trends on which to base development of long-range plans. Prioritize objectives and formulate strategies to improve current plans, policies, and procedures. Conduct strategic research and analysis on topics of specific importance to the SPP, to include issues related to future uses, required competencies and operational and employment concepts for SPP security cooperation activities.
