Headquarters ANG Title 10 2-4 years Statutory Tour at **NGB/SG (Joint Base Andrews, MD)**. Must be Air Force Specialty Code (AFSC) **4N071 or 4A071**. Duties and Responsibilities: Incumbent implements and enforces AF and ANG policies related to professional medical services and physical standards. Maintains and updates tracking mechanisms for all ANG members on a medical waiver. Processes 7,000 - 8,000 medical cases annually for ANG members processed for medical and waiver action. Processes medical clearance requests for members processing for deployments; CONUS or OCONUS as required for all ANG deployers. Reviews and makes medical recommendations on retraining, classification actions, and special assignments for continued military service. Acts as liaison and provides necessary information and guidance to active duty medical referral facilities to ensure proper preparation of disability evaluation processing. Reviews and coordinates on selected cases of ANG members on disability continuation pay. Provides statistical analytical data. Researches and replies to Congressional inquiries, as well as Exception to Policy (ETP) for medical case management. Coordinates all cases of aircrew members requiring evaluations at the Aeromedical Consultation Service and other special consultations as necessary. Responsible for providing policy interpretation and guidance to 89 Medical Groups in the functional area of physical standards, disability processing, and line of duty determinations. Responsible for the implementation of AF and ANG physical standard policies and directives as they relate to medical and physical evaluations of ANG flying and non-flying personnel, accessions, general officer exams, initial flying examinations; evaluation of line of duty determinations; and the evaluation and processing of medical and physical evaluation board packages. Trains full-time Health Technicians, Traditional Guard members, State Air Surgeons, Flight Surgeons, Medical Group Commanders, and Medical Administrative Officers on all facets of medical examination packages and develops and implements strategies to reduce "incomplete" rates on physical exam, waiver, and line of duty actions. Thorough knowledge of nursing theory and techniques: anatomy and physiology; medical ethics; emergency medicine and dental techniques; peacetime aeromedical evacuation procedures; medical organization and functions; resource management; and administration. Thorough knowledge of AF, DoD, ANG instructions, policies, and procedures; qualification of their medical AFSC in residence; experience in directing medical functional areas or related health care activities, as well as computer skills with

proficiency in AF medical data programs; Aeromedical Waiver Tracking System (AIMWTS) and Physical Processing Examination Program PEPP.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Any MVA to an overseas location will require additional screening for the selectee and family prior to orders publication.

Enlisted applicants who are higher grade than the highest grade for the advertisement must provide a statement of understanding with the application stating he/she is willing to be voluntarily demoted if selected for this position, IAW ANGI 36-2503, Paragraph 3.8.

Application for this MVA signifies agreement to the following statement, "I certify that, to the best of my knowledge and belief, all of the information in and attached to this application is true, correct, complete and made in good faith. I understand that false or fraudulent information on or attached to this application may be grounds for rejection or for release from statutory tour after I begin work, and may be punishable by fine or imprisonment.
