Duties and Responsibilities: Demonstrated leadership and effective written and oral communication skills are required. Thorough knowledge of Communications Flight procedures. At least five years experience working with Federal Desktop Core Configuration software to include: MS Windows operating systems, MS Exchange, MS Office Suite, and Adobe products. Should be familiar with Ethernet technology. Upgrade to 9-Level is required. Completion of appropriate Professional Military Education and Training for grade and time in service required. Should be in compliance with DoD 8570 certification requirements. Should be able to interact effectively with members of the TEC Senior Leadership, TEC staff, TEC students and 134th ARW personnel. This position requires high level coordination and communication with the Air Force Network Operations Center (AFNOC), ANG Network Operations and Security Center (NOSC), ANG Regional Operations and Security Center (ROSC) and ANG/NGB/SC managers at A6.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Enlisted applicants who are higher grade than the highest grade for the advertisement must provide a statement of understanding with the application stating he/she is willing to be voluntarily demoted if selected for this position, IAW ANGI 36-2503, Paragraph 3.8.
