**NSA/CSS EVALUATED PRODUCTS LIST

PUNCHED TAPE DESTRUCTION DEVICES**

The Evaluated Products List (EPL) contains a listing of destruction devices that have been evaluated by the National Security Agency (NSA) or its designee and meet the performance requirements of NSA/CSS Specification 04-01, Punched Tape Destruction Devices. Inclusion of a product in the EPL is not an endorsement by NSA or the U.S. Government.

The EPL provides the device name, manufacturer, distributor, and sales/marketing contacts for each destruction device evaluated. Models listed have successfully passed evaluation for the security and performance requirements of devices designed for the destruction of plastic and paper / plastic laminate punched tape materials. The EPL is organized alphabetically by distributor name.

The EPL shall be updated on a quarterly basis, or as new models are successfully evaluated. Users are encouraged to contact the device manufacturers /distributors for assistance in selecting unit(s) best suited to their requirements, and to determine if additional punched tape devices have been added to the EPL in the interim.

The procedures for administration and distribution of the EPL are subject to change without notice.
