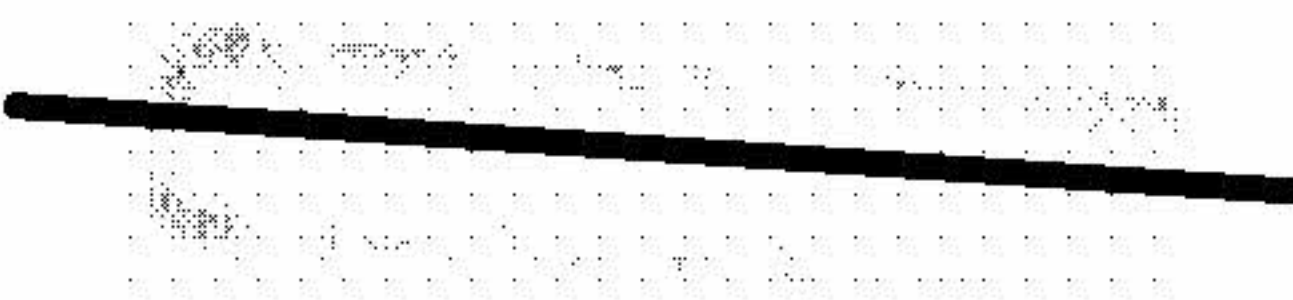

REPORT On 26 April 2007, at approximately 2150 while (b)(3):10 USC §130b.(b)(6) was conducting Pod NCO duties, detainee (b)(6) (b)(7)(C) in cell (b)(2) was being escorted to shower by Guards (b)(3):10 USC §130 and (b)(3):10 USC §130 and asked for a chair to be put in the shower, Guards (b)(3):10 USC §130 and (b)(3):10 USC §130 told (b)(6) (b)(7)(C) that he was not authorized a chair in the shower. After detainee was placed in shower he asked a second time for a chair and again he was told he was not authorized a chair in the shower. (b)(6) (b)(7)(C) began hitting the shower door which started a mass disturbance that lasted approximately 60 seconds, Pod NCO (b)(3):10 USC §130 ordered detainees to stop and they refused. On 08 October 2006, at approximately 0935, (b)(3):10 USC §130b,(b)(6) approached (b)(2) and asked detainee if he wanted shower and rec. Detainee stated he wanted shower rec and was shackled by (b)(3):10 USC §130b,(b)(6) without incident. While detainee was being escorted down the tier, detainee stated he no longer wanted shower/rec and he wanted only a (b)(2),(b)(3):10 USC §130b,(b)(6) and (b)(3):10 USC §130b (b)(6) informed detainee that (b)(2) and he was being placed in rec yard only to allow (b)(2). Detainee became argumentative and resisted any movements of block guards. Block guards continued attempting to escort detainee to rec yard and detainee started screaming "NCO why they taking me to Rec"? At this time detainee (b)(2) and (b)(2),(b)(6) (b)(7)(C) started to yell and bang on their bean holes causing a block disturbance. Block NCO, (b)(3):10 USC §130b (b)(6) then asked (b)(2) if he wanted shower/rec and detainee responded, "No." (b)(3):10 USC §130b (b)(6) then instructed the guards to return detainee back to his cell. (b)(3):10 USC §130b (b)(6) instructed (b)(2),(b)(6) (b)(7)(C) to stop banging on their bean holes and the detainees did not comply. SOG 2, (b)(3):10 USC §130b (b)(6) arrived on block and told (b)(2) to secure shutters to the block. The block disturbance stopped after shutters were secured and (b)(2) was secured in his cell.
