Use of Program Comment for DoD Rehabilitation Treatment Measures

Did you know that you can reduce your compliance burden for routine repair and maintenance of DoD historic buildings and structures?

You sure can!

In December 2008, DoD adopted the Advisory Council on Historic Preservation's (ACHP) Program Comment for DoD Rehabilitation Treatment Measures. The Program Comment provides a process for reducing compliance timeframes for routine repair and maintenance activities that comply with the Secretary of the Interior's Standards for Rehabilitation. An installation may conclude NHPA Section 106 compliance by following the Program Comment protocol. The Program Comment describes the process for compliance; the attached rehabilitation treatment measures, which are written as detail construction specifications, describe appropriate repair and maintenance practices. A professionally qualified preservationist must oversee the work. The installation must first consult with the relevant SHPO to determine if any site/building specific refinements are necessary to ensure appropriate repair of specific building materials or features.

The Program Comment originally covered **five rehabilitation treatment measures**, and DoD intends to add 26 additional measures. The original five are: **1) Removal of mortar joints and repointing; 2) Preparation of Lime and Cement-Amended Mortars; 3) Preparation of Lime or Portland Based Stucco; 4) Repair of Historic Stucco; and 5) Identifying Masonry Types and Failures.** DoD will initiate the process described in the Program Comment for adding the 26 proposed rehabilitation treatment measures very shortly. The proposed rehabilitation treatment measures cover a range of repair and maintenance activities, addressing historic exterior masonry repair (concrete repair, repair through patching and grouting, joint sealers, removal and replacement of limewash and masonry cleaning); historic roofing (slate, clay, metal, flashing/gutters), historic windows (metal windows, storm windows, hardware and fittings); painting (masonry, metal and wood), and historic exterior wood (wooden profiles and missing elements).

To support the next phase of this effort, DoD requests that installations which have used the Program Comment and Rehabilitation Treatment Measures contact Ms. Serena Bellew at Serena.Bellew.FN.UK@osd.mil to indicate which rehabilitation treatment measures were used and provide examples of successful implementations and any problems that may have occurred.

1 Day, 48 Installations, Thousands of Volunteers

Each year on the 25th of September, National Public Lands Day (NPLD) celebrates service on public lands by engaging various adult and youth groups to improve those areas that are held in public trust. For NPLD 2010, thousands of volunteers were signed up to assist 48 different installations across DoD in cultural and natural resource projects and the stewardship of the land.

Just about half of the 48 NPLD projects assisted in the stewardship of cultural resources or had a cultural resources component. The remaining were natural resource-focused. This year featured more integrated DoD projects than any other NPLD year, where cultural and natural resource endeavors were combined within one project. Projects eligible for funding include those that are installation-specific, assist in the stewardship of cultural and/or natural resources, with an emphasis on resource restoration or enhancement, public awareness, education and volunteerism.

Are you a DoD resource manager and need additional funds for standard and routine type small-scale projects at your installation? For example, past projects have related to the conservation of an object, site or structure, the clearing of debris from an interpretive trail or the clearing of grave markers, the set up fencing or signage in a historical district, or providing for traditional/ cultural plant landscaping. **Plan to apply for funds for next year's NPLD!** For more information on the application process and deadlines visit www.publiclandsday.org. Quarters One Restoration at Rock Island Arsenal



Restoration of the historic four-story Italianate mansion are underway at the Army's Rock Island Arsenal in Illinois. The 51-room "Quarters One" has been the residence of every Arsenal commander between 1871, when General Thomas Rodman designed and built the structure, and 2008.

The restoration will allow for the Army's plan for the first floor of Quarters One to be a community activity center and for the 22 bedrooms to be rented out to visiting personnel. Currently the Quarters are being used for special events, as the restoration will take several years to complete.

GAO's Report on Status of Federal NAGPRA Compliance

"Almost 20 years after [the establishment of the] Native American Graves Protection and Repatriation Act (NAGPRA), key federal agencies still have not fully complied with the act for their historical collections acquired on or before NAGPRA's enactment", according to the Government Accountability Office's (GAO) report, released 28 July 2010. The report details NAGPRA compliance activities of several agencies and provides recommendations based on their study and the report's findings.

DoD SERDP and ESTCP to Host Annual Technical Symposium and Workshop

On **November 30 – December 2, 2010**, DoD's Strategic Environmental Research and Development Program (SERDP) and the Environmental Security Technology Certification Program (ESTCP) will hold the annual **Partners in Environmental Technology Technical Symposium & Workshop**, "Meeting DoD's Environmental Challenges," at the Marriott Wardman Park Hotel in Washington, D.C.

This year's Symposium and Workshop will offer a dynamic opening Plenary Session, 14 technical sessions, three short courses and an Exhibit Hall. Technical sessions will highlight research and innovative technologies that assist the Department of Defense in addressing increasingly complex environmental and mission sustainability challenges. Over the course of the event, short courses will provide training opportunities on select technologies and methods in environmental restoration and munitions response.

Technical Sessions: A comprehensive technical program consisting of concurrent sessions covering a variety of scientific and technical subjects will follow the Plenary Session. The list of topical areas includes:

- Military Munitions in the Underwater Environment
- Maintaining Sustainability of Forward Operating Bases
- Passive Sampling Approaches for Contaminated Sediment Management

Short Courses: Three short courses will be offered for which Professional Development Hours will be available! An American Indian Conflict Management and Consultation Seminar will be held Friday, November 5, 2010, at the Kiana Lodge, Poulsbo, Washington. The Friday seminar follows DoD's American Indian Cultural Communication Course (AICCC), which is being conducted from Tuesday, November 2 thru Thursday, November 4, also at the Kiana Lodge. To register for the American Indian Conflict Management and Consultation Seminar, you must have completed AICCC training, either at Suquamish or at another location.

This **FREE** seminar provides valuable training for DoD employees working with Indian tribes and tribal members to implement DoD's American Indian and Alaska Native Policy and Instruction. Seminar topics include:

- Understanding interests, issues, proposals, and their interconnections and relationships to the other party
- Making pre-consultation preparations
- Developing problem solving/negotiation skills in a multi-cultural environment
- Using negotiation skills to handle strong negative emotions and behaviors that interfere with creative problem solving
- Developing tactics and strategies for avoiding impasses within and between groups
- Integrating the three necessary consultative factors and satisfactions for groups to reach agreements
- Writing durable, long-lasting "win-win" consultative agreements that minimize future dissatisfaction

The Seminar will be conducted from 0800-1700. The Native American instructors are accomplished practitioners, experienced in extensive relations with Indian tribes, intercultural conflict resolution, and complex multi-party negotiations.
