### [Managing DoD's Historic Real Property- Your Questions, Answered \(Sort of...\)](#)

Last month, the author complained that no one had sent in questions about DoD historic real property for inclusion here. This month, the author thanks you for your questions, especially the super difficult ones that will take some higher levels of brainpower to address and report on. So, despite some interesting queries, this month, we're taking the easy way out. Next month, we'll try to somehow answer a particularly puzzling problem involving a historic 1830s log cabin, 1960s additions, a circular driveway, tree-lined avenues, and housing privatization.

This month's (straightforward) historic real property puzzler (thanks to JGY):

(Here's the background:) "On my installation, we have a historic building that we determined eligible for listing on the National Register. The SHPO concurred with our determination. A subsequent project involving several needed alterations to the building led to a determination of adverse effect in and the required Section 106 process. At the end of the 106 action, the installation and the SHPO agreed to mitigate the adverse effects, and signed an agreement document to that end." (And here's the question:) "So, if we all agree that the building is severely altered, and those alterations have been mitigated through a 106 process, what historic status real property code should we assign to the building?"

Answer: See page 5, "RPAD."

### NEW ACHP WEBSITE QUESTIONS AND ANSWERS

Five new questions and answers have been posted on the Advisory Council on Historic Preservation's website in the Section 106 Archaeology Guidance section.

This guidance, while keyed to the special responsibilities of federal agencies, is also intended to help other stakeholders, such as State and Tribal Historic Preservation Officers, private sector consultants, and the interested public, navigate issues posed by archaeological properties in the Section 106 process. As with current questions and answers, each has links to pertinent federal law, regulation, standards and other agency guidance, as well as related questions.

New questions and answers include:

- ☛ Can archaeologists participate in Section 106 review as consulting parties?
- ☛ Does issuance of an ARPA permit constitute an undertaking requiring Section 106 review?
- ☛ Who owns the artifacts recovered from private land?
- ☛ Can the NHPA be used to restrict access to information about an archaeological site?
- ☛ What is a "reasonable and good faith effort" to identify historic properties under the ACHP's Affordable Housing Policy?

The ACHP's Archaeology Task Force, chaired by expert member Dr. Julia King, oversaw development of this guidance. New Section 106 archaeology guidance is one of three initiatives of the Archaeology Task Force. The Task Force also developed the new ACHP "Policy Statement Regarding Burial Sites, Human Remains, and Funerary Objects" which was adopted by the ACHP last year, and is available at <http://www.achp.gov>. It is also working to expand the Preserve America initiative through greater knowledge and appreciation of archaeological properties.

All users of this guidance are encouraged to share their ideas, suggestions, and recommendations on the utility of the guidance and ways it might be improved so we can continue to make this site more useful.

#### Panel I - Looking Back: Lessons Learned from Past Conflicts

Lynn H. Nicholas, Independent researcher of Nazi era social and cultural policy and author of "Rape of Europa," will discuss Nazi and World War II art looting, wartime preservation measures and post-War restitution.

Robert M. Edsel, Author of the non-fiction book, "Rescuing Da Vinci," co-producer of the documentary film, "The Rape of Europa," and Founder and President of the Monuments Men Foundation for the Preservation of Art, will discuss the role of the WWII Monuments, Fine Arts and Archives troops in protecting, preserving and restituting looted art.

András J. Riedlmayer, Harvard University, will discuss the destruction of cultural property during the Balkan Wars of the 1990s.

Hays Parks, U.S. Department of Defense, will discuss the history of and U.S. position toward the 1954 Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict.

Thomas R. Kline - Panel Chair, Attorney, Andrews Kurth LLP, and Assistant Professorial Lecturer, GWU, Museum Studies Program.

#### Panel II - Looking Forward: Applying the Lessons Learned.

Corine Wegener, President, U.S. Committee of the Blue Shield; Associate Curator, Architecture, Design, Decorative Arts, Craft, and Sculpture at The Minneapolis Institute of Arts and Major (retired) in the U.S. Army Reserve, will discuss looting and destruction of cultural property at the Iraq National Museum and recovery efforts and also the role of the Blue Shield in protecting cultural property in future conflicts.

John Russell, Professor, Massachusetts College of Art, and former Senior Advisor to the Iraqi Ministry of Culture, Coalition Provisional Authority, will discuss damage done to cultural heritage during the Iraq War and efforts toward cooperation between the U.S. military and cultural heritage professionals of different nationalities.

Richard Jackson, Special Assistant to the Judge Advocate General for Law of War Matters and Army Colonel (Ret.), will discuss current attitudes of the U.S. military toward the Hague Convention and obligations to preserve cultural heritage during armed conflict.

Patty Gerstenblith - Panel Chair, Professor, DePaul College of Law, and President, Lawyers' Committee for Cultural Heritage Preservation.

the building should still be coded as historic – either NREI (National Register Eligible, Individual) if it's individually eligible, or NREC (National Register Eligible, Contributing Element), if it contributes to a district. Even though the building is severely modified, and its integrity compromised, it should still be considered as historic – but (and here's the real key) – managed as needed. Perhaps a note can be made in your real property database that the building, although historic, is no longer subject to 106 actions.

**CANADIAN RECIPE:  
Lemongrass and Citrus Poached Salmon**

**RECIPE**

2 ½ lbs	salmon fillet	1	small onion, chopped
1 quart	chicken stock	2 tbsp	minced garlic
1 quart	orange juice	2 c	coarsely chopped lemongrass
2 c	white wine	1 tsp	salt and white pepper (each)

**DIRECTIONS**

Remove salmon skin and cut fillet into desired portion. In a large pot, combine all ingredients, except fish. Bring liquid to a boil for five minutes. Reduce heat to a low boil. Place salmon in the liquid for about 5 minutes, or until flaky and tender.
