### The Legacy Resource Management Program

Thank you to all of the proponents who submitted preproposals by the September deadline. The Legacy staff is happy to report the receipt of 69 cultural resources preproposals with total requests of \$7.28 million. The combined natural and cultural resources request for funding totals more than \$28 million!

The Cultural Resources Review Committee will meet in early October to review the pre-proposals. Authors can expect to hear specific feedback on their pre-proposals by 10 October.

#### National Public Lands Day (NPLD)

Announcing the 2008 NPLD volunteer effort which occurred on Saturday, September 27. The Legacy Program financially sponsored 37 sites on varying installations around the nation. Eight site projects focused on cultural resources:

#### **DoD Issues New Cultural Resources Policy**

The Department of Defense (DoD) is proud to announce the issuance of a new policy on cultural resources. DoD Instruction 4715.16, Cultural Resources Management, became effective September 18, 2008.

This Instruction establishes DoD policy and assigns responsibilities under the authority of DoD Directive (DoDD) 5134.01, Under Secretary of Defense for Acquisition, Technology, and Logistics, and in accordance with DoDD 4715.1E, Environment, Safety, and Occupational Health, to comply with applicable Federal statutory and regulatory requirements, Executive orders, and Presidential memoranda for the integrated management of cultural resources on DoDmanaged lands.

The new policy reflects the Department's efforts to comprehensively manage its cultural resources as assets that support the military mission. DoDI 4715.16 is based on three core policy statements:

It is DoD policy to:

- Manage and maintain cultural resources under DoD control in a sustainable manner through a comprehensive program that considers the preservation of historic, archaeological, architectural, and cultural values; is mission supporting; and results in sound and responsible stewardship.
- Be an international and national leader in the stewardship of cultural resources by promoting and interpreting the cultural resources it manages to inspire DoD personnel and to encourage and maintain U.S. public support for its military.
- Consult in good faith with internal and external stakeholders and promote partnerships to manage and maintain cultural resources by developing and fostering positive partnerships with Federal, tribal, State, and local government agencies; professional and advocacy organizations; and the general public.

The Instruction provides new responsibilities and procedures for DoD Component cultural resources programs, an updated list of Integrated Cultural Resources Management Plan

contents, and an entirely new set of reporting requirements to track the Component cultural resources programs. The Office of the Secretary of Defense, proponent of the policy, will transition into the new reporting requirements over the coming year and require full Component reporting for the fiscal year ending September 30, 2009.

DoDI 4715.16 is significant as the first revision to the Department-wide cultural resources policy in over ten years, and the first stand-alone DoD cultural resources policy in over twenty years. The cultural resources portions of the previous DoD Instruction 4715.3, Environmental Conservation Program, are no longer valid. That DoDI is currently under revision and will be reissued as a natural resources management-only DoDI.

# DOD REVISES FINANCIAL MANAGEMENT REGULATION ON HERITAGE ASSET REPORTING

The Department of Defense (DoD) is proud to announce the issuance of a revised regulation on Heritage Asset Reporting. Volume 6B, Chapter 12, of DoD Financial Management Regulation (FMR) 7000.14-R, entitled "Required Supplementary Information," is now effective.

DoD Heritage Assets are real and personal property with significance in American history and prehistory due to their architectural, archaeological, and cultural values. The FY2008 categories are defined as follows:

- Buildings and Structures. Includes buildings and structures that are listed on, or eligible for listing on, the National Register of Historic Places (NRHP), including Multi-use Heritage Assets. Includes National Historic Landmarks (NHL); buildings or structures that are contributing elements to districts listed on or eligible for the NRHP or a NHL District; and buildings and structures designated eligible for the NRHP for purposes of a Program Alternative.
- Archaeological Sites. Sites that have been identified, evaluated, and determined to be eligible for or are listed on the NRHP.
- Museum Collection Items. Items which are unique for one or more of the following reasons: historical or natural significance; cultural, educational or artistic importance; or significant technical or architectural characteristics. Museum collection items are divided into two subcategories: fine art and objects. Fine art includes paintings, sculptures and other three

dimensional art. Objects are current use, excess, obsolete, or condemned material; war trophies; personal property such as uniforms, medals, or diaries, and military equipment.

This revised regulation also requires the reporting of deferred maintenance for Heritage Assets (Buildings and Structures) in FY2008.

DoD revised its Heritage Asset definitions and reporting requirements to better align with other internal and external data calls, such as the Federal Real Property Profile (mandated by Executive Order 13327) and changes to financial accountability regulations. DoD plans to implement these revisions for the FY2008 reporting year.

# SENATE VOTES ON '54 HAGUE CONVENTION FOR PROTECTION OF CULTURAL PROPERTY IN THE EVENT OF ARMED CONFLICT

On September 25, 2008, the United States Senate voted to give its advice and consent to ratification of the 1954 Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict. The Convention is the first comprehensive international agreement on the protection of cultural property.

The Archaeological Institute of America, the Lawyers' Committee for Cultural Heritage Preservation, and the U.S. Committee for the Blue Shield provided the following additional information via email on September 26th:

"The United States now joins 121 other nations in becoming a party to this historic treaty which establishes the principles for protecting cultural sites, monuments and collections during both armed conflict and military occupation. By taking this significant step, the United States demonstrates its commitment to the preservation of the world's cultural, artistic, religious and historic legacy.

The Statement of the Archaeological Institute of America, the Lawyers' Committee for Cultural Heritage Preservation, and the U.S. Committee for the Blue Shield urging Senate ratification, joined by twelve other cultural preservation organizations, is available at:

#### **National Preservation Awards**

Announcing the establishment of the Secretary's Historic Preservation Award, a new annual award to recognize the outstanding contributions of the employees of Federal, State, and Tribal Preservation Offices and Certified Local Governments in the area of historic preservation. Each year, the Secretary will recognize one individual from each of four categories – Federal Preservation Offices, State Historic Preservation Offices, Tribal Historic Preservation Offices, and of Certified Local Governments. Employees of the National Park Service are not eligible for these awards.

Nominees are individuals whose contributions surpass the expected scope of their positions and whose creativity and expertise have fostered the overall goals of the National Historic Preservation Act. Nominees should have demonstrated a sustained and outstanding contribution to the preservation of historic resources. Nominations should concentrate on activities and accomplishments during the last two years (2007-2008).

#### At last you do not have to worry about...

#### SOUND MIRRORS

These structures were built during the Great War into the 1930s along the northeastern and southern coasts of England. These devises preceded radar in the attempt to detect approaching enemy aircraft.

As the militaries developed faster aircraft, the listening devices became less effective. Radar fully replaced the obsolete sound mirrors by the Second World War.

Sound mirrors work by concentrating sound waves in their concrete concave structures and passing the sounds through a microphone to the listener. A skilled listener could detect aircraft several miles away over the English Channel, and the direction from which it approached.

Although "listening ears" still exist along the coasts of Great Britain, the best known example are located on the Dungeness Peninsula. The Dungeness mirrors consist of a concaved wall and two concave structures, all approximately 30 feet high (seen below).

NOTE: I had a tough time choosing the recipe for this month! This one can be done in the oven or on the grill. I've also seen it done with a campfire, but am personally not skilled in the art of open-flame cooking.



# **APPLE RECIPE: Baked Apples**

### RECIPE

4 baking apples 1 tsp cinnamon 8 tbsp dried fruits 2 tsp butter 8 tbsp nuts cinnamon red-hots (optional) ½ cup sugar caramel candies (optional)

#### DIRECTIONS

Combine cinnamon and sugar in a small bowl. Core the apples, leaving the bottom intact. Stuff the cavity tightly with fruits, nuts, cinnamon, or caramel candies. Sprinkle stuffed apples with cinnamon-sugar sugar and dot with butter. Wrap the apple in double-thickness aluminum foil. Place the apple in the oven, or on the coals, for 12-18 minutes, turning occasionally. The baked apple should yield slightly when poked. Vent the apples for a few minutes before serving.
