## Plenary & Luncheon Speakers

The official conference kick-off begins with the Opening Lunch and Plenary Session, at noon on Tuesday, July 31. Mr. Alex A. Beehler, ADUSD(ESOH) will host the event. The luncheon speaker is MGen Lehnert, Commanding General, Marine Corps Installations West. The plenary will feature DoD panel consisting of Mr. Philip W. Grone, DUSD (I&E), Dr. Paul W. Mayberry, DUSD Readiness, and Mr. David Duma DOT&E and a senior military panel including LTG James Lovelace, Deputy Chief of Staff G-31517; RADM Matthew G. Moffit, CNO N43; MGen George Flynn, Commanding General, Training and Education Command; and Mr. Fred Pease, AF/A30A. Also speaking at the Plenary are a number of notables including: Secretary Dirk Kempthorne (invited), Department of Interior; Chairman John Nau, Advisory Council on Historic Preservation; and Secretary Bill Ross, North Carolina Department of Environment, Health, and Natural Resources.

Following the plenary will be a reception in the Exhibition Space where conference attendees can view posters and other exhibits, discuss the posters with their authors, and mingle with speakers and other attendees.

## Highlited Speakers

**Colonel Matthew Bogdanos** was commissioned a Second Lieutenant in the US Marine Corps in 1980. In 1984, he was appointed a Special Assistant US Attorney. Once released from active duty in 1988, he joined the District Attorney's Office, rising to Senior Trial Counsel in 1996.

Remaining in the Marine Reserves Bogdanos was recalled for Desert Storm, and also served in South Korea, Lithuania, Guyana, Kazakhstan, Uzbekistan, and Kosovo.

Recalled to active duty after losing his apartment near the World Trade Center on September 11, 2001, he joined a multi-agency task force, received a Bronze Star for counter-terrorist operations against al-Qaeda in Afghanistan, and was promoted to Colonel. He then served two tours in Iraq as the head of that task force, searching for evidence of terrorist networks and ultimately leading the international investigation into the looting of Baghdad's Iraq Museum, resulting in the recovery of 6000 antiquities in eight countries.

He was named an Easter Seals Distinguished Participant in 2001, received the 2004 Public Service Award from the Hellenic Lawyers of America, the 2006 Distinguished Leadership Award from the Washington DC Historical Society, and a 2007 Proclamation from the City of New York, and is the recipient of a 2005 National Humanities

Medal from President George W. Bush for his work recovering Iraq's treasures. All his royalties from his book, *Thieves of Baghdad*, go to the Iraq Museum. Released back into the reserved in October 2005, he returned to the DA's Office. Col. Bogdanos will be speaking in the session titled "Over There: Cultural and Heritage Resource Management in Support of OEF / OIF," Wednesday afternoon.

**Philip W. Grone** was appointed as the Deputy Under Secretary of Defense for Installations & Environment in 2004, after having served as that post's principal assistant deputy since 2001. His responsibilities include the development of installation capabilities, programs, and budgets; base realignment and closure, privatization of military housing and utilities system; competitive sourcing; and integrating installations and environment needs into the weapons acquisition process. Additionally, he has responsibility for environmental management, safety and occupational health; environmental restoration at active and closing bases; conservation of natural and cultural resources; pollution prevention; environmental research and technology; fire protection; and explosives safety. Mr. Grone also serves as the DoD's designated Senior Real Property Officer, as well as the DoD representative to the Advisory Council on Historic Preservation.

Mr. Grone served as the Deputy Staff Director and the Assistant Deputy Staff Director for the House Armed Services Committee (HASC) from 2000-2001. From 199 to 2001, Mr. Grone served as Staff Director of the HASC Subcommittee on Military Installations and Facilities. He also served as the Subcommittee Professional Staff member for the HASC Subcommittee on Oversight and Investigations; Professional Staff Member for the Joint Committee on the Organization of Congress; and Legislative Assistant to US Representative Willis D. Gradison, Jr. of Ohio. Mr. Grone will speak both in the plenary and in the cultural resources policy session Wednesday morning.

**John L. Nau, III**, Chairman of the Advisory Council for Historic Preservation since 2001, is president and CEO of Silver Eagle Distributors, L.P., a position he has held since 1990. He was appointed to the Texas Historical Commission by the Governor in 1993, and was reappointed to the commission in 1999 by then-Governor George W. Bush. Since 1995, Nau has served as chairman of the commission. In addition, he serves on the board of directors of The Civil War Preservation Trust, is a member of the Texas State History Museum Advisory Committee, and was appointed to the President's Transportation Infrastructure Streamlining Task Force.

Nau also serves on the board of the Downtown Historic District, is an advisory board member for the Greater Houston Preservation Alliance, and is a charter member of the Monticello Cabinet, Charlottesville, Virginia. He also sits on the executive committee of the National Capital Campaign of the University of Virginia, and the Board of Directors of the Greater Houston Partnership.

## Registration

There is **no conference registration fee**. ## Hotel

The conference and associated training sessions will occur between July 30, 2007 and August 3 at **Disney's Coronado Springs Resort**.
