Those who achieved passing scores on the assessment were first to earn the SFPC. They are commended for volunteering their efforts and for blazing the trail for professionalism within the DoD security community. The SFPC is now in full production, and personnel can expect to hear more in the coming months regarding the implementation of this new program within their respective service or agency.

## **DSS Conferral Ceremony**

The first SFPC conferral ceremony in DoD history was held April 1, 2011, at the U.S. Patent and Trademark Office in Alexandria, Va. Defense Security Service (DSS) recognized 20 employees, including Center for Development of Security Excellence instructors, course curriculum developers, and an industrial security professional from DSS Industrial Security Field Operations.

## **DoD Hosts SFPC Conferral Ceremony**

On April 29, 2011, at the U.S. Patent and Trademark Office in Alexandria, Va., DoD hosted an SFPC conferral ceremony recognizing individuals from DSS; DoD Office of Inspector General; Defense Threat Reduction Agency; National Geo-Spatial Agency; Office of the Secretary of Defense (OSD), Deputy Under Secretary of Defense for Intelligence; OSD, General Counsel of the Department of Defense; Office of the Director, Operational Test and Evaluation; Pentagon Force Protection Agency; United States Air Force; and Washington Headquarters Services.



An SFPC Conferral Ceremony on April 29 recognized individuals from Defense Security Service and several other DoD organizations.

Frank Wilson, DoD FACA Committee Management Officer, commented on the benefits of SPēD Certification: "To be certified as a SPēD security professional is similar to earning your CPA or a PMP Certification in Program Management. It indicates that the recipient demonstrates a particular level of proficiency in a common set of competencies. It's a visible indication that the certified individual is a true professional in the security career field."

## SFPC Holders Needed for Upcoming Beta Testing

The Defense Security Service (DSS) will be conducting beta testing of the Security Asset Protection Professional Certification (SAPPC) Assessment this fall. Security professionals who hold the Security Fundamentals Professional Certification (SFPC) will be eligible to take the SAPPC Beta Assessment. Beta testing will launch at the DoD Worldwide Security Conference on August 22–26, 2011, and other testing opportunities will be announced in the coming months.

## **STEPP replaced ENROL**

In May 2011, the Security Training, Education and **Professionalization Portal** (STEPP) replaced Electronic Network Registration On-Line Learning (ENROL). STEPP is the Center for Development of Security Excellence (CDSE) learning management application that enables students to find training, manage learning, and track professional development.

You must have a STEPP account to access diagnostic tools and to take a SPēD Assessment. Access STEPP at
