#### **FOREWORD**

This Manual is issued under the Authority of DoD Directive 6400.1, "Family Advocacy Program," August 23, 2004. It prescribes procedures for completion and submission of information about substantiated and unsubstantiated reports of child maltreatment and domestic abuse incidents. It applies to the Office of the Secretary of Defense (OSD), the Military Departments, and the Defense Agencies, hereafter referred to collectively as "the DoD Components." The term "Military Services," as used herein, refers to the Army, the Navy, the Air Force, and the Marine Corps.

This Manual standardizes data submissions for all incidents of child maltreatment and domestic abuse among the Military Services. It supersedes Assistant Secretary of Defense Memorandum, "Child and Spouse Abuse Report," August 22, 1997. The Manual expands spouse abuse reporting requirements to encompass not only spouses, but also former spouses, a person of the opposite sex with whom the abuser shares a child in common, or a current or former intimate partner of the opposite sex with whom the abuser shares or has shared a common domicile. The Manual eliminates the reporting requirement for incidents of child maltreatment and domestic abuse in the Coast Guard. The Coast Guard is an agency within the Department of Homeland Security and has its own family advocacy program, separate from the Department of Defense. The file formats specified in this Manual are intended to satisfy DoD policy and budgetary requirements.

This Manual is effective immediately, and is mandated for use by all DoD Components. The DoD Components may issue supplementary instructions with the understanding that DoD-wide standardization precludes the development of unique definitions and procedures. #### INTRODUCTION

In May 1981, The Department of Defense published Directive 6400.1, "Family Advocacy Program," reference (a), which officially established the Department of Defense Family Advocacy Program (FAP). The Directive also published a set of common definitions, and required each of the Services to establish a broad-based family advocacy program providing for the prevention, identification, reporting, treatment, and follow-up of child and spouse abuse. In October 1981, Congress appropriated funding for the program, and mandated comprehensive child and spouse abuse incident reporting and DoD accountability for developing, managing, and monitoring a family advocacy program.

As a result, DoD Instruction 6400.2, "Child and Spouse Abuse Report," reference (b), was issued on July 10, 1987. This Instruction required each of the Services to report suspected child abuse and neglect, suspected spouse abuse, and suspected child sexual abuse in out-of-home care using the data on DD Form 2486. Then, each of the Services maintained a central registry of reports, using the data submitted by installations on the DD Form 2486. The Service Headquarters compiled the installation data from the Form 2486 to submit aggregate data to the Department of Defense semi-annually on DD Form 2404.

In 1997, the DoD central registry was changed from a victim-based reporting system to an "incident-based reporting system" within the Defense Manpower Data Center (DMDC), and was automated. This revision was made to address significant problems with data collection and reporting using DD Form 2486. In addition, many of the data fields on the form were not used by the DoD FAP Office for policy analysis or budget requirements, and were not necessary for a DoD central registry. Finally, the lack of a DoD-wide automated, incident-based central registry made it difficult to track substantiated cases across Services, which is of critical importance in conducting background criminal and suitability checks for those providing services to military families.

The present DoD central registry, managed within DMDC, has information on (1) unsubstantiated reports not linked to an identifiable individual and (2) information on substantiated reports linked to identifiable active duty and retired Service members, Department of Defense civilian employees, contractors, and their family members.

The present automated, incident-based reporting system, in contrast to the pre-1997 case-based reporting system, has the following additional advantages:

- a. It provides unduplicated counts of the number of reports the installation FAP responds to ("cases to be worked").
- b. It permits differential classifications/status determinations based on available evidence.
- c. It serves as the basis for FAP workload analysis and permits calculations leading to empirically based budget projections.
- d. It replaces DD Forms 2486 and 2404 with electronic submissions, and reduces the number of data elements required by the Department of Defense and the Services.

#### C1. CHAPTER 1

#### GENERAL INFORMATION

#### C1.1. PURPOSE

- C1.1.1. This Manual replaces reference (b) by updating the assignment of responsibilities and the reporting requirements associated with child maltreatment and domestic abuse in the Department of Defense.
- C1.1.2. This information collection has been assigned Report Control Symbol DD-P&R(Q)2052.

#### C1.2. POLICY

It is Department of Defense policy that a central child maltreatment and domestic abuse database be maintained to:

- C1.2.1. Analyze the scope of child maltreatment and domestic abuse, types of maltreatment, and information about victims and offenders to analyze the effectiveness of the FAP, and develop changes in policy to address child maltreatment and domestic abuse.
  - C1.2.2. Support the requirements of DoD Instruction 1402.5, reference (c).
  - C1.2.3. Support the replies to public, congressional, and other governmental inquiries.
- C1.2.4. Support budget requirements for child maltreatment and domestic abuse program funding.

#### C1.3. RESPONSIBILITIES

- C1.3.1. The <u>Under Secretary of Defense (Personnel and Readiness (USD(P&R))</u>, or designee, shall:
- C1.3.1.1. Review information collected, analyzed, and reported by the Military Departments and the DoD Components on child maltreatment and domestic abuse under this Manual.
- C1.3.1.2. Evaluate, in accordance with DoD guidance and performance measures, the performance of FAP operations in achieving the outcomes of reduced frequency, severity, and recidivism of child maltreatment and domestic abuse.
  - C1.3.1.3. Ensure compliance with this Manual is timely and thorough.
  - C1.3.1.4. Provide advice to the DoD Components on implementation of this Manual.

- C1.3.2. The <u>Secretaries of the Military Departments</u> and the <u>Heads of Other DoD</u> Components, or designees, shall:
- C1.3.2.1. Issue policies and procedures in accordance with reference (a) and this Manual providing for the prompt, thorough, and accurate reporting of child maltreatment and domestic abuse incident data.
- C1.3.2.2. Issue policies and procedures in accordance with reference (a) for an installation case review committee (CRC) to determine the clinical status of a reported incident.
- C1.3.2.3. Issue policies and procedures for review of the incident status of a report as determined by an installation CRC when such incident status is contested, or for correction of such CRC incident status clinical determinations.
- C1.3.2.4. Issue policies and procedures for the correction of errors in the recording of child maltreatment and domestic abuse information.
- C1.3.2.5. Ensure information about reports of alleged child maltreatment and domestic abuse is managed in accordance with DoD Directive 5400.11, reference (d), and this Manual, and issue policies and procedures for the circumstances and procedures for the FAP to disclose information about one or more incidents of alleged child maltreatment or domestic abuse accordingly.
- C1.3.3. The <u>Director of the Defense Manpower Data Center (DMDC)</u>, or designee, under the USD(P&R) shall:
- C1.3.3.1. Receive child maltreatment and domestic abuse incident data from the Family Advocacy Program Managers (FAPMs) of the DoD Components, or designees, and maintain it in a database in accordance with reference (e) and this Manual.
- C1.3.3.2. Assist the FAPMs of the USD(P&R) and the DoD Components, or designees, in creating statistical reports of child maltreatment and domestic abuse incidents by providing requested data.
- C1.3.3.3. Assist the FAPMs of the DoD Components, or designees, in conducting background checks required by reference (b) for individuals in DoD-sanctioned child care services, and applicants for Nonappropriated Fund or other positions on the installation who may have contact with children and youth.

#### C2. CHAPTER 2

#### **RECORD FILE FORMAT**

This chapter presents the record file format for entering information about an alleged incident, and the military sponsor, victim, and alleged offender associated with the incident. Descriptions of required data fields for an alleged incident (C2.1.), the military sponsor (C2.2.), the victim (C2.3.), and the alleged offender (C2.4.) are included. Figures C2.F1. through C2.F4. present the required data field numbers; field names; domains; coding instructions and remarks; record positions; and size for information on the alleged incident, and the associated sponsor, victim, and alleged offender.

#### C2.1. <u>ALLEGED INCIDENT INFORMATION</u>.

- C2.1.1. Data to complete fields 1 through 15 shall be submitted for each alleged incident of child maltreatment and domestic abuse involving a member of a DoD Component and reported to a family advocacy program of the Armed Services.
- C2.1.2. Field 1, Situation Identifier. An eight-digit number assigned to each reported alleged incident of child maltreatment or domestic abuse. The first four digits refer to the fiscal year and the second four digits are taken from a unique subset of numbers assigned to each family advocacy program (FAP) by each Service Family Advocacy Program Manager (also known as "Incident Number.") Incidents of alleged child maltreatment in which two or more children were the alleged victims shall be recorded as separate incidents for each child.
- C2.1.3. <u>Field 2, FAP Unit Identification Code (U.I.C.)</u>. The unique alphanumeric code identifying the FAP where the incident was reported. (Also known as the "Geographical or Unit I.D.")
- C2.1.4. <u>Field 3, US State Alpha Code</u>. A two-digit alphabetical abbreviation designating the State in which an incident was reported. (Also known as "State Code.")
- C2.1.5. <u>Field 4, Country Code</u>. A two-digit alphabetical abbreviation designating the country in which an incident was reported. (Also known as "Country Code.") If there is a US State code, leave the Country code blank.
- C2.1.6. <u>Field 5, Incident Report Date</u>. The calendar year date the incident was reported to the FAP.
- C2.1.7. Field 6, Military Service Organization Code. The designation describing the military service (Army, Navy, Marine Corps, or Air Force) that received the report of an alleged incident for assessment, and is submitting the report.
- C2.1.8. <u>Field 7, Organization Name Text</u>. Completed when the Defense Logistics Agency or the National Security Agency received the alleged report.

- C2.1.9. <u>Field 8, Victim Type Code</u>. The designation of whether a victim of an alleged incident is a child or an adult. (Also known as "Type of Victim.")
- C2.1.10. <u>Field 9, Legal Event Context Code</u>. The designation of the category of alleged maltreatment reported as "Physical Abuse," "Sexual Abuse," "Emotional Maltreatment," and/or "Neglect." (Also known as "Type of Alleged Maltreatment.") See Appendix 1, Definitions.
- C2.1.11. <u>Field 10, Person Status Code</u>. The designation of a child or an adult victim as alive or deceased as a result of the incident. (Also known as "Fatality Occurred.") If no death occurred, designate "Alive Person." If a death occurred, designate "Deceased Person."
- C2.1.12. Field 11, Alleged Victim Previously Known to the DoD Central Registry. A designation that the alleged victim in the incident had or had not been previously reported to the DoD Central Registry as a victim of a previous incident of maltreatment with the same or different alleged offender. APPLIES ONLY WHEN THE VICTIM DIES AS A RESULT OF THE ABUSIVE INCIDENT. CHILD AND ADULT VICTIM FATALITIES ARE REPORTABLE TO THE DoD CENTRAL REGISTRY AS INCIDENTS. Field 11 assists the Office of the Secretary of Defense FAP in the fatality review process.
- C2.1.13. Field 12, Alleged Offender Previously Known to the DoD Central Registry. A designation that the alleged offender in the incident had or had not been previously reported to the DoD Central Registry as an alleged offender with the same or different victim. An alleged offender is an individual who allegedly abused, maltreated, or neglected his/her child, current or former spouse, a person with whom the alleged offender shares a child in common, or a current or former intimate partner with whom the alleged abuser shares or had shared a common domicile. In a child maltreatment incident with more than one alleged offender, the person allegedly responsible for the most severe maltreatment shall be deemed the alleged offender. If the person allegedly responsible for the most severe maltreatment cannot be determined and the victim's sponsor is an alleged offender, the sponsor shall be deemed to be the alleged offender. APPLIES ONLY WHEN THE VICTIM DIES AS A RESULT OF THE ABUSIVE INCIDENT. The purpose of this field is the same as in field 11.
- C2.1.14. <u>Field 13A, Situation Findings Date</u>. The date the CRC determines, for clinical purposes, whether an alleged incident of child maltreatment or domestic abuse occurred. (Also known as "Incident Report Status Date.")
- C2.1.14.1. <u>Field 13B, Situation Incident Unsubstantiated, Unresolved</u>. A designation indicating the CRC determined, for clinical purposes, that the preponderance of the available information to support an alleged incident is of the same weight or equally convincing as the information that the alleged incident of abuse or maltreatment did not occur.
- C2.1.14.2. <u>Field 13C</u>, <u>Situation Incident Unsubstantiated</u>, <u>Did Not Occur</u>. A designation indicating an alleged incident has been determined by the CRC to be without merit or foundation for clinical purposes. An "Unsubstantiated Situation Did Not Occur" determination means the preponderance of available information indicating maltreatment or

abuse did not occur is of greater weight or more convincing than the information indicating abuse or maltreatment occurred.

- C2.1.14.3. Field 13D, Situation Unsubstantiated, Referred for Services. A designation indicating the incident was presented to the CRC for determination and although some form of maltreatment may have occurred, either (1) the incident did not meet the criteria for an appropriate referral to FAP and was referred to another agency for appropriate intervention services, such as an incident of child maltreatment allegedly committed by someone outside the family who was not in a caregiving relationship, or when either the victim or alleged offender is a non-beneficiary, or (2) although it met the criteria for an appropriate referral to FAP, the resulting harm was assessed to be moderately low or lower in severity level, the likelihood of recurrence was assessed to be moderately low or lower in risk level, and intervention services were only recommended.
- C2.1.14.4. <u>Field 13E</u>, <u>Situation Incident Substantiated</u>. A designation indicating an alleged incident has been determined by the CRC to be merited or founded for clinical purposes. A "Substantiated" determination means the preponderance of available information indicating abuse or maltreatment occurred is of greater weight or more convincing clinically than the information indicating abuse or maltreatment did not occur.
- C2.1.14.5. <u>Field 13F, Situation Incident Transferred In Date</u>. The calendar date on which a FAP received an incident file already clinically determined as "Substantiated" from a FAP of the same or different Military Service. Case Review Committee accepts the previous Case Review Committee's determination.
- C2.1.14.6. Field 13G, Situation Incident Transferred Out Date. The calendar date on which a FAP sent an incident file reporting its CRC had clinically determined as "Substantiated" to a FAP of the same or different Military Service.
- C2.1.14.7. Field 13H, Situation Substantiated Incident Closed Date. The date a "Substantiated" incident was closed by the FAP because (1) the CRC determined intervention and/or treatment was no longer needed or possible, (2) the risk of maltreatment was considered minimal, (3) the sponsor and family members were no longer eligible for care, (4) the victim had died, or (5) because the alleged offender refused treatment. Examples of when intervention and/or treatment was no longer possible would include situations in which the victim doesn't progress in treatment or the alleged offender is a treatment failure or refuses treatment. (Also known as "Incident Closed Date.")
- C2.1.15. <u>Field 14, Person Association Reason Code</u>. A designation of the alleged offender's relationship to the victim as being "Intrafamilial," or "Extrafamilial." (Also known as "Relationship of Alleged Offender to Victim.")
- C2.1.15.1. <u>Intrafamilial</u>. A designation of a current familial relationship created by birth, law, or marriage between the alleged offender and victim, such as a parent, sibling, spouse, or other family member.

- C2.1.15.1.1. <u>Parent</u>. A designation identifying an alleged offender as the biological, step-, adoptive, or foster parent of a child.
- C2.1.15.1.2. <u>Spouse</u>. A designation identifying an alleged offender as married to the victim. This includes a marriage to an individual who is under 18 years of age.
- C2.1.15.1.3. <u>Sibling</u>. A designation to identify an alleged offender in a child maltreatment case who is the child victim's sister, brother, stepsister, stepbrother, or foster sister or brother AND who was providing care to the child.
- C2.1.15.1.4. Other Family Member. A designation to identify an alleged offender in a child maltreatment case who was providing care to the child and who is related by blood, law, or marriage to the child victim.
- C2.1.15.2. <u>Extrafamilial</u>. A designation classifying the alleged offender as unrelated to the victim by blood, law, or marriage (i.e., as being outside the victim's family).
- C2.1.15.2.1. Extrafamilial Caregiver. The classification of an alleged offender who is an employee (including janitors, bus drivers, etc.), independent contractor, or volunteer in a military-sanctioned or military-sponsored program providing care for and supervision of a child by agreement with the child's parent, guardian, or foster parent. The program includes non-certified temporary babysitters in the home. Such care and supervision may be provided in the child's home, in a military-sanctioned caregiver's home, at a military-sponsored or military-sanctioned out-of-home care facility, residential facility or school, or in military-sponsored or military-sanctioned activity conducted at various locations.
- C2.1.15.2.2. <u>Extrafamilial Non-Caregiver, Acquaintance.</u> Someone known to the victim's family but outside the victim's family who is NOT in a caregiving role, and is NOT an employee, independent contractor, or volunteer in a military-sanctioned or military-sponsored program providing care for and supervision of a child by agreement with the child's parent, guardian, or foster parent.
- C2.1.15.2.3. Extrafamilial Non-Caregiver, Stranger. Someone previously unknown to the victim's family and outside the victim's family who is NOT in a caregiving role, and is NOT an employee, independent contractor, or volunteer in a military-sanctioned or military-sponsored program providing care for and supervision of a child by agreement with the child's parent, guardian, or foster parent.
- C2.1.15.2.4. <u>Former Spouse.</u> A person of the opposite sex who was once married to the victim, but is legally divorced from the victim.
- C2.1.15.2.5. <u>Intimate Partner.</u> A person of the opposite sex with whom the victim shares a child in common, or a person with whom the victim shares or has shared a common domicile.

- C2.1.15.2.6. <u>Relationship Unknown.</u> The designation for an alleged offender who is unknown because the victim is physically or psychologically unable or unwilling to identify the alleged offender. Includes instances in which the victim is deceased or too young.
- C2.1.16. <u>Field 15, Extrafamilial Caregiver Type Code</u>. The classification of an alleged extrafamilial caregiver offender as follows:
- C2.1.16.1. <u>Military Child Care Center Personnel</u>. A staff member or volunteer in a military-sanctioned or military-sponsored child development or child care program directly caring for and supervising children. Examples include personnel in programs such as nursery schools, pre-schools, Sure Start programs, or parent co-operatives providing services in a centralized facility. This designation does not include home-based child care.
- C2.1.16.2. <u>Military Family Child Care Personnel</u>. A certified provider, family member of a certified provider over the age of 12, or other person living in a military-sanctioned family childcare home. Military home-based child care is provided on a regular or daily basis (10 hours per week or more) for compensation in a provider's Government quarters with the approval and certification of the commanding officer. This designation does not include random or temporary baby-sitting services.
- C2.1.16.3. <u>Military Youth Program Personnel</u>. A staff member or volunteer in a military-sanctioned or sponsored program, service, or activity focusing on youth, including recreation programs, camps, scouting, clubs, and educational classes.
- C2.1.16.4. <u>Teacher/Other DoD School Personnel</u>. A staff member or volunteer in a military-sanctioned or sponsored school or kindergarten, through grade 12. It includes staff members and volunteers in schools administered by the Department of Defense Educational Activity. It does not include staff or volunteers in civilian schools located outside the military installation, unless the program, service, or activity is military-sponsored or sanctioned.
- C2.1.16.5. Other DoD Sanctioned Caregiver. A staff member or volunteer of any military-sponsored or sanctioned program, service, or activity responsible for the child that is not a child care center, family child care program, youth program, or DoD school. Examples include the chaplaincy, medical staff, civil air patrol, and YMCA.
- C2.1.16.6. <u>Non-DoD-Sanctioned Caregiver.</u> A caregiver who is not sponsored or sanctioned by the Department of Defense. It includes nannies, temporary babysitters certified by the Red Cross, and temporary babysitters in the home, and other family members.

#### C3. CHAPTER 3

#### **DATA SUBMISSION PROCEDURES**

#### C3.1. EDIT STANDARDS

- C3.1.1 Each Service is responsible for the quality of the child maltreatment and domestic abuse data sent to DMDC to be incorporated into the DoD Child Maltreatment and Domestic Abuse Central Registry.
- C3.1.2. Before sending to DMDC, ensure all data has been checked and meets the standards listed in Appendix 2.

#### C3.2. DATA SPECIFICATIONS

- C3.2.1. Use blanks for non-applicable or non-available data.
- C3.2.2. Alpha and alphanumeric data shall be left-justified with trailing blanks.
- C3.2.3. Alpha and alphanumeric data shall be in upper case.
- C3.2.4. Numeric data shall be right-justified with leading zeroes.
- C3.2.5. Records shall be sorted in sequence by incident number (situation identifier.)
- C3.2.6. Data shall be submitted in its entirety to the DMDC not later than twenty (20) days after the end of each calendar year quarter. The DMDC will use new submissions to replace existing data files.
- C3.2.7. The DMDC will return submissions containing errors with appropriate error notification to the submitting agency. The submitting agency will make the appropriate corrections and resubmit the information.

#### C3.3. FILE TRANSFER PROTOCOL (FTP).

- C3.3.1. The FAPM shall establish contact with the DMDC point of contact who will oversee the data relationship. The DMDC contact will assign each FAPM an account number and a password.
- C3.3.2. The DMDC supports the standard FTP software on IBM mainframes. The DMDC contact will inform the FAPM of other system specifications.
  - C3.3.3. All data submissions shall include the total record counts for each file submitted.
  - C3.3.4. The DMDC contact should be notified by e-mail of all data submissions.

#### C4. CHAPTER 4

#### RELEASE OF INFORMATION AND RECORD RETENTION

#### C4.1. AUTHORIZED RELEASE OF INDIVIDUAL INFORMATION

- C4.1.1. Requests from individuals for information about themselves will be processed under the Privacy Act procedure (reference (d)).
- C4.1.2. All other requests for information about individuals, to include those contained in reference (c), will be forwarded for action to the individual's sponsoring DoD Component. DoD Component access to information containing personal identifiers shall be limited solely to the DMDC's use for official statistical analysis and record verification.
- C4.1.3. Requests for information about individuals for use in determining suitability for special assignments, promotions, and select positions such as drill sergeants and recruiters is not authorized.

#### C4.2. AUTHORIZED RELEASE OF STATISTICAL INFORMATION.

The DMDC shall extract statistical information upon request from a DoD Component. The DMDC shall also extract child maltreatment and domestic abuse incident data annually for OSD. Personal identifiers or any information identifiable by circumstance shall not be released as a part of the extract. In the case of a request not from a DoD Component for statistical information, DMDC shall contact the OSD FAPM for authorization before release of data.

#### C4.3. RECORD FILE RETENTION.

C4.4.1. Information identifying the victim, the victim's sponsor, and the alleged offender in a substantiated incident of child maltreatment or domestic abuse is kept indefinitely to conduct background criminal and suitability checks for those providing services to military families.

#### AP1. APPENDIX 1

#### **DEFINITIONS**

- AP1.1. <u>Abandonment</u>. A type of child neglect in which the caregiver is absent and does not intend to return or is away from home for more than 24 hours without having arranged for an appropriate surrogate caregiver.
- AP1.2. <u>Alleged Offender</u>. An individual who allegedly physically or sexually abused, emotionally maltreated, or neglected his or her child or sibling, a current or former spouse or intimate partner of the opposite sex with whom the individual has shared a domicile, or an intrafamilial or extrafamilial caregiver who allegedly physically or sexually abused, emotionally maltreated, or neglected a child in his or her care.
- AP1.3. <u>Case</u>. One or more alleged or substantiated incidents of child maltreatment or domestic abuse pertaining to the same victim.
- AP1.4. <u>Case Review Committee (CRC)</u>. A multidisciplinary team of designated individuals working at the installation level, tasked with the clinical evaluation and determination for clinical purposes of all incidents of child maltreatment or domestic abuse reported to the family advocacy program and the development and coordination of treatment and disposition recommendations for substantiated incidents.
- AP1.5. <u>Child</u>. For the purposes of this Manual and the FAP, a "child" is an unmarried person under 18 years of age eligible for care through a DoD medical treatment program, and for whom a parent, guardian, foster parent, caregiver, employee of a residential facility, or any staff person providing out-of-home care is legally responsible. The term "child" means a biological child, adopted child, stepchild, foster child, or ward. The term also includes an individual of any age who is incapable of self-support because of a mental or physical incapacity, and for whom treatment in a DoD medical treatment program is authorized.
- AP1.6. <u>Child Maltreatment</u>. The physical or sexual abuse, emotionally maltreatment, or neglect of a child by a parent, guardian, foster parent, or by a caregiver, whether the caregiver is intrafamilial or extrafamilial, under circumstances indicating the child's welfare is harmed or threatened. Such acts by a sibling, other family member, or other person shall be deemed to be child maltreatment only when the individual is providing care under express or implied agreement with the parent, guardian, or foster parent.
- AP1.7. <u>Child Maltreatment and Domestic Abuse Incident Report</u>. An electronic submission of data concerning each incident of child maltreatment or domestic abuse reported to the FAP.
- AP1.8. <u>Deprivation of Necessities</u>. A type of child neglect including the failure to provide appropriate nourishment, shelter, and clothing.
- AP1.9. <u>DoD Civilian Employee</u>. A permanent employee of the Department of Defense who is a U.S. citizen and who is paid from appropriated or nonappropriated funds.

- AP1.10. <u>Domestic Abuse</u>. (1) domestic violence or (2) a pattern of behavior resulting in emotional/psychological abuse, economic control, and/or interference with personal liberty when such violence or abuse is directed toward a person of the opposite sex who is: (a) A current or former spouse; (b) A person with whom the abuser shares a child in common; or (c) A current or former intimate partner with whom the abuser shares or has shared a common domicile.
- AP1.11. <u>Domestic Violence</u>. An offense under the United States Code, the Uniform Code of Military Justice, or State law involving the use, attempted use, or threatened use of force or violence against a person-of the opposite sex, or the violation of a lawful order issued for the protection of a person-of the opposite sex, who is: (a) A current or former spouse; (b) A person with whom the abuser shares a child in common, or (c) A current or former intimate partner with whom the abuser shares or has shared a common domicile.
- AP1.12. <u>Educational Neglect</u>. A type of child neglect including knowingly allowing the child to have extended or frequent absences from school, neglecting to enroll a child in school, or preventing the child from attending school for other than justified reasons.
- AP1.13. Emotional Maltreatment of a Child. A type of child maltreatment including acts or a pattern of acts, omissions or a pattern of omissions, or passive or passive-aggressive inattention to a child's emotional needs resulting in an adverse affect upon the child's psychological well-being. Emotional maltreatment includes intentional berating, disparaging or other verbally abusive behavior toward the child, and violent acts that may not cause observable physical injury.
- AP1.14. <u>Emotional Maltreatment of a Spouse or Intimate Partner</u>. A type of domestic abuse including acts or threats adversely affecting the psychological well-being of a current or former spouse or intimate partner, including those intended to intimidate, coerce, or terrorize the spouse. Such acts and threats include those presenting likely physical injury, property damage or loss, or economic injury.
- AP1.15. <u>Exploitation</u>. A type of child sexual abuse in which the child is made to participate in the sexual gratification of another person without direct physical contact between them. Exploitation includes forcing or encouraging a child to do any of the following: to expose the child's genitals or (if female) breasts, to look at another individual's genitals or (if female) breasts, to observe another's masturbatory activities, to view pornographic photographs or read pornographic literature, to hear sexually explicit speech, or to participate in sexual activity with another person, such as in pornography or prostitution, in which the alleged offender does not have direct physical contact with the child.
- AP1.16. <u>Family Advocacy Program (FAP)</u>. A program designed to address prevention, reporting, identification, evaluation, treatment, rehabilitation, and follow-up of child maltreatment and domestic abuse.

- AP1.17. <u>Family Advocacy Program Manager (FAPM)</u>. An individual designated by the Secretary of the Military Department or the head of another DoD Component to manage, monitor, and coordinate the FAP at the headquarters level.
- AP1.18. <u>Family Members</u>. Includes those individuals for whom the Service member provides medical, financial, and logistical (for example, housing, food, clothing) support. This includes the spouse, children under the age of 18, elderly adults, and persons with disabilities.
- AP1.19. <u>Incident</u>. A single allegation of one or more acts of child maltreatment or domestic abuse that occurred in a short period of time. An incident shall refer only to one victim, but may include more than one alleged offender.
- AP1.20. <u>Incident Data</u>. Information about a reported incident of child maltreatment or domestic abuse. Incident data in an unsubstantiated incident does not contain any information specifically identifying the alleged victim, the sponsor of the alleged victim, or the alleged offender. In substantiated incidents the data includes identifying information about the victim, the victim's sponsor, and the alleged offender.
- AP1.21. <u>Incident Status</u>. The status of the reported incident for clinical purposes as determined by the CRC. Includes "unsubstantiated unresolved," "unsubstantiated did not occur," "unsubstantiated referred for services," or "substantiated."
- AP 1.22. <u>Intimate Partner</u>. A person of the opposite sex with whom the victim shares a child in common, or a person with whom the victim shares or has shared a common domicile.
- AP1.23. <u>Lack of Supervision</u>. A type of child neglect characterized by the absence or inattention of the parent, guardian, foster parent, or other caregiver resulting in injury to the child, in the child being unable to care for himself or herself, or in injury or serious threat of injury to another person because the child's behavior was not properly monitored.
- AP1.24. Medical Neglect. A type of child neglect in which a parent or guardian refuses or fails to provide appropriate, medically necessary health care (medical, mental health, dental) for the child although the parent is financially able to do so or was offered other means to do so. The term does not include the failure to provide treatment (other than appropriate nutrition, hydration, or medication) to a child when, in the treating physician's or physicians' reasonable medical judgment:
  - AP1.24.1. The child is chronically and irreversibly comatose;
- AP1.24.2. The provision of such treatment would merely prolong dying, not be effective in ameliorating or correcting all of the child's life-threatening conditions, or otherwise be futile in terms of the survival of the child, or the provision of such treatment would be virtually futile in terms of the survival of the child and the treatment itself under such circumstances would be inhumane.

- AP1.25. <u>Molestation</u>. A type of child sexual abuse involving fondling or stroking a child's breasts or genitals, oral sex, or attempted penetration of the child's vagina or rectum.
- AP1.26. <u>Neglect</u>. The negligent treatment of a person through acts or omissions by an individual responsible for the victim's welfare under circumstances indicating the victim's welfare is harmed or threatened.
- AP1.27.1 <u>Child Neglect</u>. The negligent treatment of a child through acts or omissions by an individual responsible for the child's welfare under circumstances indicating the child's welfare is harmed or threatened. Includes "Abandonment," "Deprivation of Necessities," "Educational Neglect," "Lack of Supervision," "Medical Neglect," and/or "Non-Organic Failure to Thrive."
- AP1.27.2. <u>Spousal Neglect</u>. A type of domestic abuse in which an adult fails to provide necessary care or assistance for his or her spouse who is incapable of self-care physically, emotionally, or culturally.
- AP1.28. <u>Non-Beneficiary</u>. A person who is not eligible to receive medical treatment in a military medical program.
- AP1.29. <u>Non-Organic Failure to Thrive</u>. A type of child neglect which manifests itself in an infant's or young child's failure to adequately grow and develop when no organic basis for this deviation is found. Usually such children register below the third percentile in height and weight.
- AP1.30. <u>Out-of-Home Care</u>. The responsibility of care for and/or supervision of a child in a setting outside the child's home by an individual placed in a caretaker role sanctioned by a Military Service or Defense Agency or authorized by the Service or Defense Agency as a provider of care, such as care in a child development center, school, recreation program, or family child care.
- AP1.31. Physical Abuse. Acts such as grabbing, pushing, holding, slapping, choking, punching, kicking, sitting or standing upon, lifting and throwing, burning, immersing in hot liquids or pouring hot liquids upon, hitting with an object (such as a belt or electrical cord), and assaulting with a knife, firearm, or other weapon that caused or may cause bodily injuries. Such injuries include brain damage or skull fracture, subdural hemorrhage or hematoma, bone fracture, dislocations or sprains, internal injury, poisoning, burns or scalds, severe cuts, lacerations, bruises or welts. An injury does not have to be visible for physical abuse to have occurred.
- AP1.31.1. <u>Physical Abuse of a Child</u>. A type of child maltreatment involving physical abuse. In infants and toddlers, it includes acts of shaking or twisting the child, which may cause brain damage, subdural hemorrhage, and hematoma. It does not include discipline administered by a parent or legal guardian to his or her child provided it is reasonable in manner, and moderate in degree and otherwise does not constitute cruelty.
  - AP1.31.2. Physical Abuse of a Spouse or Intimate Partner. Acts of domestic violence.

- AP1.32. <u>Rape or Intercourse with a Child</u>. A type of child sexual abuse involving the penetration of the vagina, however slight, by means of physical force, from emotionally manipulating the child, or by taking advantage of a child's naiveté.
- AP1.33. <u>Rape of a Spouse or Intimate Partner</u>. A type of domestic violence involving the penetration of the vagina, however slight, by means of physical force.
- AP1.34. <u>Reasonable Medical Judgment</u>. A medical judgment made by a reasonably prudent physician knowledgeable about the case and the treatment possibilities for the medical conditions involved.
- AP1.35. Sexual Abuse. Illegal sexual activity with a child, spouse, or intimate partner.
- AP1.35.1. <u>Child Sexual Abuse</u>. Sexual activity with a child for the purpose of sexual gratification of the alleged offender or some other individual. Includes "Child Exploitation," "Molestation," "Rape/Intercourse of a Child," and "Sodomy."
- AP1.35.2. <u>Sexual Abuse of a Spouse or Intimate Partner</u>. Acts of domestic abuse or domestic violence to coerce the spouse or intimate partner to engage in any sexual activity. It includes "Rape/Intercourse," "Sodomy," and coercing the spouse to participate in sexual activity with another person, as in pornography or prostitution.
- AP1.36. <u>Sodomy of a Child</u>. A type of child sexual abuse involving the penetration of the mouth or rectum, however slight, by means of physical force, from emotionally manipulating the child, or by taking advantage of a child's naiveté.
- AP1.37. <u>Sodomy of a Spouse or Intimate Partner</u>. A type of domestic violence involving the penetration of the mouth or rectum, however slight, by means of physical force.
- AP1.38. Spouse. A married individual who is either (1) a Service member; (2) employed by the Department of Defense and eligible for care through DoD medical treatment programs, or (3) a civilian who is eligible for care through DoD medical treatment programs because of marriage to a Service member, or to an employee of the Department of Defense who is eligible for care through DoD medical treatment programs. This includes a married individual who is under 18 years of age.
- AP1.39. <u>Victim</u>. A child or current or former spouse or intimate partner of the opposite sex who is the subject of an alleged incident of child maltreatment or domestic abuse because he/she was allegedly maltreated by the alleged abuser.
