
Preview: Three Points

National partnership of National Guard & Department of Veterans Affairs

Need:

- Over 50% of OEF/OIF National Guard & Reserves
- National Guard members became Combat Veterans
 - Hail from small towns & rural communities
 - Temporarily leave civilian jobs & their own businesses
 - Lack supporting infrastructure of military bases (medical, psychiatric, support personnel)
 - Lack familiarity with benefits & entitlements earned
- Reintegration requires access to services



Mission


- Goal- Maximize access to services for reintegration
 - Develop State Coalitions
 - Coordinate delivery of VA & Community Services for Guard & Reserve Veterans
 - Inform Active duty, Veterans, Families
 - Link to health care, services, benefits, insurance, Tricare
 - Refer for counseling & rehabilitative care
 - Assist with job search or financial needs
 - Connect to VBA & VSOs to file for disability





Coalitions for Reintegration

"...develop a continuum of care that has no gaps in service provision, whether in transition from DoD to VA's health care system or in subsequent linkages... in the veteran's community" (NAPA, 2008, p. 16).



Coalitions Work in Population Health

Core of prevention initiatives since 1990

- 1. Preventing risky behavior
 - tobacco, drug, alcohol abuse
- 2. Promoting healthy behavior
 - immunizations, seat belt use, physical activity, cancer screening
- 3. Managing chronic disease
 - asthma, diabetes, obesity
- 4. Enhancing access
 - Services, benefits, for military or veteran returnees



Coalitions Integrate Services

- Coalition
 - alliance of diverse organizations (public, private, nonprofit & voluntary officials, leaders and citizens) work on a common goal
- Integration of Services
 - For example, Acute care, Rehabilitation, Therapies, Equipment, Education, Employment, Housing, Transportation, Insurance, Financial aid



Coalition Success Factors

- Internal coalition functioning & External community changes
- Leadership style & governance
- Diverse coalition membership
- Process- collaboration, coordination, integration
- Cultural competence
- Communication, outreach, negotiation



Current Knowledge

- Studies of integrated health & social services
 - Generally- lack theoretical frameworks, consistent measurement across studies, instrument validity, single-case studies, only one study coalition development
 - Specific to OEF-OIF limited to subsets of veteran population (homeless veterans; mental health services), qualitative study



TAA State Coalitions Study

- Purpose
 - Explore state level coalitions established by the TAA Program to facilitate reintegration of OEF/OIF service members, National Guard and Reserves
- Aims
 - 1. Document national implementation
 - 2. Add to our understanding of organizational factors that contribute to successful implementation and reintegration






National Guard & VA Partnership
