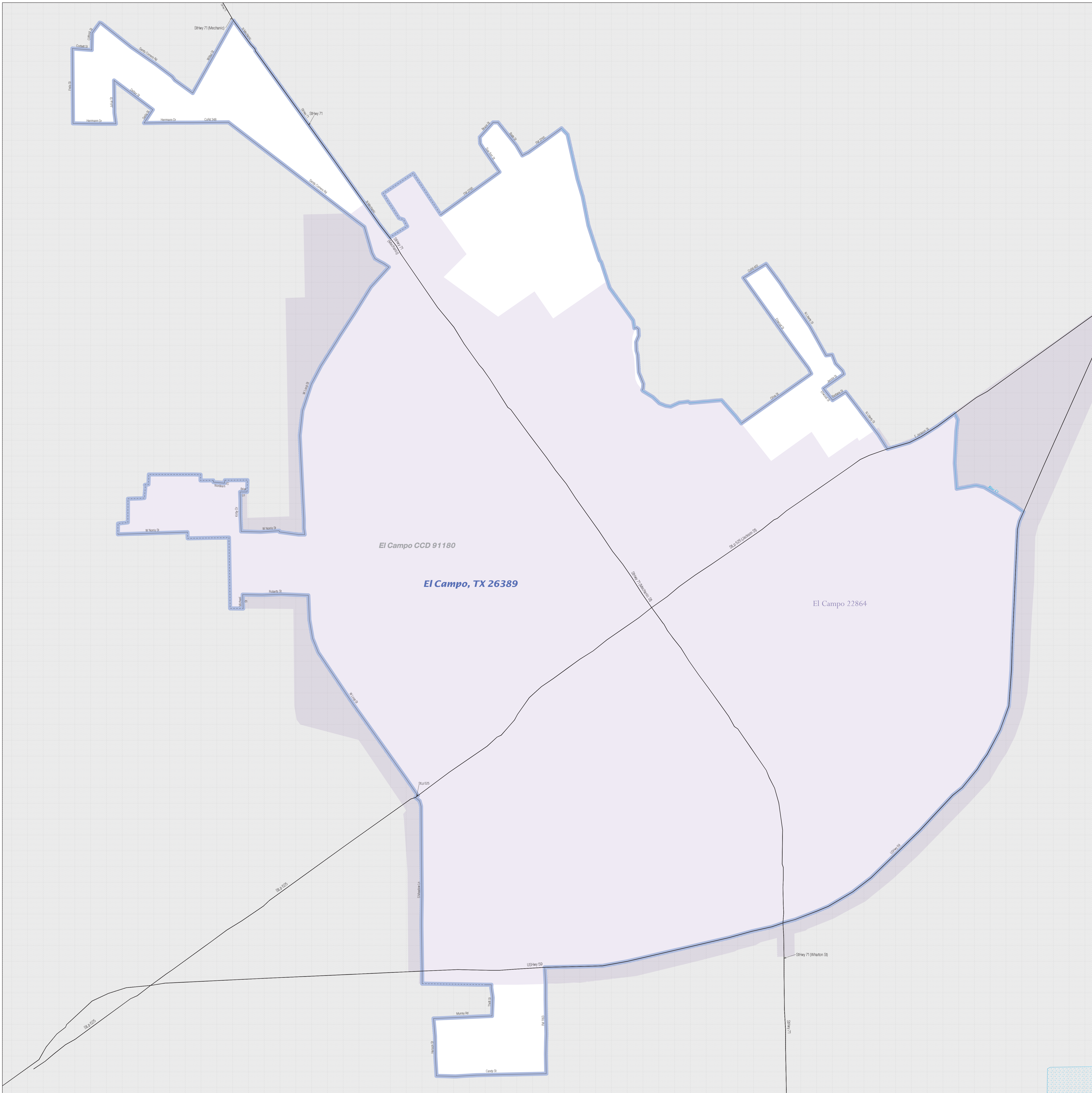


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) El Campo, TX
