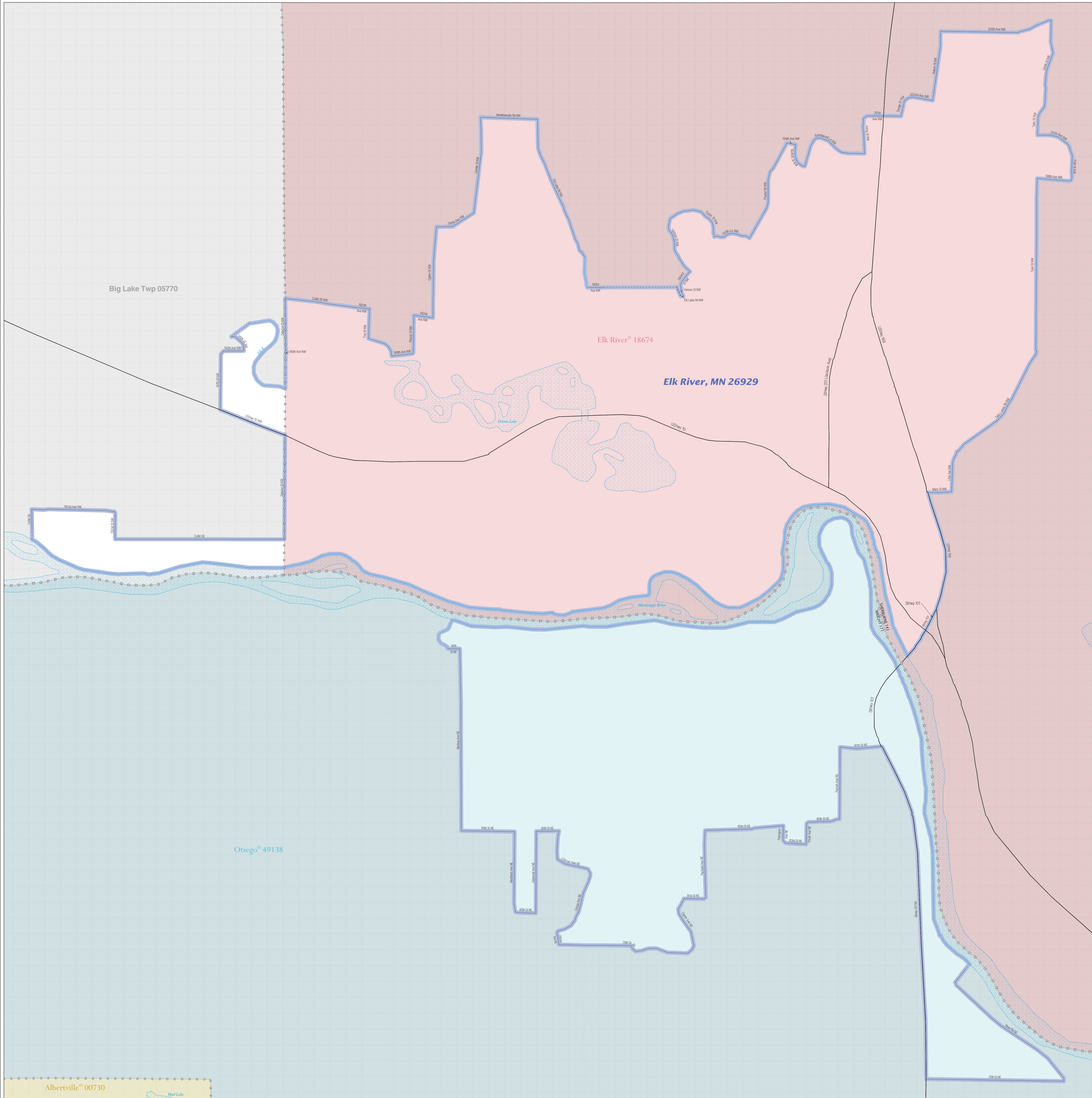


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Elk River, MN
