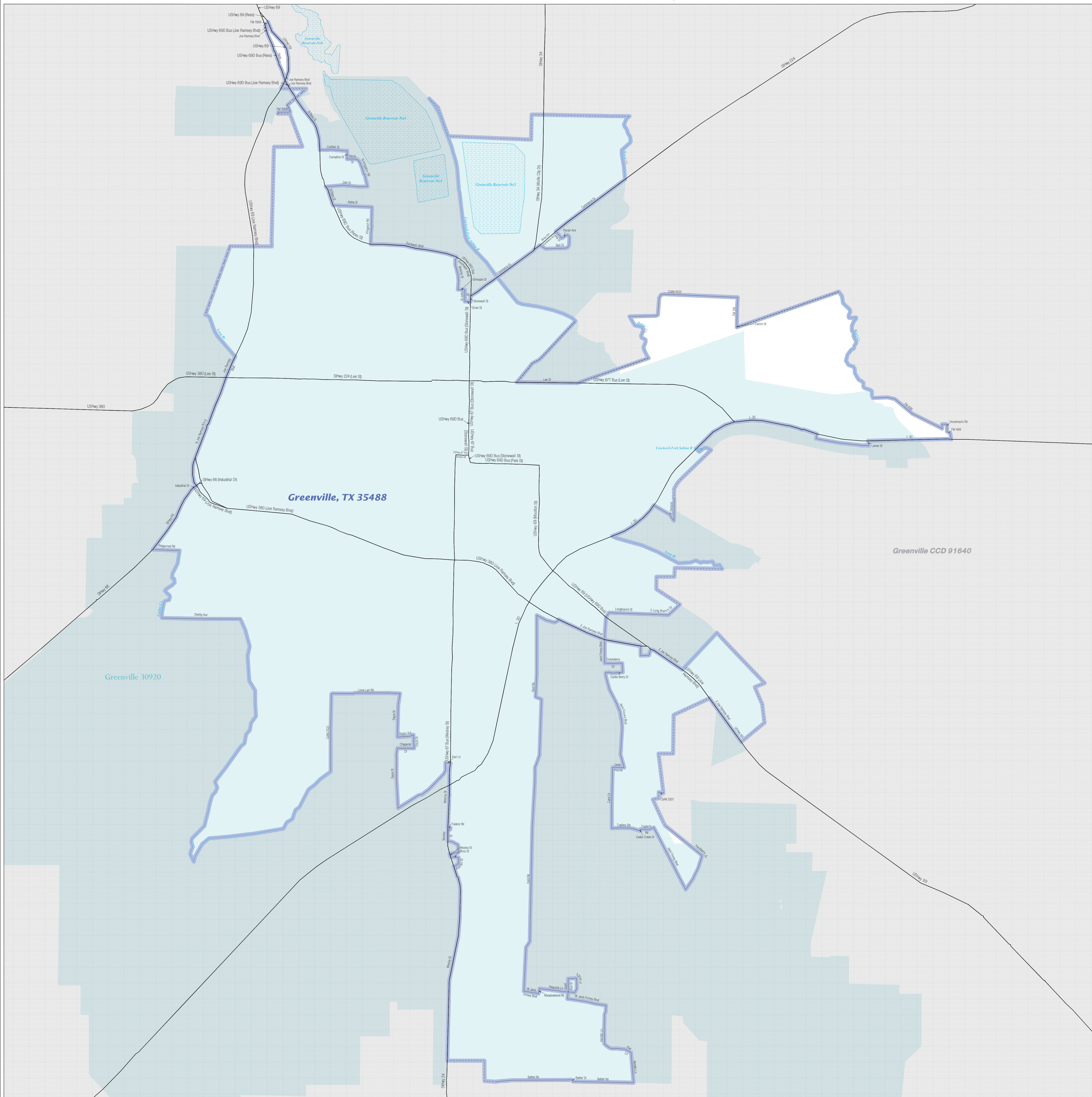


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Greenville, TX
