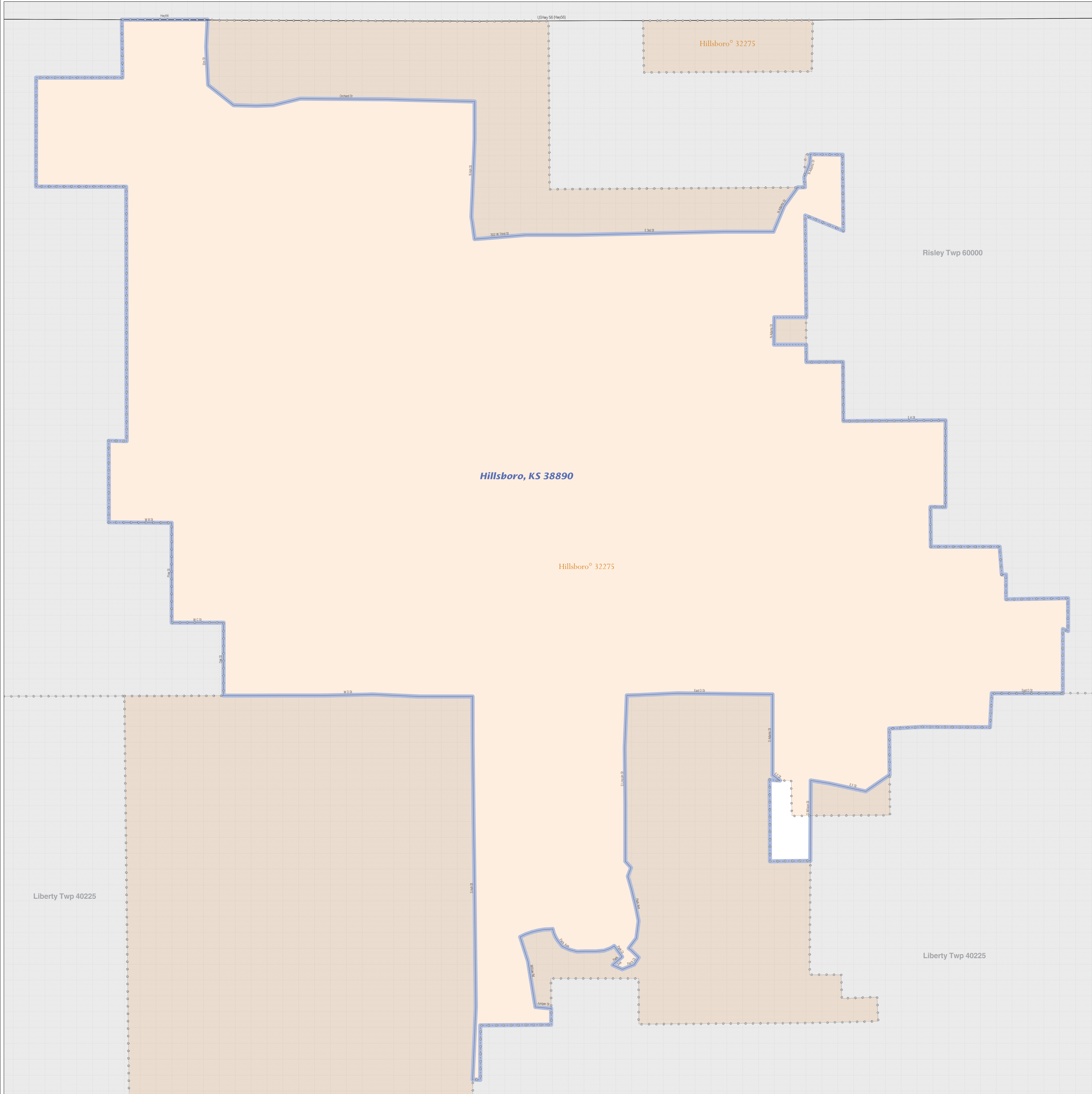


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Hillsboro, KS
