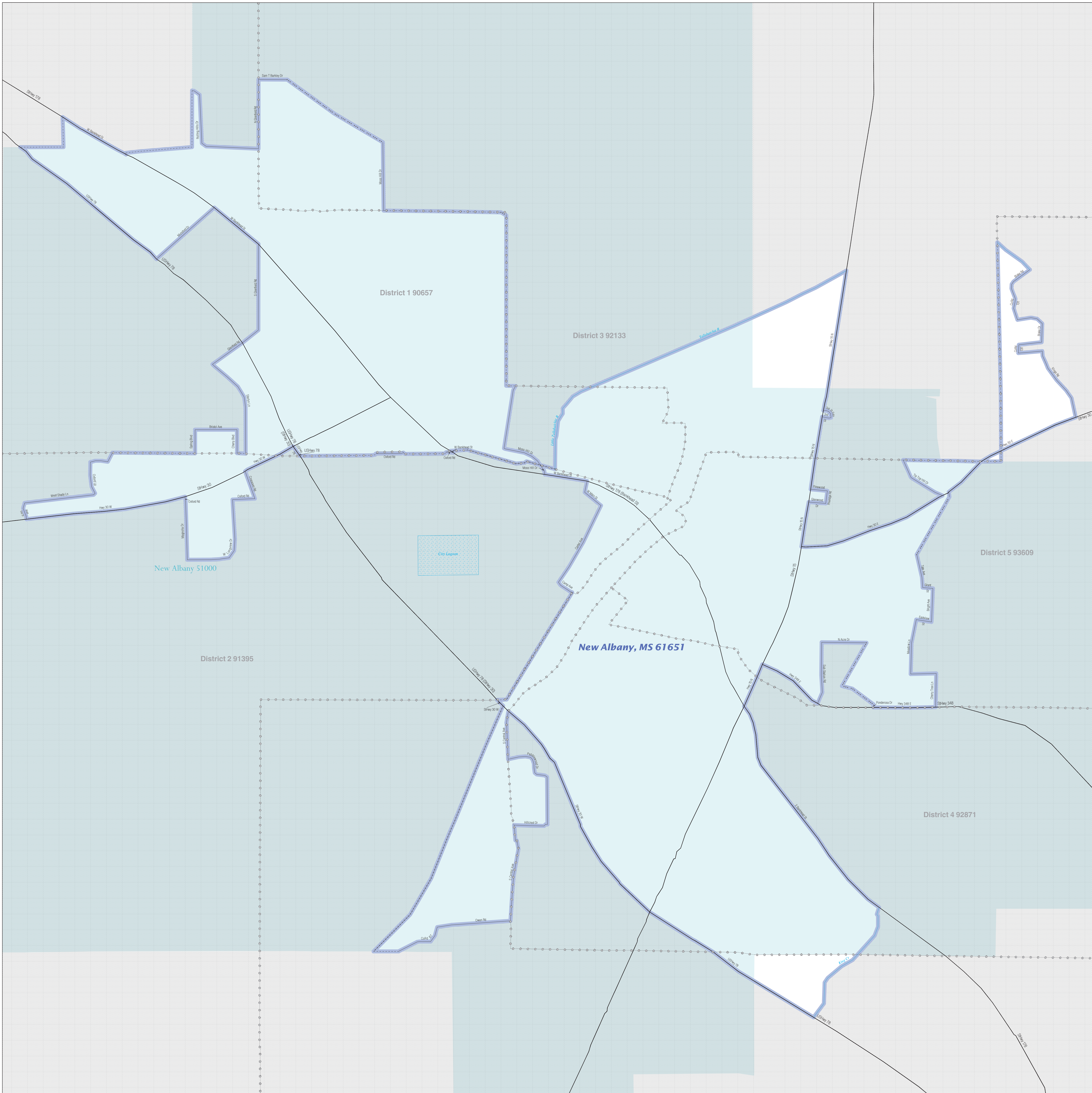


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) New Albany, MS
