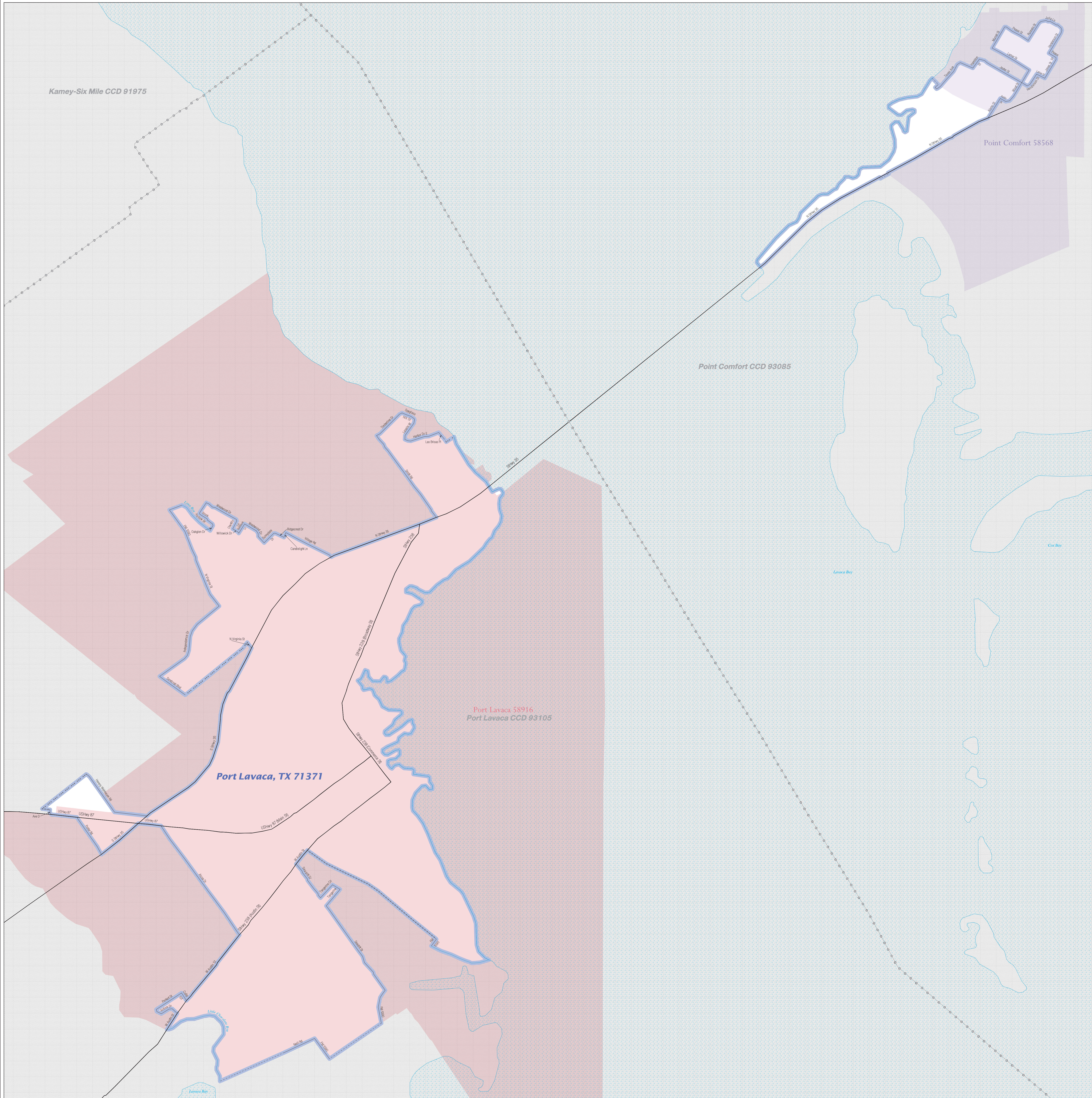


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Port Lavaca, TX
