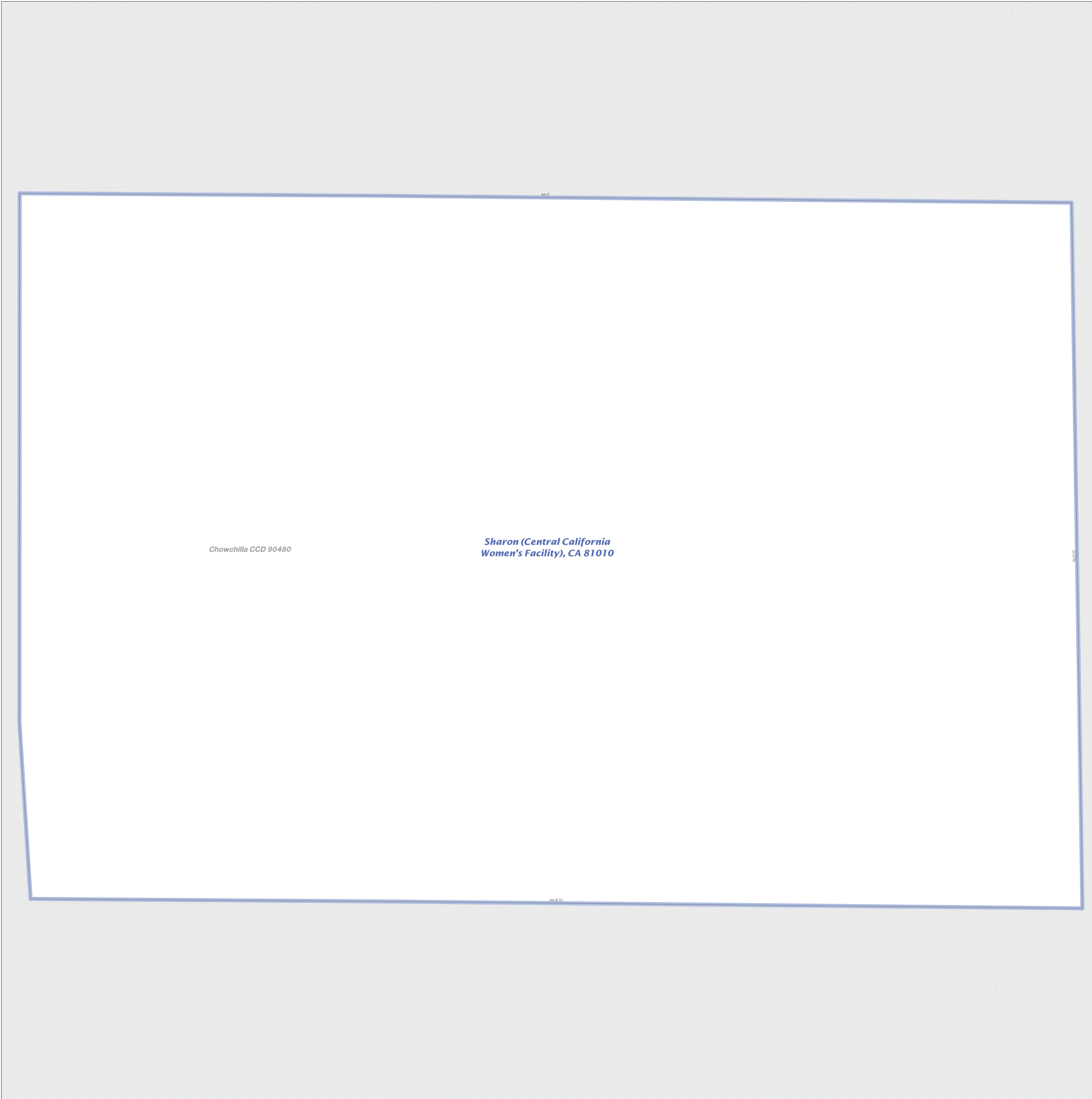


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Sharon (Central California Women's Facility), CA
