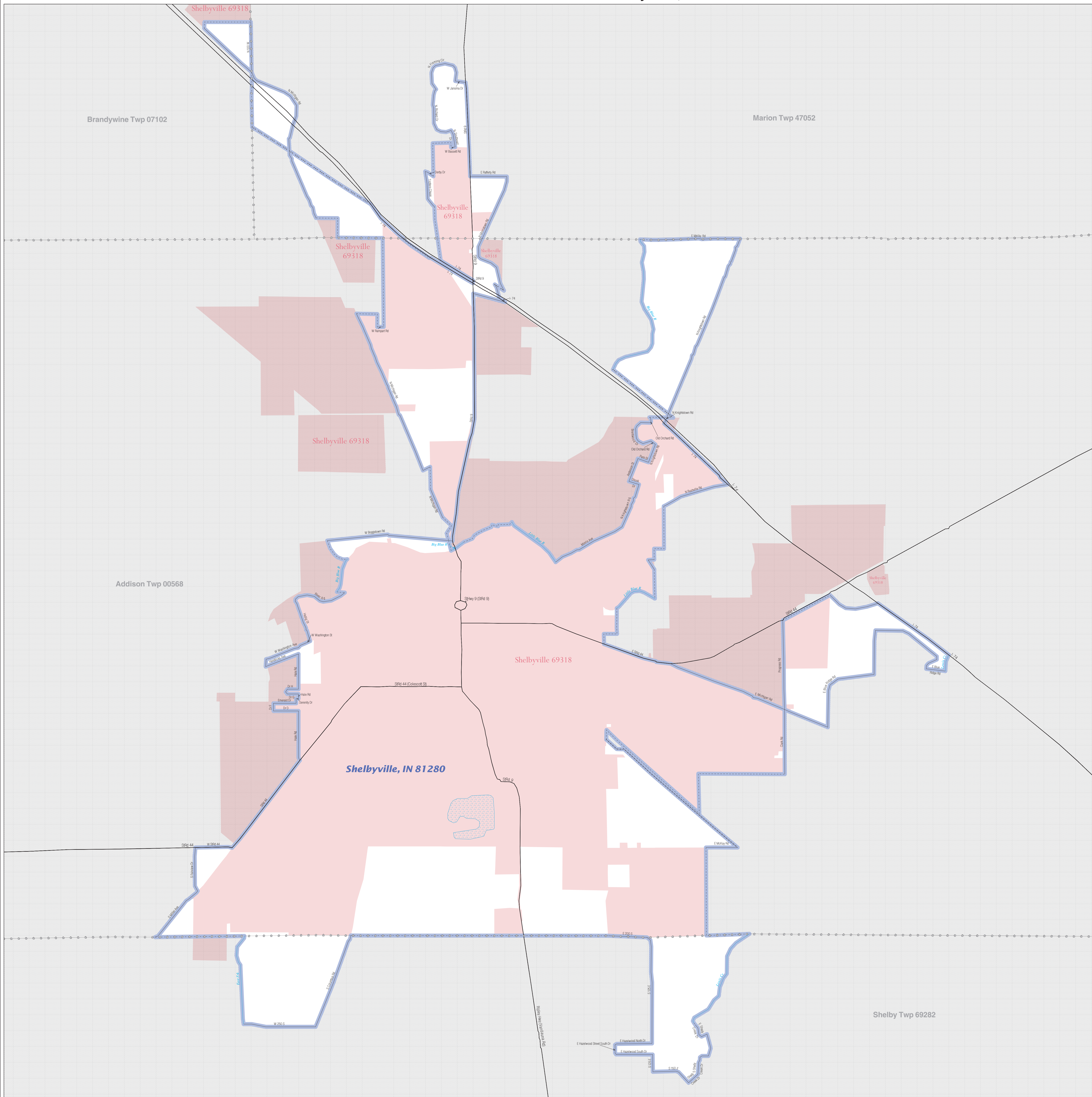


# URBAN CLUSTER OUTLINE MAP (CENSUS 2000) Shelbyville, IN
