## John P. Lavinus III Director of Resale Contracting

John P. Lavinus III is director of resale contracting for the Defense Commissary Agency, headquartered at Fort Lee, Va., a position he has held since March 2011.

In his current position, Mr. Lavinus is responsible for managing and directing the execution of the acquisition mission for all agency brand and non brand name resale products and services. This is a critical acquisition position in accordance with the Defense Acquisition Workforce Improvement Act (DAWIA).

Prior to his appointment as director of resale contracting, Mr. Lavinus served as the agency's director of contracting, leading more than 80 employees in three divisions – commercial services, contracting and policy, and systems – and directing the agency's acquisition activities for services, supplies, equipment, construction and resale, exceeding \$5.8 billion annually. Mr. Lavinus is contracting-level-3 certified and is a member of the Defense Acquisition Corps.

From 2004 to 2005, he served as the acquisition directorate's chief of contracting, managing more than \$56 million in annual acquisitions. He was instrumental in merging the functions of services acquisition support for stores and regions at DeCA headquarters.
