#### *Eric Swayzee* Director of Logistics

Eric Swayzee is the director of logistics for the Defense Commissary Agency, headquartered at Fort Lee, Va., a position he has held since October 2011. As the agency's logistics director, Mr. Swayzee oversees the operations and business processes of 10 overseas central distribution centers, the central meat processing plant in Europe, management and accountability for operational equipment and supplies, and the agency's distribution and transportation operations supporting nearly 250 commissaries in 13 countries, and 900 dedicated employees.

Mr. Swayzee has more than 35 years of combined military and civil service. Prior to his current assignment, he served as DeCA's business enhancement officer, responsible for managing automated business operations for the agency. Mr. Swayzee began his commissary career as an enlisted airman assigned to the Air Force Commissary Service (AFCOMS) and culminated a 20-year Air Force career as a chief master sergeant responsible for DeCA's Air Force troop support and wartime missions and the subsequent transfer of these missions to the Air Force.

He is the recipient of the Meritorious Civilian Service Award, the Superior Civilian Service Award and numerous military and DoD Awards.
