**NSA/CSS EVALUATED PRODUCTS LIST  
for  
OPTICAL MEDIA DESTRUCTION DEVICES**

This Evaluated Products List (EPL) contains a listing of destruction devices that have been evaluated by the National Security Agency (NSA) or its designee and meet the performance requirements of NSA/CSS Specification 04-02, Optical Media Destruction Devices. Inclusion of a product in the EPL is not an endorsement by NSA or the U.S. Government.

The EPL provides the device name, manufacturer, distributor, and sales/marketing contacts for each destruction device evaluated. Models listed have successfully passed evaluation for the security and performance requirements of devices designed for the destruction of optical media (CDs and DVDs). The EPL is organized alphabetically by distributor name.

**The Destruction Evaluations and Guidance Branch of the NSA has determined that disintegrators currently listed on the NSA/CSS 02-02 Evaluated Products List (EPL) also provide adequate security for the destruction of optical media (CDs and DVDs) in accordance with NSA/CSS 04-02, Optical Media Destruction Devices. It is recommended that paper be mixed with the optical media during destruction. Please contact the manufacturer to determine if a specific product is mechanically suited for optical media destruction.**

The EPL shall be updated on a quarterly basis, or as new models are successfully evaluated. Users are encouraged to contact the device manufacturers /distributors for assistance in selecting unit(s) best suited to their requirements and to determine if additional devices have been added to the EPL in the interim.

The procedures for administration and distribution of the EPL are subject to change without notice. Inquiries from U.S. Government users should be forwarded through designated support channels to the NSA Information Assurance Directorate. All other inquiries should be directed to the NSA Public Affairs Office.
