ROBERT E. HARDING, Vice President, Ellenco, Inc., 41st and Webster Streets, Brentwood, Maryland, was telephonically requested to review his records in an effort to determine if they indicated any of his company's equipment is presently installed at the Howard Johnson Motor Lodge, 2601 Virginia Avenue, N.W., Washington, D.C.

Mr. HARDING replied that his records show four such devices were shipped to that location in August, 1962. That two of the devices had serial number 312; one had number 311 and one had number 314. He stated that he did not authorize anyone to remove the seal which reflects number 312 and to do so without authority is a violation of the District of Columbia laws.

In conclusion, Mr. HARDING advised that he would be the proper person to subpoena regarding this seal and instrument.

~~W. RICHARD HOWARD~~, Staff Assistant, White House, was interviewed in the Office of JOHN W. DEAN, Counsel to the President.

HOWARD was shown a memorandum dated April 1, 1972, regarding the removing of EVERETTE HOWARD HUNT, Jr. from the Consultant Job and recommending that he be picked up at 1701 Pennsylvania Avenue, N.W.

HOWARD stated he had learned from CHARLES COLSON that HUNT was no longer needed and that HUNT was not being used by him, COLSON, since he was last working for the Domestic Council.

HOWARD said he forwarded this memo to BRUCE KEHRLI since HUNT could not be hired with the White House Staff since he was on annuity from another Government Agency. Since he was having this problem, it was recommended that HUNT be picked up at 1701 Pennsylvania Avenue, N.W. He stated the memo came back to him with KEHRLI's initials approving the pick up at 1701. He stated he did not know first hand or otherwise if HUNT ever did go to work for 1701 Pennsylvania Avenue.

HOWARD denied any knowledge of the Watergate Burglary and denied ever receiving any information from JAMES WALTER MC CORD, Jr., GEORGE GORDON LIDDY or EVERETTE HOWARD HUNT, Jr. regarding any confidential matters from the Democratic National Committee.

~~WILLIAM RHATICAN~~, Staff Assistant, White House was contacted and interviewed in the office of JOHN DEAN, Counsel to the President, at the Executive Office Building regarding his association with EVERETTE HOWARD HUNT, JR. RHATICAN furnished the following information:

RHATICAN advised that he is the White House liaison with the Advertising Counsel of New York which does such advertising as Hire the Handicap and National Football League Drug commercials, etc. Sometime in October, around the 28th, 1971, HUNT, while as a Consultant with the Office of Education and employed by Robert Mullen Company, was working on a film called, "Closer Look." RHATICAN received a copy of a letter by HUNT to the Advertising Counsel wherein he requested Bulletin Status, that is, a magazine type of advertising which comes out every month. HUNT had asked for Bulletin status on the Closer Look Campaign and the letter was written on Mullen Company stationery. A reply from the Counsel was received sometime later, turning down the request because it came too late.

The next contact he had with HUNT was in the form of a letter dated November 12, 1971, wherein HUNT sent a photograph of JULIE EISENHOWER with handicap children. He, HUNT, suggested in his letter that JULIE do the Closer Look spot with the Handicap children. RHATICAN felt it was a good idea to get JULIE involved, however, he could not do it himself so he referred the matter or suggestion to CONNIE STUART, her assistant, and requested that she bring it before JULIE. At that time, the idea never came across.

Later, on March 28, 1972, RHATICAN received another letter from HUNT who was still trying to get JULIE to do the film. He was working on the script at Robert Mullen Company. HUNT suggested that he be permitted to have JULIE for four hours to do the commercials.

According to RHATICAN's file, he replied to HUNT by letter on March 31, 1972, telling HUNT that JULIE would be available on APRIL 25, 1972, to do the film, but for only 90 minutes.

By letter dated April 10, 1972, HUNT wrote to ALLEN HALL, and forwarded the script over to the White House for their approval.

By letter dated April 14, 1972, RHATICAN replied that the committment was for April 25, 1972, and that JULIE would do the film.

RHATICAN said that the first meeting with HUNT on the matter was on April 24, 1972, when JULIE, HUNT, RHATICAN and TOM RASH of Logos Studios met and discussed the script. JULIE gave her approval after reviewing the script.

On April 25, 1972, the film was completed at Logos Studios Arlington, Virginia.

According to RHATICAN, the next entry in his file reflects that May 23, 1972, the film was reviewed and it was described as good.

On June 28, 1972, the Advertising Council accepted the film spots.

RHATICAN advised that since the completion of the film, he has had no other contact with HUNT.

He stated that for background purposes, HUNT came to the White House or the Executive Office Building on two occasions in October and November of 1971. He stated there were two other contacts with HUNT, in person, at the Executive Office Building after March, 1972. One of these meetings possibly took place at Robert Mullen Company. He stated that at no time did he solicit HUNT to do any work at the White House and that HUNT never told him about any other assignment he was performing or had performed. He stated he never knew HUNT to be involved in any other assignment.

RHATICAN advised that the names of JAMES WALTER McCORD, JR., and GEORGE GORDON LIDDY were not familiar to him, prior to June of 1972. He stated they are known to him now because of the newspaper accounts of their involvment in the Watergate Burglary.

RHATICAN advised that as far as he was concerned, HUNT was not employed by the White House in any capacity while he was involved in the filming of Closer Look, and HUNT never told him that he was a Consultant to the White House. He stated he never saw a claim for any expenses from HUNT and held fast to his belief that HUNT was a consultant for the Office of Education.

RE: The CLOSER LOOK Campaign

Having just heard from Joel Weiss that the Advertising Council had refused us the renewed campaign listing requested last summer - and which until now had been anticipated, (see attachments), I conferred with Bill Rhatican who professed himself as baffled as I over the Council's refusal. Worse, in anticipation of Bulletin listing, collateral TV kit material had been printed at government expense, and is now unusable since it cited Advertising Council listing.

It may be, of course, that listing for CLOSER LOOK was not included in the November-December Bulletin through inadvertence. Otherwise it is difficult to understand how Help for East Pakistani Refugees can compare on the nation's priority list with the education of America's handicapped children, which is what CLOSER LOOK is all about.

For your information, the Bureau of Education for the Handicapped has in final production a number of other television campaign spots. The material printed for inclusion in these mailing kits cites the old March-April Bulletin listing inasmuch as the television spots were not ready for release during that time period.


While it is probably now too late to ameliorate the present unfortunate situation, I trust the Advertising Council will not withhold use of its lists for subsequent CLOSER LOOK television and radio mailings, so much production money having been expended in good faith.

While in Northampton yesterday I was reminded that Julie Eisenhower is involved in graduate studies concerning one or more aspects of child psychology or Special Education ---that general field.

It occurred to me that there might be political benefits accruing from her appearance in a CLOSER LOOK television spot early in 1972. Commissioner Marland has made full educational opportunity for all children one of OE's major priorities, and this thrust is a worthwhile identification for the Administration. Accordingly, we could have OE finance a sympathetic TV spot utilizing Julie, and getting across the message that this Administration not only cares about our young handicapped citizens, but is doing something for them.

Properly produced, and distributed under Ad Council listing, the spot should get several million dollars worth of public service air time with all the related benefits.

USOE Sets 1980 Goal

Sidney P. Marland, Jr., U.S. Commissioner of Education, has urged the adoption of a national goal to provide full educational opportunity for every handicapped child in the Nation by 1980.

"The right of a handicapped child to the special education he needs is as basic to him as is the right of any other young citizen to an appropriate education in the public schools," Dr. Marland said. "It is unjust for our society to provide handicapped children with anything less than the full and equal educational opportunity they need to reach their maximum potential and attain rewarding, satisfying lives."

Dr. Marland designated education of the handicapped as one of the five major priorities of the Office of Education for fiscal 1972. Dr. Terrel H. Bell, Deputy Commissioner for School Systems, and Dr. Edwin W. Martin, Associate Commissioner for Education of the Handicapped, are responsible for planning toward the 1980 goal.

There are an estimated six million school-age and one million pre-school age children who are handicapped. Only 40 percent of these children receive any special education at all. As many as half of them, the Bureau of Education for the Handicapped estimates, could develop in regular educational classrooms if they had the

support of part-time special education services.

Dr. Marland has already established target objectives for the education of the handicapped in fiscal 1972. They are:

-To provide appropriate special educational programs to an additional 250,000 school-age children, raising the total number to nearly three million.

-To provide 250,000 teen-age handicapped students already receiving special education with appropriate career education programs, including placement and employment services.

-To produce in 1972 through Office of Education-supported college and university training programs the 17,000 trained teachers, teacher trainers and leadership personnel needed to support the additional special education programs.

Along with the education of the handicapped, Dr. Marland has given Office of Education priority to the following areas for fiscal 1972:

-Career education for all who can benefit.

-Quality education and equality of educational opportunity for disadvantaged children.

-Elimination of racial and cultural isolation.

-Innovation and renewal wherever they can strengthen education.

SUBJECT: Julie Eisenhower TV Film for CLOSER LOOK

There seems to have been a misconception concerning the amount of time required properly to film Mrs. Eisenhower at the Logos studios in Arlington and on location--here or in the Miami area. The two-hour period allocated by scheduling officials first for the 29th and then the 31st is simply not long enough to assure a first-rate public service film.

The script proposed showed Mrs. Eisenhower in an attractive, modern classroom, with attractive handicapped children; however, location scenes take variable amounts of time, particularly when children are involved. Now, because I gather that Mrs. Eisenhower will not be able to allot one day to the film project, I am reluctantly eliminating the scenes showing her actually with children, and instead we will film her at Logos against a limbo background. This will permit later rear projection of classroom, clinic and playground scenes, though the finished film will project less warmth.

At this juncture, what I am asking for is a firm shooting date the week of April 10th when, I understand, Mrs. Eisenhower will again be in the Washington area. Four hours time at Logos studios would be the minimum.

Subsequently, if Mrs. Eisenhower agrees, we would be able to photograph her with children at Miami's Mailman Center for Child Development, probably the most modern facility of its kind in the country. Done without sound, this segment could be accomplished in two hours' shooting time.

Mr. MORGAN LEE ~~ELLIOTT~~, was contacted at the Committee to Re-elect the President (CRP), 1701 Pennsylvania Avenue, Northwest. ELLIOTT was immediately advised of the identity of the interviewing Agents and the fact that he was being interviewed concerning any knowledge he may possess of the break-in at the Democratic National Committee, 2600 Virginia Avenue, Northwest.

Present during the course of the interview was Mr. DONALD KISSLER, Attorney for the CRP.

ELLIOTT advised that he retired from the United States Army, after serving 26 years, on November 1, 1971. He stated that upon his discharge he begin driving a bus in Epperdine, Maryland. ELLIOTT stated that around December 1, 1971, he was contacted telephonically by Mr. JAMES MCCORD, inquiring whether ELLIOTT was interested in securing employment with the CRP working on the Security Staff.

ELLIOTT stated that he was interviewed personally by Mr. MCCORD shortly before Christmas, 1971 and that the job was explained as general security type work in and around the offices located at 1701 Pennsylvania Avenue. ELLIOTT stated he began work on January 25, 1972 and was employed in the Security Section for approximately two weeks where he worked as a Guard.

In February, 1972, he became a chauffeur and was assigned to drive various people around the Washington, D.C. area. ELLIOTT stated he is currently a chauffeur with the CRP and his immediate supervisor is Mr. ODELL.

ELLIOTT stated that he has some twenty years experience in Field Communications while he was in the United States Army, and he never at any time discussed with Mr. CCORD or any other member of the CRP his communications background nor were any questions ever asked of him concerning his communications or electronics background. ELLIOTT stated that he was never at the MCCORD household and knows absolutely nothing about the burglary of the Democratic National Committee located at 2600 Virginia Avenue, Northwest.

ELLIOTT stated he knew absolutely nothing about the construction or use of these types of devices and has absolutely no experience in that area.

He stated that he retired from the U.S. Air Force in June, 1971, and furnished the Central Referral Agency a resume of his experience for job placement. He stated his field was explosives and that he never had any training in electrical technology.

He stated that in late March, 1972, he received a telephone call from JAMES WALTER MC CORD, Jr., who asked FOSTER if he was interested in a Security job or a driver's job with the committee. FOSTER expressed a desire to be a driver and began that employment shortly thereafter. He stated he is the driver for JEB MAGRUDER.

FOSTER denied knowing any of the subjects of this investigation, except his former employer, JAMES WALTER MC CORD, Jr. He denied having prepared or assisting in the preparation of any eavesdropping equipment or telephone tap devices.

~~THOMAS DEVERAUX BELL, JR.~~, was interviewed at the offices of the Committee to Re-Elect the President (CRP), 1701 Pennsylvania Avenue, N.W., Washington, D.C. (WDC), in the presence of PAUL L. O'BRIEN, an attorney representing the CRP. Mr. BELL indicated that he had not retained Mr. O'BRIEN to act as his personal attorney, but rather that Mr. O'BRIEN would be present during the interview to represent his employer, the CRP. He furnished the following information:

Mr. BELL indicated that his local address is 122-11th Street, S.W., WDC, (phone number: 546-5765); home of record: 5417 N. Angela Drive, Memphis, Tennessee. Mr. BELL stated that he has been employed at the CRP since June 1, 1971.

It was determined Mr. BELL serves as an assistant to KEN REITZ, CRP, and has responsibilities in areas pertaining to the direction and coordination of the activities of "Young Republicans" groups who support President RICHARD M. NIXON. In this position, Mr. BELL has occasion to travel frequently in connection with his work.

Mr. BELL stated that to his knowledge, no other individual named BELL is employed by the CRP. He advised that he has had no contact whatsoever with BERNARD L. BARKER of Miami or EVERETTE HOWARD HUNT, JR., of Potomac, Maryland. He stated his knowledge of both individuals is restricted to that which had been published by the news media.

Mr. BELL stated he had had a limited amount of contact with GEORGE GORDON LIDDY during Mr. LIDDY's employment with the CRP as a general counsel. Mr. BELL stated that this association had been restricted to consultation with Mr. LIDDY on legal matters which pertained to the housing of Young Republicans at the proposed San Diego, California, Convention site for the Republican National Convention this year.

CHAMBERLAIN stated that COLLINS asked him why RUSSELL was in the Howard Johnsons restaurant at approximately 2:00 a.m. on the morning that five individuals were arrested in the headquarters of the Democratic National Committee (DNC). CHAMBERLAIN told RUSSELL that he had no comment concerning this and he had absolutely no knowledge of RUSSELL's whereabouts as RUSSELL was employed by him but his employment was terminated in February, 1972.

CHAMBERLAIN advised that several weeks later, LOUIS RUSSELL called him and asked him (CHAMBERLAIN) why he was making statements to the press about him. CHAMBERLAIN told RUSSELL that he made no comments to the press concerning him and did not know what he was talking about. RUSSELL said to CHAMBERLAIN that "I was making heavy bread with McCORD and it was to bad that he got caught".

CHAMBERLAIN stated that LOUIS RUSSELL was employed by him from November 28, 1971 until February 1, 1972, at which time his employment was terminated as being unsatisfactory. CHAMBERLAIN stated that RUSSELL's duties were doing various background investigations concerning perspective employees. DETAILS:

On November 9, 1972, Lt. Col. WHITNEY WALKER, OSI, Ent Air Force Base, Colorado Springs, Colorado, advised that only service records of military personnel currently assigned to a specific base are maintained at the base. Since subject MC CORD, Air Force Serial Number 0-209-9263, is not currently active with Air Force assigned to the Air Force facility in the Colorado Springs area, his military service record would not be located at any of the Air Force facilities within the Colorado Springs area. WALKER advised that if MC CORD is retired his military service records would be located at the National Records Center, St. Louis, Missouri.

On November 14, 1972, DOROTHY ELLIOTT, Air Force Accounting and Finance Center (AFAFC), Denver, Colorado, advised no record on file at AFAFC for EVERETE HOWARD HUNT, JR. ELLIOTT stated Air Force records pertaining to HUNT would be located at National Personnel Records Center, St. Louis, Missouri.

COVI, Lieutenant Colonel, United States Air Force, Director of Reserve Personnel Records Headquarters, Air Reserve Personnel Center, 3800 York, furnished from the official personnel file of JAMES W. MC CORD, JR. one Xerox copy each of U. S. Air Force Officer Military Record Form AF-11 and of a Career Brief Summary pertaining to MC CORD which are attached hereto.

COVI stated that MC CORD's file, in addition to the above described documents, contained voluminous routine medical, routine transfer, and other routine records, however, he said the above described documents comprised a comprehensive summation of MC CORD's Air Force military history. COVI further advised that MC CORD's Air Force personnel file was unblemished and contained nothing derogatory regarding MC CORD.

COVI stated that he would be the appropriate person to be subpoenaed should MC CORD's personnel file be needed for trial purposes.

1. Lt Colonel James McCord was born on 26 January 1924 at Waurika, Oklahoma. He was graduated from the University of Texas with a Bachelors Degree in Business Administration in 1949, and in 1951 had 15 semester hours at Lincoln Law School, Oakland, California.

2. He was enlisted in the Air Force from 23 November 1943 to 24 July 1945 at which time he was discharged to accept a commission as a 2d Lt with a bombardier rating, and was on extended active duty until 14 November 1945. From 15 November 1945 to 30 June 1963 he was on reserve status as an intelligence officer and had 139 days active duty. He was inactive from 1 July 1963 to 30 June 1964. He was then assigned to duty as an intelligence officer with AFESS-FE at Headquarters USAF. During this period, the servicing CBPO was located at Bolling AFB. On 15 June 1970 he was reassigned to duty as Commander, Detachment 23, 1st Censorship Squadron, Arlington, Virginia. This Detachment was under command control of the 1st Censorship Squadron, Ft Totten, New York. The CBPO for the Detachment was at ARPC until 1 May 1972 at which time the responsibility was transferred to the 459th Military Airlift Wing, Andrews AFB.

3. Colonel McCord has 17 years, 8 months, and 8 days good reserve time toward retirement. We do not yet have the AF Form 190 for the period from 1 July 1971 to 30 June 1972. There is a report of active duty for training from 17 July 1971 through 31 July 1971.

4. His record shows evidence of a background investigation completed in November 1951 and filed at Hqs OSI (IG), Washington, D. C. The current Ready Reserve Agreement (DD Form 1644) obligates him to reserve service until 18 September 1972.

5. The officer effectiveness reports and the training reports since 18 February 1967 have been quite complimentary. Many of them are based on intelligence schools including the Defense Intelligence School, U. S. Naval Station, Anacostia, Washington, D. C., and the John F. Kennedy Center for Special Warfare at Ft Bragg, N. C.
