RESPONSIBILITIES OF OR DELEGABLE TO THE PRINCIPAL ASSISTANT RESPONSIBLE FOR CONTRACTING (PARC)

AND

NON-DELEGABLE PARC RESPONSIBILITIES

- A. Authorities of or Delegable to the PARC.
- 1. Approve an exception to the prohibition against issuance of a solicitation for R&D which is to be incrementally funded over successive years unless planned funds (Future Years Defense Plan FYDP) are sufficient to accomplish it, provided the approval identifies steps to be taken to revise the approved FYDP to include adequate resources IAW AFARS 5101.602-2(a)(ii)(D).
- 2. Select, appoint, and terminate contracting officers (AFARS 5101.603-1 (1)(iii)(1)).
- 3. Take action in the event of violations or possible violations of the Procurement Integrity Act (without power of re-delegation) (FAR 3.104-7 & AFARS 5103.104-7).
- 4. Release long-range acquisition estimates to industry and the general public IAW AFARS 5105.404-1(a).
- 5. Approve consolidation of contract requirements up to \$100 million (DFARS 207.170 & AFARS 5107.170).
- 6. Approve award or extension/renewal of contracts for 18 months or more, for any vessel, aircraft, or vehicle, through a lease, charter or similar agreement IAW DFARS 207.470(b).
- 7. Waive including the clause "Price Reduction for Defective Cost or Pricing Data Modifications Sealed Bidding" in contracts with foreign governments or agencies of foreign governments IAW FAR 14.201-7(b)(2).
- 8. Waive including the clause "Subcontractor Cost or Pricing Data Modifications Sealed Bidding" in contracts with foreign governments or agencies of foreign governments IAW FAR 14.201-7(c)(2).
- 9. Appoint the source selection authority for acquisitions not managed in accordance with DODD 5000.1 IAW AFARS 5115.303(a)(ii)(B)).
- 10. Approve use of fixed-ceiling-price contracts with retroactive price re-determination IAW FAR 16.206-3(d).
- 11. Approving/signing the determination and findings (D&F) for award-fee contracts IAW PGI 216.401.
- 12. Approve use of letter contracts (FAR 16.603-3) when the designee.
- 13. Render decisions on appeal, by SBA procurement center representative of contracting officer's rejection of a set-aside recommendation (FAR 19.505(b) & DFARS 219.505(b).
- 14. Approve award without EEO clearance (FAR 22.805(a)(8)).
- 15. Consider EPA termination for convenience recommendations based upon contractor violations of toxic chemical release reporting requirements IAW FAR 23.905(e).
- 16. Approve substitution of a surety bond to cover all or parts of the original surety bond under an existing contract (FAR 28.106-2).
- 17. Approval for D&Fs justifying exclusion of individual sureties IAW AFARS 5128.203-7.
- 18. Waive the use of the FAR Clause 52.228-7, Insurance Liability to Third Persons, in cost reimbursement contracts IAW DFARS 228.311 (other than contracts for construction or A-E services).
- 19. Approve use of unusual progress payments IAW FAR 32.501-2(a)(3).
- 20. Take action on a protest if the RFP, proposed award, or award does not comply with statutory or regulatory requirements IAW FAR 33.102(b) without power of re-delegation to lower than the chief of the supporting legal office or the official designated as the official review authority.
- 21. Prepare and submit an annual report of agency bid protests IAW AFARS 5133.103-90.
- 22. Determination not to share collateral savings under the value engineering clause and determination to use Alternate 1 of the FAR Clause 52.248-3 IAW FAR 48.104-3(a) & FAR 48.202.

- 23. Requests to Deny any contractor request for contractual adjustment under provisions of FAR 50.103-3; make all Determinations & Findings (D&Fs) as required by Public Law 85-804, Executive Order 10789 and FAR Part 50; approve, authorize and direct appropriate action in those cases as described in FAR 50.103-2(b) and 50.103-2(c) subject to the limits of FAR 50.102-3; modify or release unliquidated obligations of any sort and to extend delivery and performance duties under the contract to be adjusted; refer any case under your delegated authority (to include doubtful or unusual cases) to the Army Contract Adjustment Board IAW AFARS 5150.102-1-70(a).
- 24. May be delegated by the HCA (IAW DPAP memo dated 27 April 2011) the authority to waive the DPAP policy dated 24 Nov 2010, Improving Competition in Defense Procurements, that states to the effect: if a solicitation is less than 30 days and only one offer is received, the contracting officer shall cancel and resolicit for an additional 30 days. If a solicitation allows at least 30 days and only one offer is received, the contracting officer shall use cost and pricing analysis IAW FAR 15.404-1 vice FAR 15.403-1(c)(ii) in determining price fair and reasonableness. Therefore, if the DPAP memo waiving authority is delegated by the HCA, the delegated individual will ensure the delegated level follow any conditions in the delegation and that of the FAR and its supplements for fair and reasonableness in awarding single offers.
- 25. Ratify Unauthorized Commitments (UACs) between \$10K and \$100K if appropriate.
- 26. Enforce ethical standards across the enterprise.
- 27. Train and prepare contingency contracting officers for overseas contracting missions.
- 28. Maintain an organization that enforces EO and EEO. Take appropriate actions as necessary to maintain a hostile free environment.
- 29. Approval authority for a determination and finding of an indefinite-delivery contract that allows the issuance of orders on a time-and-materials or labor-hour basis for commercial items or otherwise non-commercial, and shall contain sufficient facts and rationale to justify that no other contract type authorized by this subpart is suitable IAW ACC CPM 11-6 and ACC Deskbook 16.601(d) (vice level-above the contracting officer authority in FAR 12.207(c)(3) and DFAR 216-601(d)). Further, D&Fs requiring Head of the Contracting Activity approval (e.g., FAR 16.601(d)(1)(ii)) and/or Secretary of the Army level approval (e.g., DFARS 212.207(b)(iii))will include the PARC signature block as a concurrence block rather than approval block.
