- ✓ Product Line Management


Shore facilities are a strategic resource sustaining the Coast Guard's capability to perform its operational missions. Today's Coast Guard shore facilities are a mix of owned and leased, supporting personnel, cutters, small boats and aircraft.

Key Accomplishments:

- ✓ Established the Shore Infrastructure Logistics Center (SILC) on 17 Feb.
- Established the Facilities Design and Construction Center (FDCC), formerly the FDCC Atlantic and designated the FDCC Pacific as a detachment of FDCC on 14 Sept.
- Established the SILC Shore Maintenance Command (SMC) with the Civil Engineering Units (CEUs) reporting to the SMC on 14 Sept.
- ✓ Transitioned the ISC Facilities Divisions to SILC Base Support Units (BSUs).

Future Initiatives:

- ✓ Commence pilots that establish product lines to Initial Operating Capability (level 1) in the new Coast Guard Logistics Business model.
- Commission a Business Process Review for optimized processes at the BSUs.
- Complete the initiative to identify the size and value of the shore inventory to achieve Total Asset Visibility.
