- ✓ Fit within the existing Coast Guard logistics footprint.

#### The APO differs in that it:

- Has in-house cross-functional experts providing systems engineering competency
- ✓ Is a standing body with full-time commitment
- ✓ Is comprised of dedicated subject matter experts (SMEs) from each functional domain offering total enterprise perspective

The APO is responsible for fielding the capability, ensuring that the field gets the complete capability package, including: Asset, Training, Configuration, Parts and Supply, Detailed Maintenance and ready Product Lines.

#### What is the APO?

The APO is a dedicated command, with representatives for all Coast Guard functional domains, that ensures delivery of required readiness at desired costs.

One of the APO's primary functions is to plan, manage and execute the delivery of newly acquired assets into the field. The APO's purpose is to make this transition safely and effectively with minimal impact on the operators and maintainers in the field.

The APO views the receiving field unit, Acquisition Program Manager, PRO, and the Logistics Center responsible for sustainment as its primary mission support partners.

A key component of the APO is the asset Product Line, which transitions from the APO at the end of the acquisition phase to the designated Logistics Center for sustainment, providing critical continuity for the life cycle support of the asset.

#### **Mission:**

Support the Program Manager in the Design, Production and Fielding of Capability.

#### Vision:

Provide affordable readiness through seamless integration.

### **Key Accomplishments:**

- ✓ Established the Asset Project Office (APO) on 26 January 2009.
- ✓ Began supporting the acquisition of the Fast Response Cutter (FRC) Sentinel.
- ✓ Formed the Small Boat Product Line and released it to the Surface Forces Logistics Center (SFLC).
- ✓ Initiated the Patrol Boat Product Line Pilot in conjunction with the SFLC.
