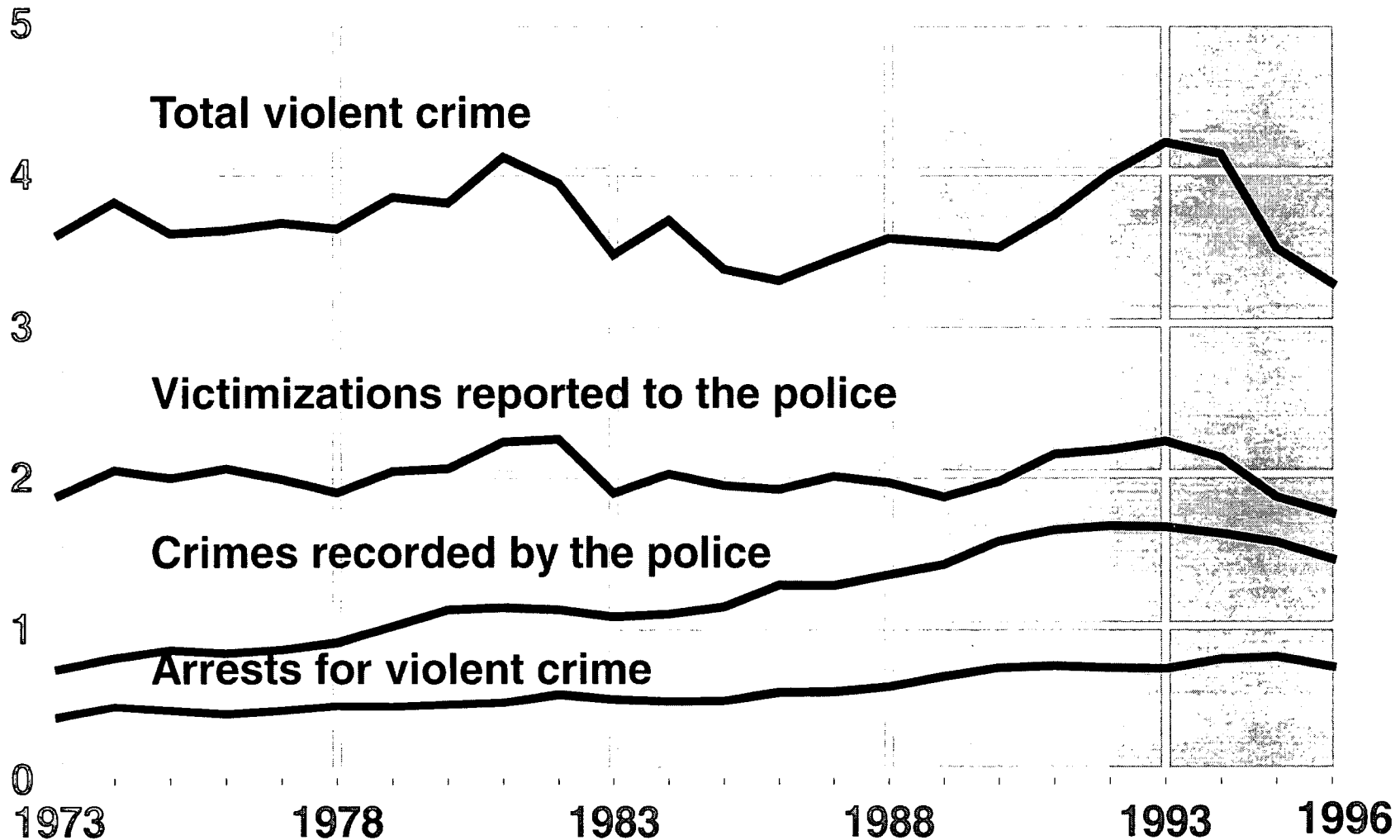

Offenses in millions

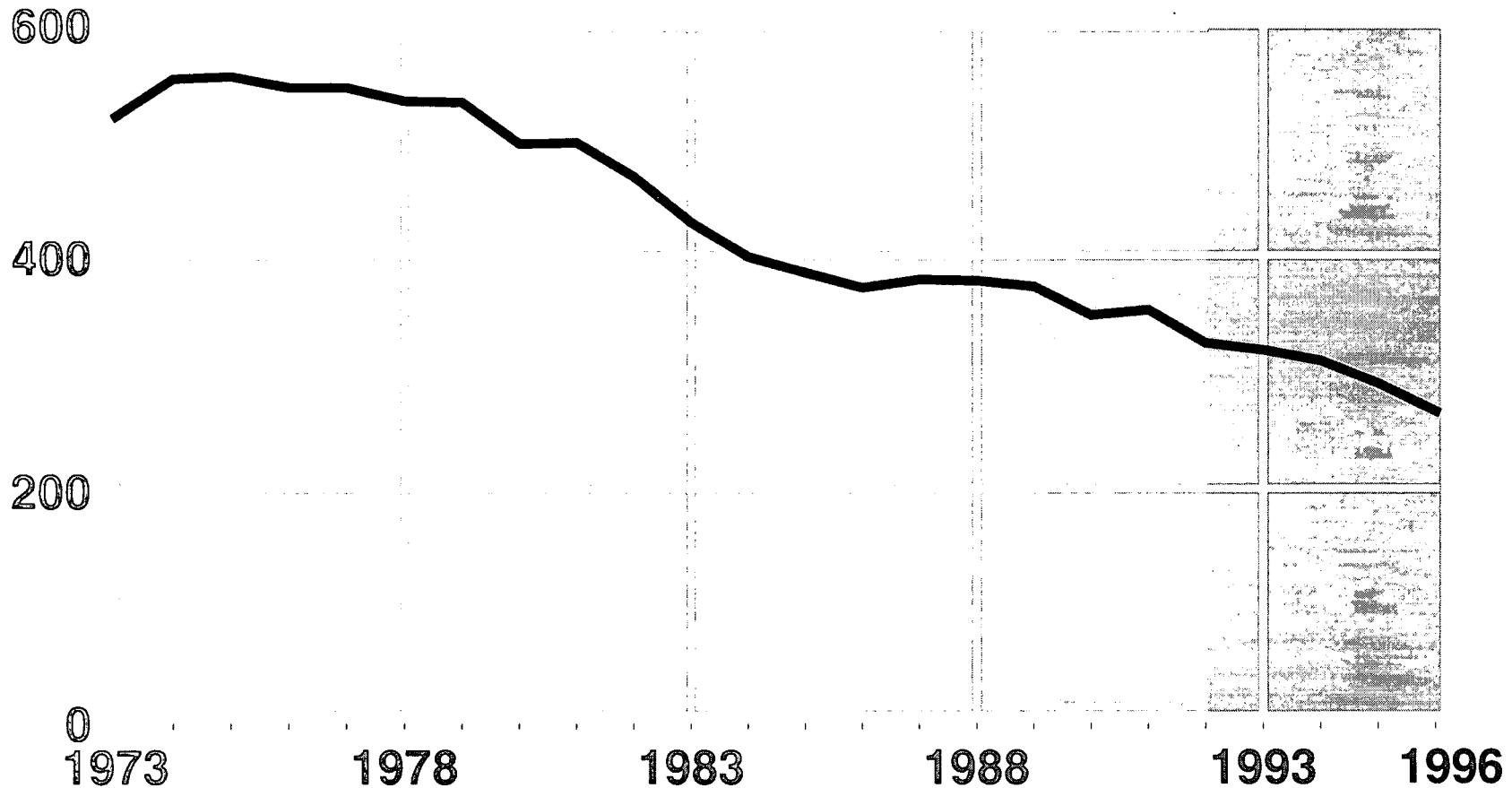

per 1,000 households

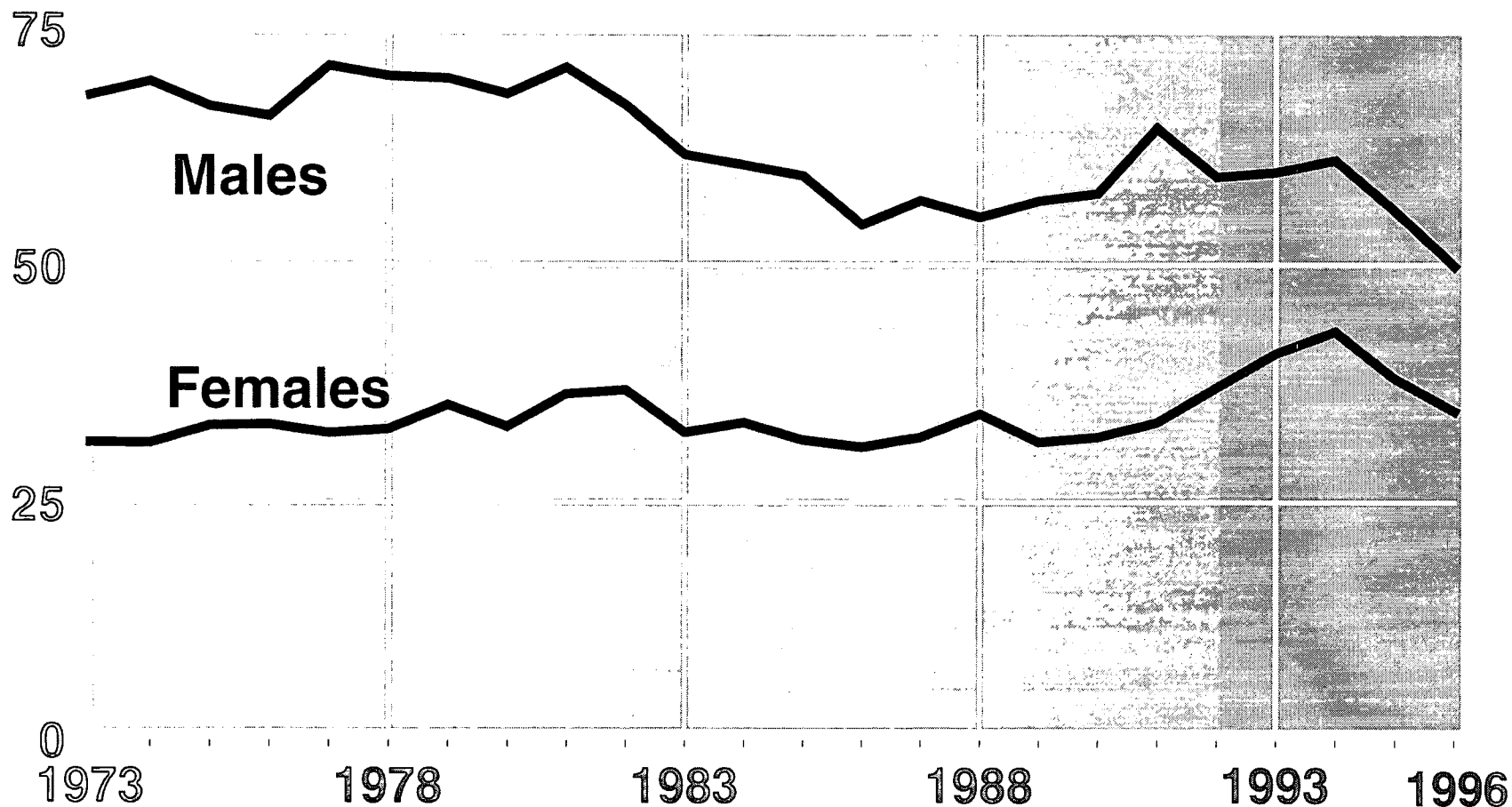

Violent crime rates by sex of victim

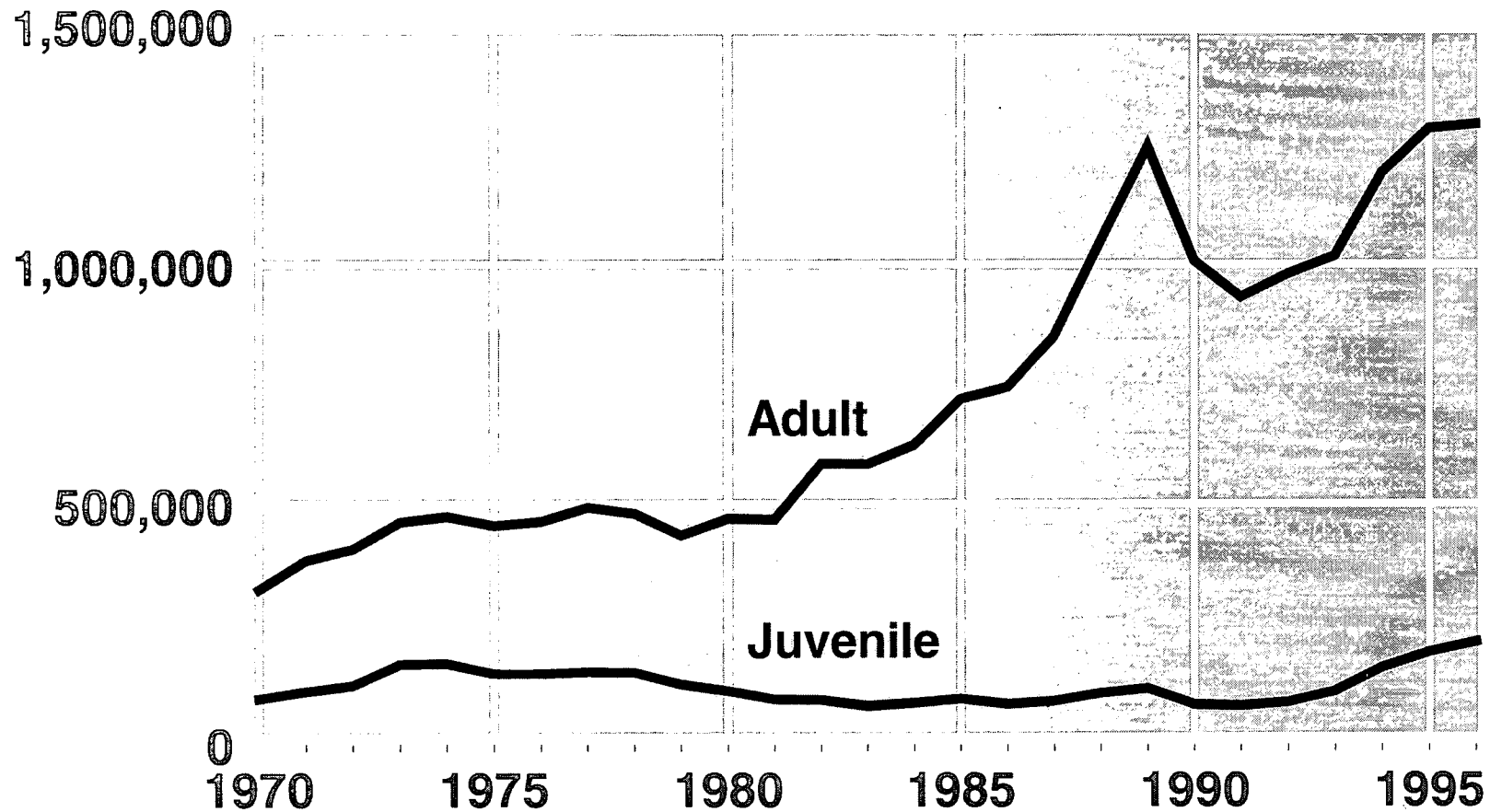
Adjusted victimization rate

Drug abuse violation arrests by age, 1970-96

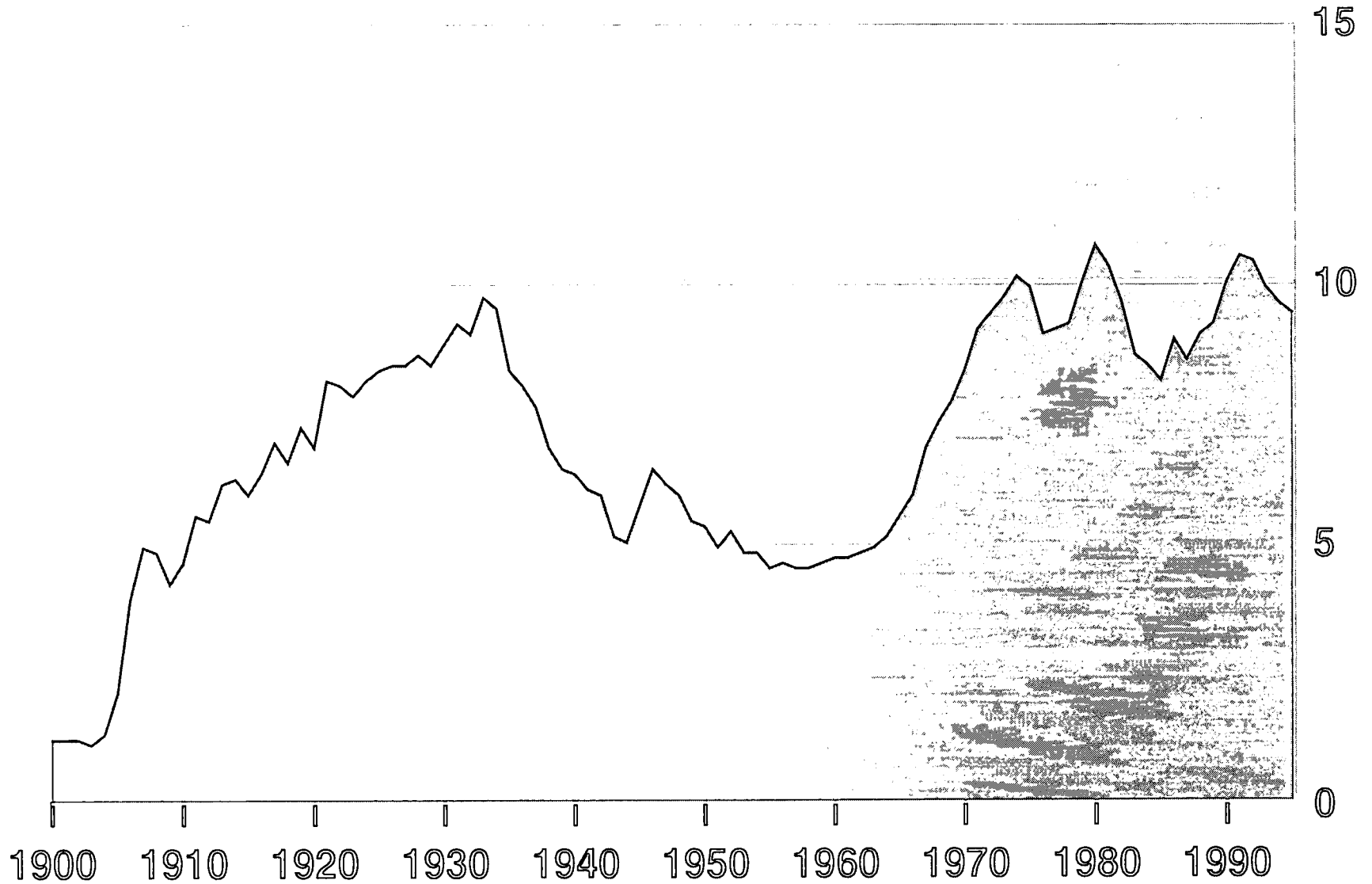

Juveniles are defined as persons under 18 years of age. Adults are defined as persons 18 years old and older.

Homicide rate, 1900-95

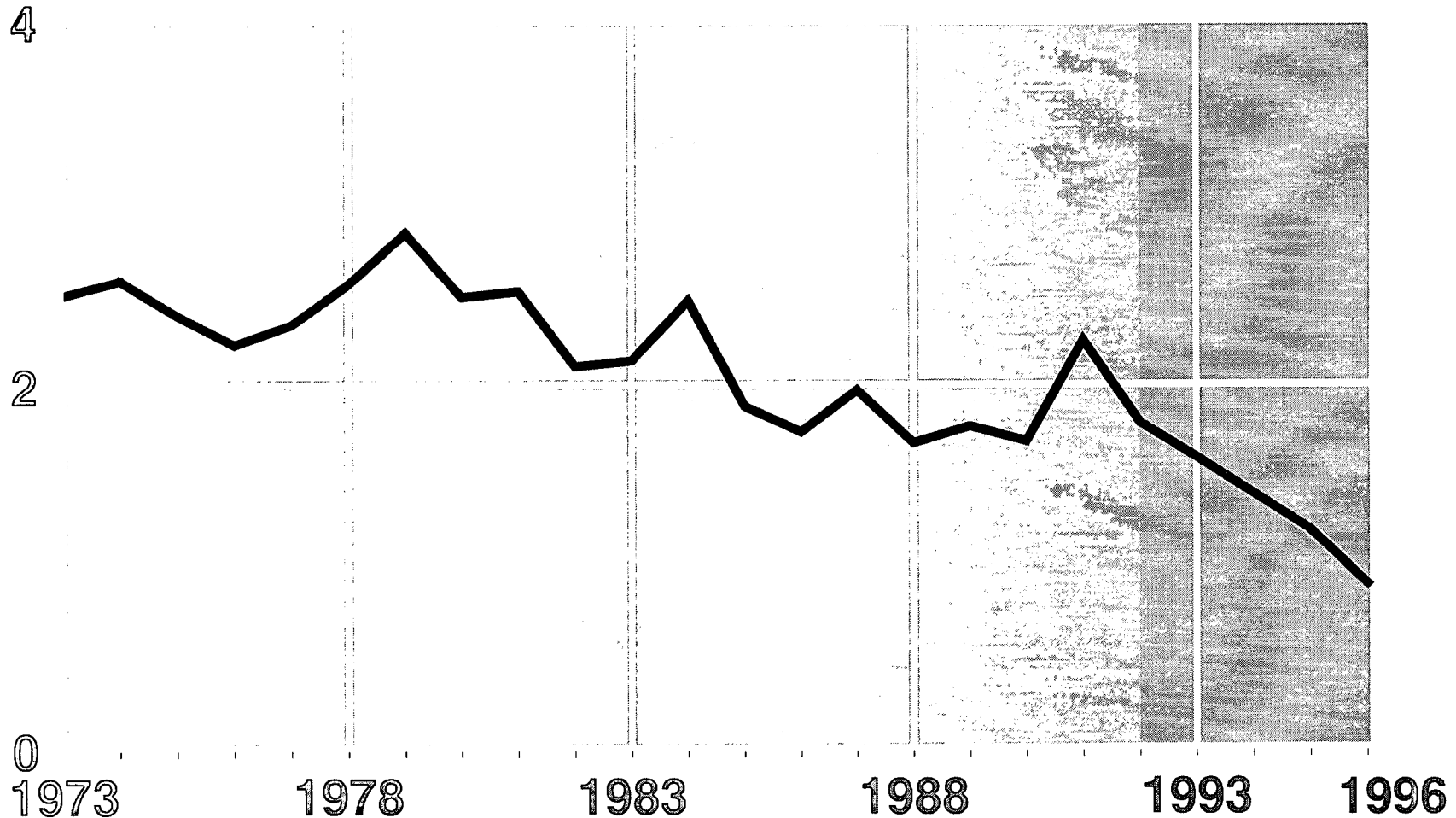
Rate per 100,000 population

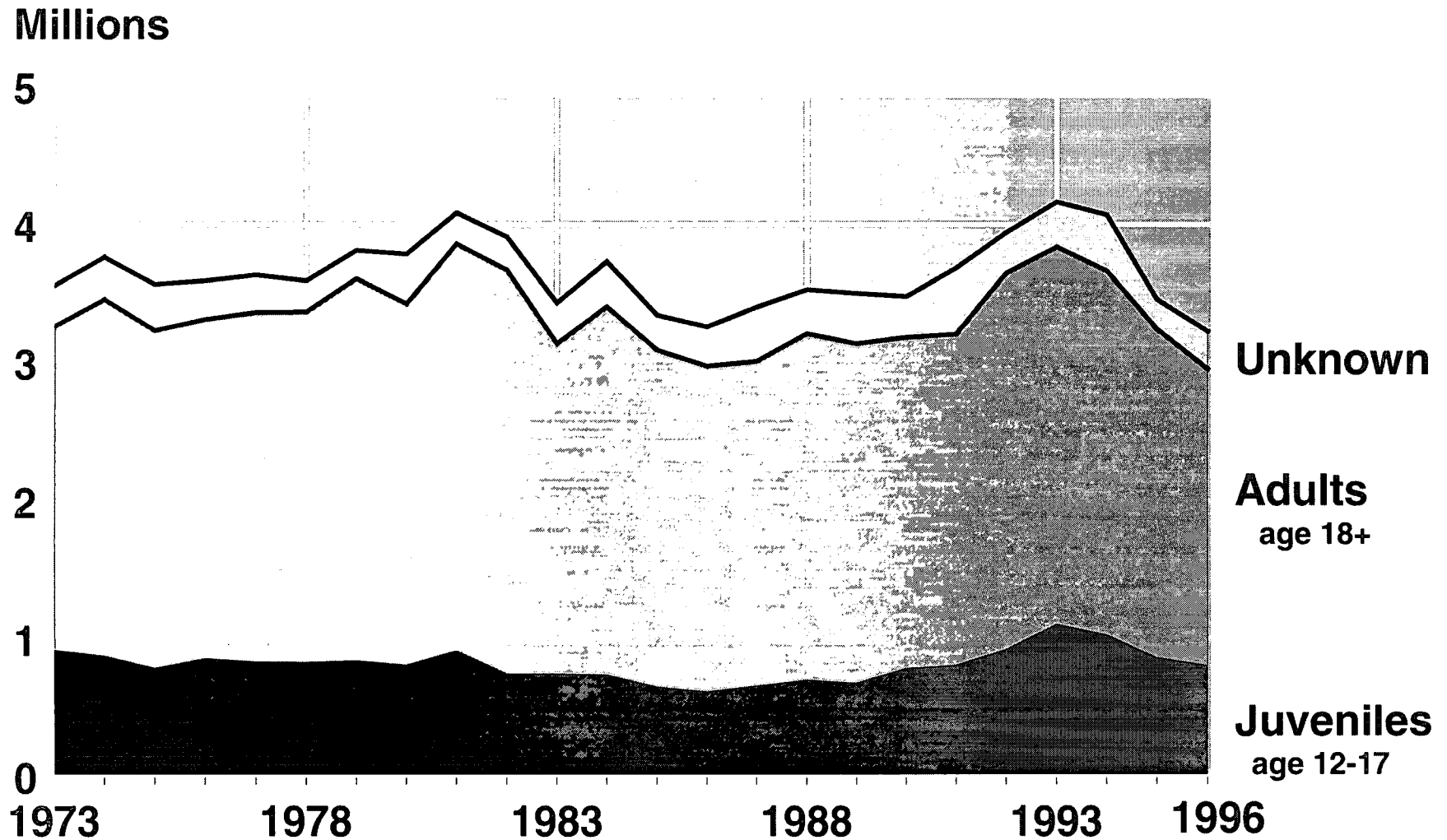
Adjusted victimization rate

Serious violent crime by perceived age of offender

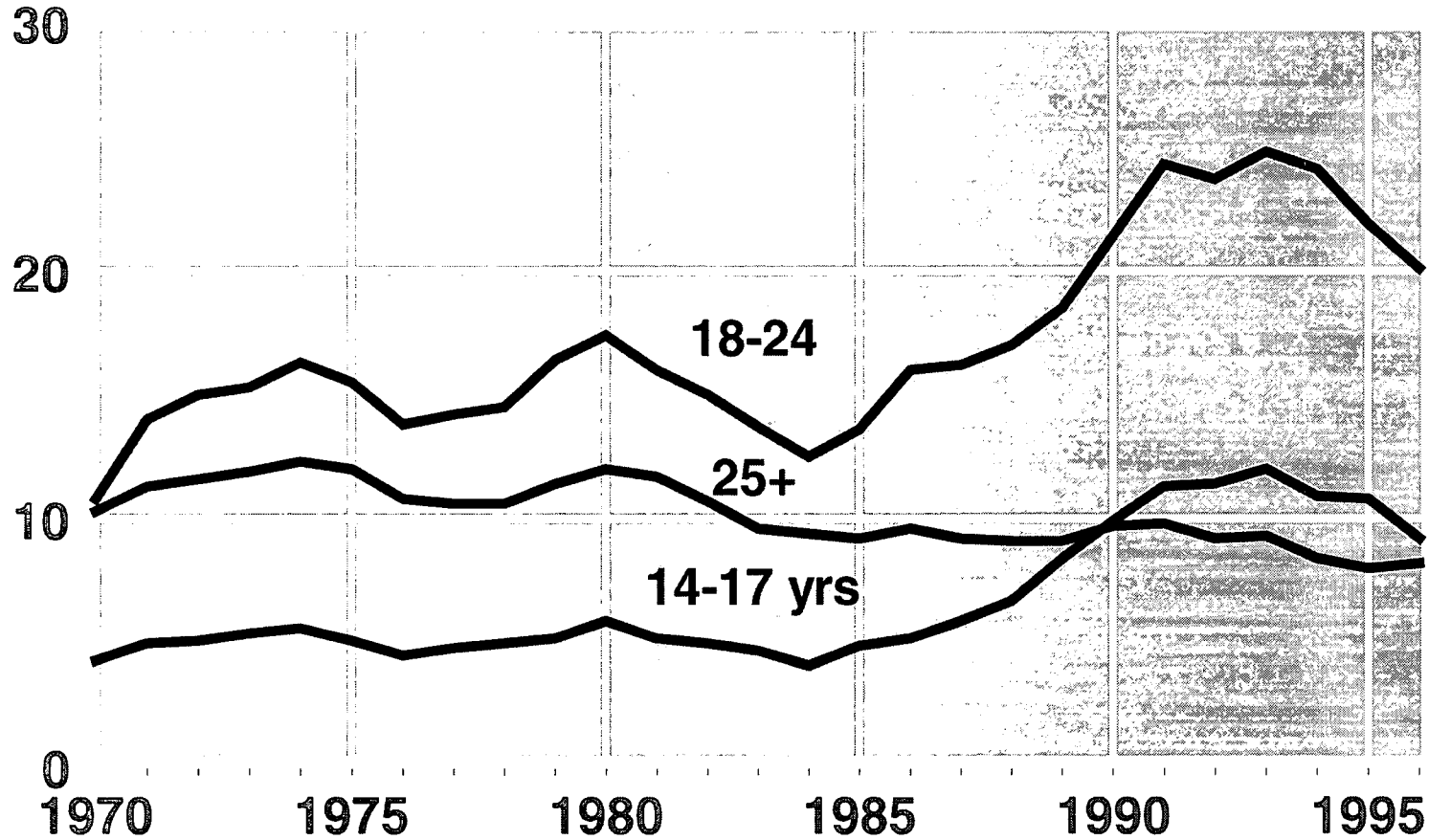

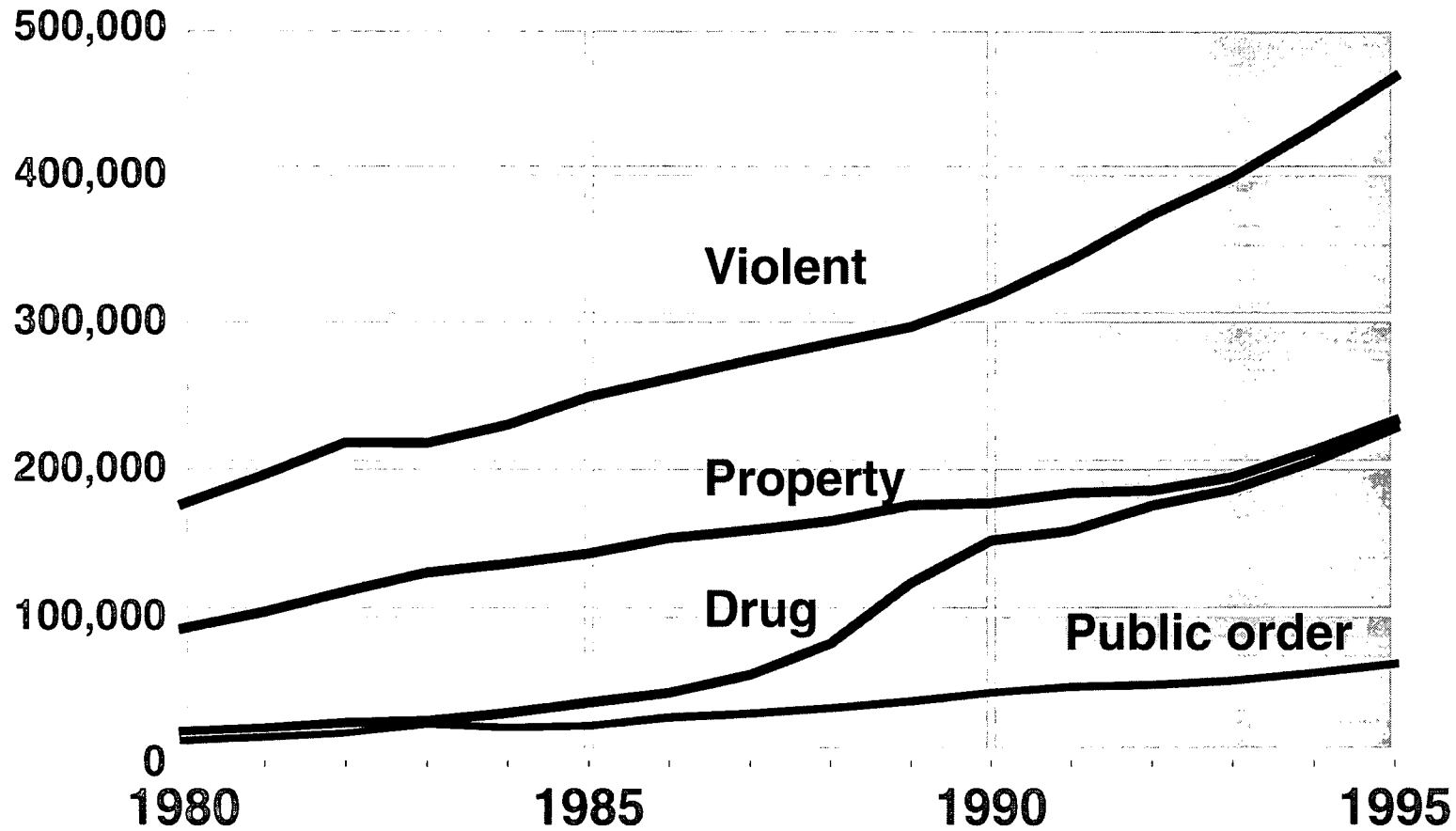

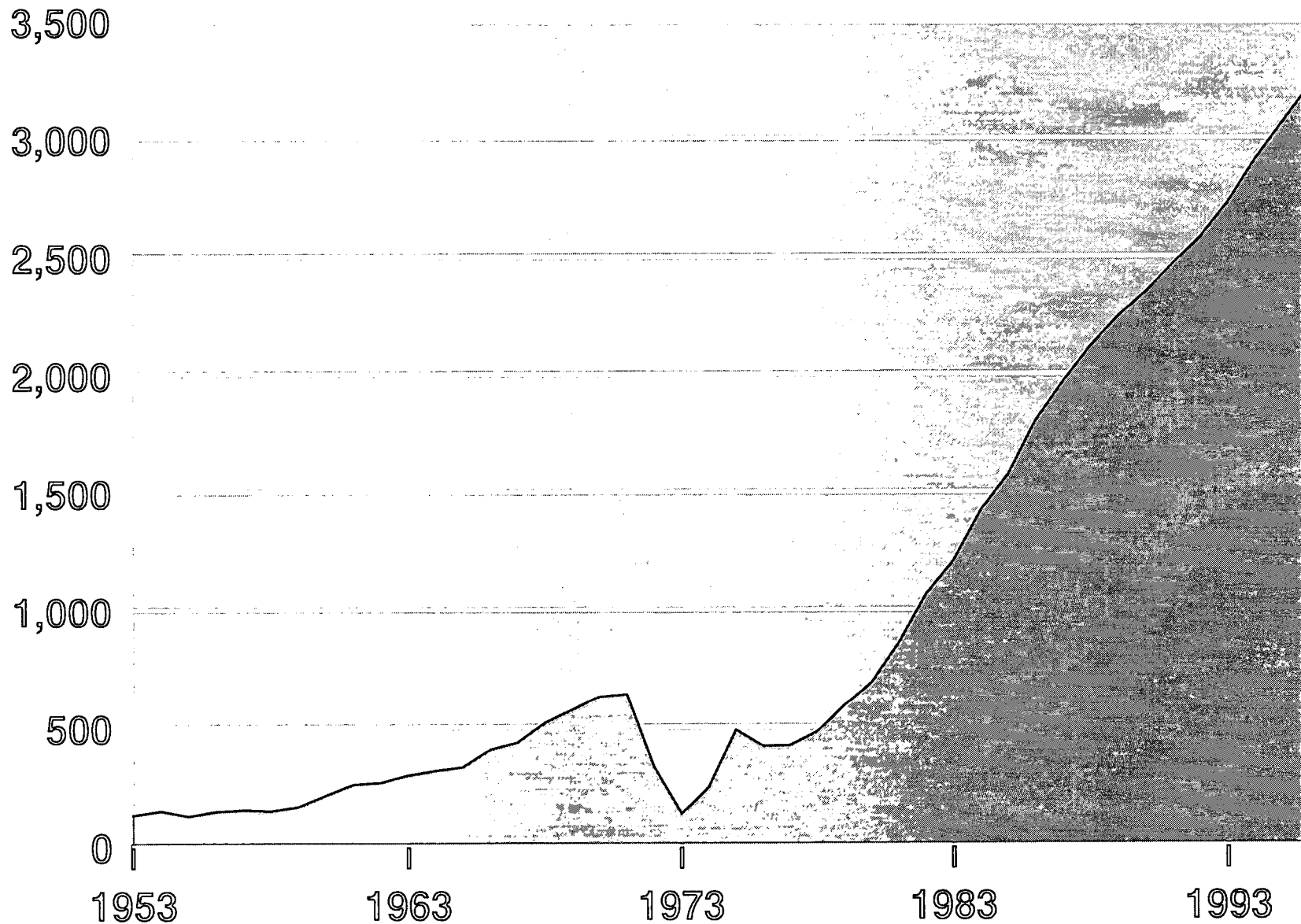
State prison population by offense type, 1980-95

Number of inmates



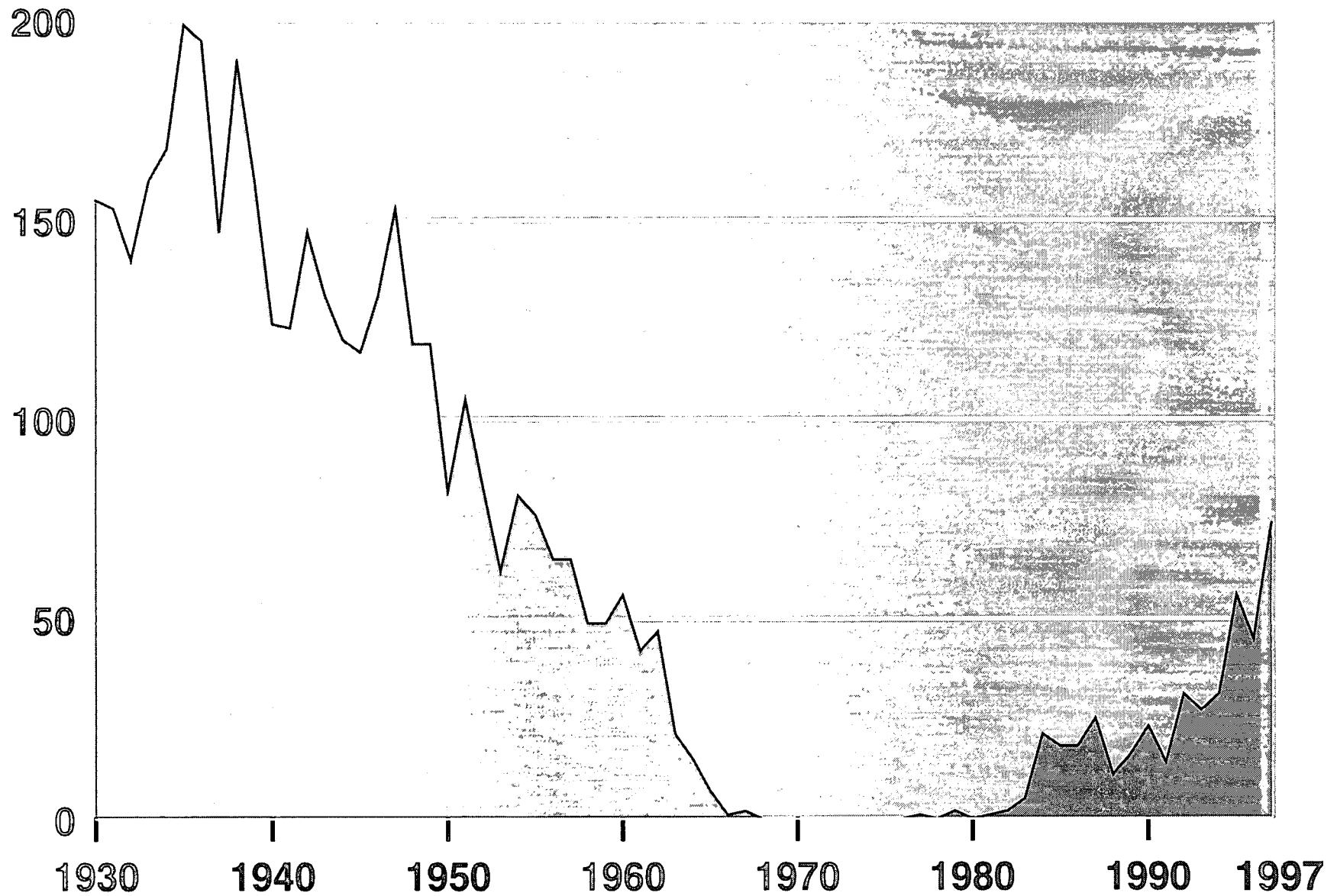

Prisoners on death row, 1953-96



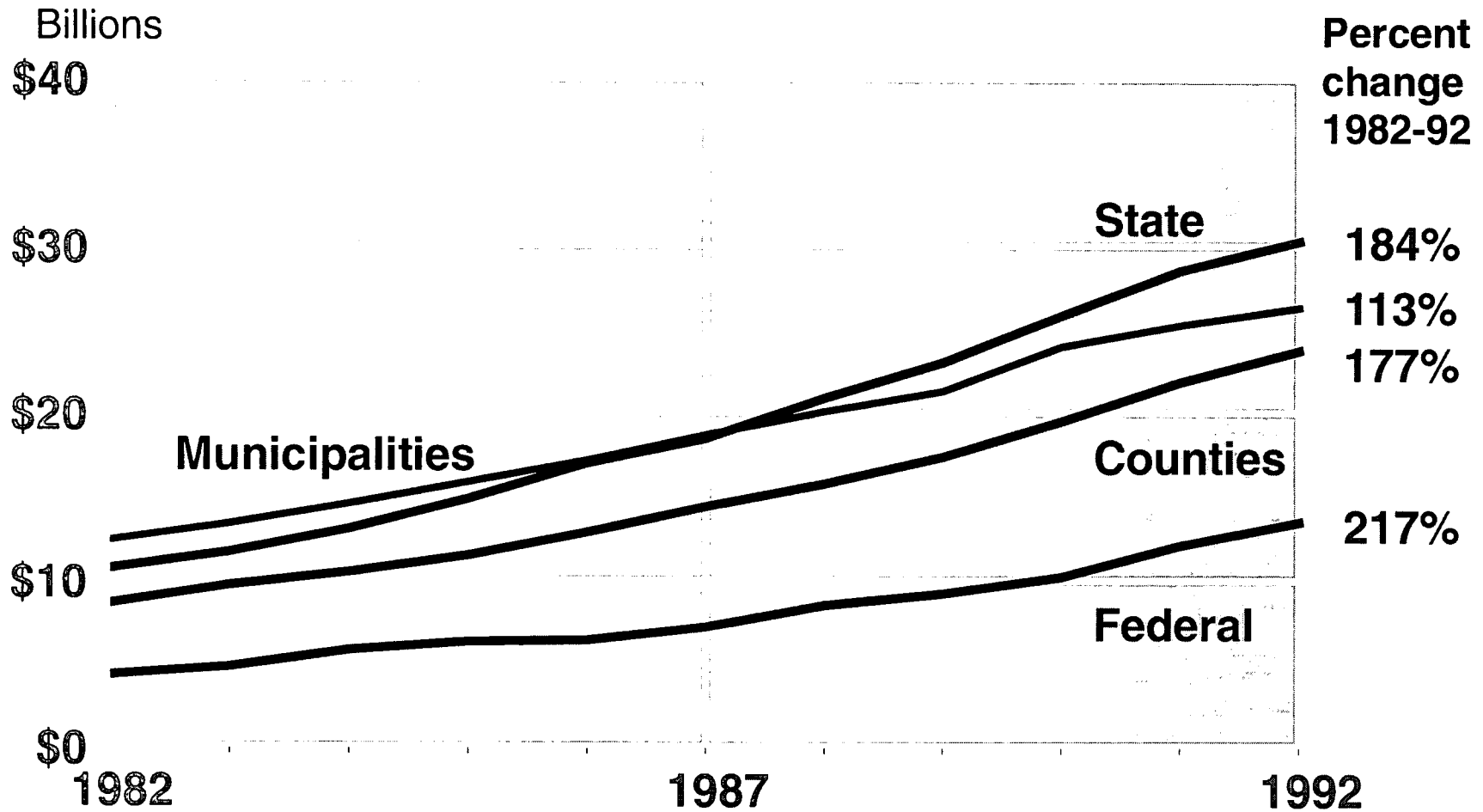
