

# Okanogan National Forest Welcomes Campers to Sunny Okanogan Country!



<u>Water and Garbage:</u> These services are provided at some campgrounds Memorial Day through Labor Day.

Weather: The weather in this area is unpredictable and changes greatly with elevation. We suggest that you check the weather forecast before you start your trip.

Clean Camp: Wildlife are attracted to a variety of odors (food, garbage, cosmetics, ect.). Keep a clean camp. Store food and garbage properly at all times. Store food in your car trunk if available. Otherwise, place food in a bag, backpack, or pannier and hang from a tree branch at least 15 feet above ground and 4 feet from the tree trunk. DO NOT STORE ITEMS IN TENTS.

Firewood: Campers may use up to ¼ cord of firewood, per day, for each campsite without needing to get a firewood load stub. Removal of firewood IN a campground is not allowed.

Unused firewood must be left in the campground when you leave. See Okanogan National Forest Firewood Removal Guide Map (FREE) for more information.



**Reservations:** Campgrounds are on a first come first serve basis.



**Fees:** Fees for campgrounds must be paid within ½ hour after arriving.

Most importantly, always bring along a healthy dose of common sense. Safety is the most important factor to insure an enjoyable outing.
