Under Section "C" of reBulet, it is noted that espionage subjects are maintained in the special section when apprehension in the event of an emergency would destroy chances of penetration and control of an operating Soviet espionage parallel or would destroy chances of penetration and control of a "sleeper" parallel.

At the present time the Bureau and the Baltimore Office are maintaining the cards of the following four individuals, in the U. S. Government employees category rather than the espionage category of the special section:

It is noted that these four cases were opened under Espionage Classification in accordance with Bureau instructions received in June, 1950. The investigation to date in each case has failed to disclose any espionage activity on the part of any of the subjects. Therefore, unless advised to the contrary by the Bureau, these four subjects will continue to be maintained in the U. S. Government employees category of the special section of the Security Index.

In the event the Bureau should advise that these individuals should be maintained in the espionage category, the instructions in reBulet would call for the immediate submission of a summary report suitable for distribution and the submission of a similar type report each six months thereafter. It is to be noted that none of the reports prepared in these four cases

Security Matter -

PURPOSE

To advise you that the investigation concerning captioned individual has been completed and that a Security Index card has been prepared which is being maintained in the "Special" section of the Security Index.

REFERENCE

Attached memorandum which summarizes the information in the Bureau's files concerning [redacted] and which indicated that at the conclusion of the Bureau's investigation, a determination would be made concerning the preparation of a Security Index card. It is noted that concerning this latter point you inquired "What has been the outcome?"

RESULTS OF INVESTIGATION

The investigation concerning [redacted] was completed by the Newark Office in January, 1951, and a closing report submitted. The investigation clearly disclosed that [redacted] is one of the foremost exponents of [redacted] in the United States today. Reliable confidential informants have recently advised that [redacted] main difficulty with the [redacted] has always been concerning the [redacted] issue and that [redacted] is acting as " [redacted] " between the [redacted] and the Yugoslavians in this country in an effort to unite both [redacted] factions behind [redacted] as true [redacted].

In view of [redacted] background and complete allegiance to [redacted], it was felt that he represents a threat to the internal security of this country and, accordingly, pursuant to the recommendation of the Newark Office, a Security Index card was prepared for him on December 19, 1950.

Section C, SAC Letter No. 23, dated March 3, 1951, provides for a new category in the special Section of the Security Index to consist of those Security Index subjects who are [redacted] and [redacted] in their sympathies. This section was set up due to the fact that at the present time the [redacted] government of Yugoslavia and its supporters are visualized as potential allies of, rather than potentially dangerous, to the United States. So long, therefore, as the [redacted] government of Yugoslavia is aligned with the United States and its Western European allies against the Soviet Union and the Soviet satellite countries, no good purpose would be achieved by applying the Detention Program to the supporters of the [redacted] government in the United States. It is felt, however, that such individuals should be the subjects of Security Index cards since their allegiance is exclusively [redacted].

REFERENCE

Attached memorandum dated March 15, 1951, upon which the above inquiries were based.

DETAILS

With reference to your first inquiry concerning the case, you are advised that a security investigation concerning _____; looking toward his future inclusion in the Security Index, was initiated upon the receipt of a summary report from the New York Office on February 23, 1950. However, the activities of _____ primarily in connection with Slavic matters, were followed by the Bureau from 1942 to 1945. During that period, although the case was not in a pending status, various field offices submitted investigative reports from time to time and the White House and interested Government agencies, including the Department of State and G-2, were furnished pertinent information from these reports concerning _____ activities and foreign travel.

In November, 1945, Elizabeth Terrill Bentley made allegations of an espionage nature against _____ in connection with the Nathan-Gregory Silvermaster Group, as the result of which, _____ was included among the subjects in that case. Upon the conclusion of the Silvermaster case, the Bureau on March 22, 1949, instructed the New York and Washington Field Offices to submit summary security matter reports on all subjects involved in that case.

The summary report on _____ was originally submitted by the New York Office on September 19, 1949, following:

return from a six month's trip abroad. This report, however, was not prepared in a manner suitable for dissemination and was returned to the New York Office to be rewritten. The corrected report was received from the New York Office on February 23, 1950, and set forth background and all information of a subversive nature which had been developed concerning from 1942 to that time.

By letter dated March 8, 1950, the Newark Office was instructed to consider for inclusion in the Security Index and to submit an investigative report whenever sufficient information had accumulated in the Newark files to justify the preparation of such a report. Status follow-ups were directed to the Newark Office on May 15, 1950 and September 19, 1950. On November 27, 1950, the Newark Office recommended inclusion in the Security Index and following the preparation of a memorandum outlining the background of the case, a Security Index card was prepared, which is presently maintained in the Special Section of the Security Index.

A follow-up was directed to the Newark Office on December 5, 1950, to which Newark replied that a report would be submitted by January 5, 1951. This report, bringing activities up to date, was received on January 10, 1951.

The above information is submitted in response to your inquiry as to why it took until January 10, 1951 to conclude the investigation.

As you are aware, security investigations of individuals are of a continuing nature and fall into two main categories; those on whom Security Index cards are prepared, and those on whom Security Index cards are not prepared. Although both types of cases (with the exception of top functionaries and key figures which are always kept in a pending status) are maintained in a closed status as an administrative aid to the field, they are being continuously reopened and closed. Information is being continuously channeled into these files and when a sufficient amount has accumulated to justify the preparation of an investigative report, or upon the receipt of specific information which would warrant immediate investigative attention, such a report is submitted. If, at the time the report is submitted, some action should be taken either to include the individual in the Security Index or to consider his removal from the Index, depending on whether his activities fall or do not fall within existing Bureau standards, such action is taken at the Bureau.

Accordingly, the cases of individuals like may be opened and closed many times before information is furnished by the field which, under existing Bureau standards, justifies consideration for inclusion in the Security Index.

In connection with the Case, it has previously been pointed out that the Bureau has been following activities since 1942. It was not until the receipt of the New York summary report on February 23, 1950 that the field was instructed to consider for inclusion in the Security Index since his activities at that time, as one of the foremost exponents of in the United States, marked him for such consideration. Since is presently included in the Security Index, his activities will be followed, as are the activities of all Security Index subjects, and a report will be submitted whenever sufficient information has accumulated in his file to justify such action or upon the receipt of any specific information which would warrant immediate investigative attention. In addition, his residence and employment will be checked by the Newark Office every six months as is the case with all Security Index subjects.

With reference to your third inquiry as to why no investigation has been made of , please be advised that is currently being investigated. This investigation was ordered by memorandum to Los Angeles dated January 22, 1951, and a current report reflecting his activities was received from the Los Angeles Office on February 27, 1951. The case is in a pending status.

With respect to your third question, our standards upon which we proceed to make investigations looking to making a decision for inclusion in the Security Index are explained as follows:

Prior to the Korean situation mere membership or affiliation with the Communist Party or other revolutionary groups was not construed as rendering the individual as dangerous or potentially dangerous to the Internal Security of the country. At that time our standards did not call for an investigation in the absence of other indications that the individual was dangerous or potentially dangerous due to Party training, employment in vital industry, or defense installations, past service in the Armed Forces or other similar categories.

With the advent of the Korean situation it was apparent that the Communist Party and other revolutionary groups had taken a definite and positive stand against the policy of the United States in the Korean matter and had launched campaigns in opposition to the policy of this country. The stand taken by those revolutionary groups left no doubt that individuals who were then active members of those groups had cast themselves on the side of the Soviet Union and must be investigated to determine whether their names should be included in the Security Index.

On July 25, 1950, the Field was instructed to open cases for investigation on all individuals reported to the Field as present or alleged members of or affiliated with the Communist Party or other revolutionary groups, or currently espousing the line of such groups, in order to identify all persons dangerous or potentially dangerous to the Internal Security and to determine if their names should be included in our Security Index.

At that time the standards for placing a person in the Security Index were broadened to include all persons who are active participating members of the Communist Party or other revolutionary groups or who espouse the line of such groups.

In applying the above standards to _____, you are advised of the following facts. After Budenz published his book "Men Without Faces," you will recall he was orally questioned regarding the identities of these individuals. At that time Budenz advised the New York Office that on _____ was one of the "400 concealed Communists" to whom he referred in this book. Prior to the receipt of this information from Budenz, the Bureau had received no information indicating that _____ had ever been an active Party member.

Upon request of the Bureau, and prior to interview of Budenz by New York for detailed identifying information (It will be noted that Budenz furnished no information at that time indicating that this _____ was identical with the _____) the Los Angeles Office was requested to submit a report setting forth information contained in its files concerning _____. In compliance with Bureau instructions the Los Angeles Office submitted a report on July 28, 1950, reflecting information in its files concerning _____. This report showed extensive association with Communists and Communist fronts by _____, although information was reported subsequent to 1946 reflecting that _____ was anti-Communist and further reflecting attacks made on _____ by the Communist Party. Subsequent to the receipt of this report from Los Angeles on July 28, 1950, our New York Office advised they interviewed Budenz in detail at which time Budenz stated that _____ had been reported to him as being a very staunch Communist during the early 1940's. Budenz also stated that Party officials informed him that during the 1940's and up until about 1944, _____ had been an active member of the Communist Party. He also said that _____ had been used at least during the early 1940's as a source of money-raising by the Communist Party. When this information was received from Budenz indicating that Budenz considered _____ as one of the "400 concealed Communists," this data was considered in conjunction with the summary of information appearing in the report from Los Angeles of July 28, 1950, reflecting an anti-Communist attitude on the part

of subsequent to 1946. In order that a decision might be made as to whether should be investigated, a memorandum dated January 15, 1951, was submitted setting forth the facts involved.

It was decided that the Los Angeles Office should initiate investigation of , which is presently pending. To date, however, no information has been developed which warrants the preparation at this time of a Security Index Card on . The investigation to date reflects a continuation of an anti-Communist stand on his party. This investigation is being followed closely and will be terminated at the earliest possible logical time.

ReBulet dated 2-7-51 in response to my letter dated 1-24-51.

Reference is made to my previous request to be permitted to make a notation on the back of the alphabetical Security Index Card indicating the date and initials of the Agent verifying the residence and business addresses of the subjects of the cards.

The instructions of the Bureau, as set forth in Section 57 of the Manual of Instructions, are being complied with in this regard and it was thought that the notation referred to above could conceivably be considered part of the administrative handling of the Security Index Cards in this office.

I want to assure the Bureau that there is no information appearing on the Security Index Cards which information is not substantiated by a communication appearing in the subject's file. The matter of placing notation on the back of the alphabetical Security Index Card was thought to be a procedure which would involve a negligible amount of time, yet would result in having readily available the date the addresses were last verified.

As stated above, this was classified as an administrative procedure and it is believed that by being permitted to place this notation on the back of the card, the possibility of not verifying the address every six months, as required by the Bureau, will be minimized.

It is respectfully requested that the Bureau reconsider my request in the light of the above and advise me of its desires.

In view of these facts it is not possible for the Bureau
to state that members of the Socialist Workers Party should be
placed in the Special Section category as "Pro-Tito." Each case
must be considered individually according to the facts available
concerning each individual Security Index subject.

ReBulet 3/19/51, which stated that as of 2/8/51 of the 1,418 Security Index cards maintained on subjects within the San Francisco Division there were 843 tabbed for DETCOM and 469 tabbed for COMSAB.

The Bureau mentioned a number of individual cases in which it drew attention to the fact that there might be some doubt whether the subject of these cases should be tabbed DETCOM. For your information, these cases have been reviewed and where appropriate forms FD-122 have already been submitted.

For the information of the Bureau, this office is presently in the midst of making a complete survey of its Security Index in conformity with SAC Letter No. 26, Series 1951, and other recent SAC Letters requiring a review of the Security Index. In the course of making such a survey, particular attention is being paid to the possibility of eliminating from the DETCOM and COMSAB program any individuals whose activities no longer merit such designation. It is pointed out that it is expected that at all times there will be a high percentage of COMSAB and DETCOM subjects in the San Francisco Security Index because of the large number of vital facilities in the San Francisco area and because of the numerous Security Index subjects who have access to the San Francisco Bay Area waterfront, which has been designated in its entirety as a vital facility.

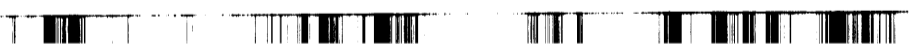

Reference is made to Bureau Inspection of the New Haven Office conducted during the month of February, 1951, by Inspector , with specific reference to administrative memorandum entitled, "Communist Coverage," item No. 7 captioned, "Security Index."

The Inspector observed that plastic tabs are being used for the tabbing of Security Index and that Bureau requirements are that metal tabs be used. The Inspector recommended that this office replace the plastic tabs with metal tabs.

It was believed that when the Bureau's instructions were originally furnished to the field that this office had advised the Bureau that metal tabs were not available and that unless advised to the contrary, this office would utilize plastic tabs; however, no record can be found of this. Efforts have been made to locate metal tabs, with negative results. This office continues to utilize plastic tabs in the absence of the metal tabs.

For the information of the Bureau, there is being transmitted a 5 x 8 card, which is similar to a Security Index Card, with three different colored plastic tabs attached thereto. This office has found that the plastic tabs have been very practical and do not tend to fall off the card or bend. They are, likewise, sturdy. It has generally been the observation that metal tabs have a tendency to bend and sometimes become detached from the cards.

Bureau authorization is respectfully requested for this office to continue to use plastic tabs for tabbing purposes in the Security Index. If the Bureau does not grant this authorization, then it is requested that the Bureau furnish metal tabs in appropriate colors and in quantities of 200 per color.

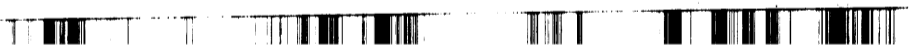

Remylet 2/6/51, advising that a separate tickler system was being instituted by the Pittsburgh Office to aid in the handling of Security Index cases, and Bulet 2/27/51, advising that the Bureau had no objection to this procedure.

For the Bureau's information, this office has recently adopted the policy of assigning verifications of the residence and business addresses of Security Index subjects to the agents responsible for their apprehension under the Detcom Program. To facilitate the administrative handling of these assignments, a 3x5 index card system has been added to the separate tickler system maintained on the Security Index subjects showing the name and file number of the Security Index subject and the agent to whom the subject is assigned under the Detcom Program. Through reference to this alphabetical section, the identity of the agent responsible for a particular subject under the Detcom Program can be immediately ascertained and the case, as it comes up on tickler for verification of employment and residence, can be assigned to that agent.

The tickler system itself is operated on a daily basis with the ticklers on each individual Security Index subject set 21 days in advance of the expiration date for the six-months' period within which the residence and business addresses of the individual subject must be again verified. When the case is re-opened on the basis of the tickler, a deadline of 20 days is set within which the agent must verify residence and business addresses.

A third section, consisting of 3x5 cards showing the name of the agent and the Security Index subjects for which he is responsible, has also been added to this separate tickler system to enable the office to maintain assignments under the Detcom Program on a current basis at all times. Through reference to this section of the tickler box, it can be established immediately the exact assignments of each agent in the office under the Detcom Program. As the Bureau is aware, there is considerable movement of Security Index subjects occasioned by changes in residence address and/or employment which necessitates administrative procedures whereby the assignments of the agents under the Detcom Program can be changed easily to correspond with the movement of the Security Index subjects themselves.

The assignment of the required six-months' verification of business and residence addresses of Security Index subjects to the agents actually responsible for apprehending these subjects under the Detcom Program enables these agents to be aware of any changes in residence and/or employment of the subjects assigned to them, since they are actually making the verifications themselves, and thereby also keeps these agents in a better state of preparedness in the event the Detcom program is ever placed in effect. The use of the three section separate tickler system, described above, consisting of (1) a tickler section; (2) an alphabetical section arranged by Security Index subjects showing the name of the agent to whom assigned under the Detcom Program, and, (3) an alphabetical section arranged by agents showing their subject assignments under the Detcom Program, enables this office to maintain assignments under the Detcom Program on a current basis and make any reassignments necessary, immediately upon notice of change of employment or residence of a particular subject. It also enables this office to keep the six-months' verification of the employment and resident addresses of the Security Index subjects in an up-to-date condition at all times.

The above administrative procedures and tickler system are being brought to the attention of the Bureau since they have been found to operate in such a satisfactory manner in this office.

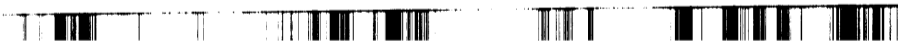

In connection with the recent inspection of the Los Angeles Office and with reference to matters discussed at the security conference held at the Bureau on April 2 and 3, 1951, it is desired to submit to the Bureau a recommendation from the Los Angeles Office regarding the status of cases on security index subjects.

The field offices of the Bureau certainly recognize the importance of the security index program, and according to public information that has appeared from time to time, statements concerning the security index program have been made by the Director to Congressional committees. The latest reference to the general subject that has been noticed appeared in the "Los Angeles Mirror" on March 30, 1951, in the column of ROBERT S. ALLEN under a Washington dateline. A copy of this is attached for the Bureau's information. This item attributes the Director with stating, "We have a complete index on all of them and we keep it up to date constantly.... we consider it one of our most important ones (jobs). The security of the nation is at stake and we are taking no chances with this element."

It is pointed out to the Bureau that in spite of the importance of this particular program under the current restrictions, once these cases have been worked up they are kept in a closed status. There is no uniformity in the field with reference to the reopening of these cases at the time the addresses and places of employment are verified periodically. Actually, it has been the experience in this office that in many of these cases a considerable amount of work is necessary to bring these matters up to date, and therefore it is felt that the cases should be reopened and assigned. Otherwise with hundreds of such cases we are devoting a large number of man hours to work which never shows up on any report accounting for the time of the agents. To reopen these cases and close them again does put a tremendous burden on the Chief Clerk's office; therefore it is recommended that the cases be placed in a pending inactive status and kept that way at all times.

One advantage in actually assigning the cases is that each agent to whom a case is assigned, recognizing that his responsibility is fixed by the issuance of an assignment card, will go to considerable lengths to establish contacts that will thereafter immediately report to him any change in the subject's daily routine or change of occupation or residence. Continuous assignment will result in familiarity with the subject's background

1

STATUS OF CASES ON SECURITY INDEX SUBJECTS

which may be of considerable assistance later in effecting the apprehension of the individual if he is not readily located by some police officer or agent. It is realized that in some offices the number of security index subjects is such that specific assignments can be given to agents and the agents held responsible for knowing the activities of these persons, and in event of emergency the agents know they will personally have to apprehend these specific individuals. However, in a large office such as Los Angeles, where it will not be possible for the agents to make the apprehensions in many instances, for we must necessarily rely on other law enforcement officers to a considerable extent, we cannot make the assignments to agents with the same objective in mind. Consequently, it is felt that the cases should be specifically assigned and kept in a pending status at all times.

The monthly administrative report of each office will more accurately reflect the true number of Security cases that are constantly receiving attention if these security index subjects' investigations are kept in a pending inactive status. In addition, the administration of the periodic check will be made relatively simple by the normal case tickler prepared when the case is placed in an active status.

In view of the above and in line with the Inspector's recommendation at Los Angeles and in line with the thoughts concurred in by some Agents in Charge at the security conference, it is recommended that these cases all be placed in a pending inactive status and retained in this condition.

FBI READY FOR REDS

WASHINGTON—The FBI is set to gobble up all U.S. resources the instant that general war breaks out. This was revealed by chief G-man J. Edgar Hoover at a meeting of the Senate Appropriations Subcommittee considering his budget. He has asked for additional funds to cope with the problem of the Communists going underground.



“What would be the situation in the event of war with Russia?” asked Sen. Pat McCarran (D) Nev. “Are you prepared to take care of the Communists in this country?”

“We are,” replied Hoover. “We are all set and ready. We are prepared to round up approximately 12,000 of the party’s key members.” “Do you know who they are and where they are?” “We do,” said Hoover. “We have a complete index on all of them and we keep it up to date constantly. We’ve been doing that for a long time. It’s not an easy job, but we consider it one of our most important ones. The security of the nation

is at stake and we are taking no chances with this element.” Note: When Gen. Bedell Smith quits as head of the Central Intelligence Agency, Hoover may be his successor. This has long been urged on President Truman. Hoover is superbly equipped for the post and should have had it a long time ago. Only Pentagon jealousy has kept him from getting it.

BATTLE SALVAGE

Lt. Gen. Matthew Ridgway, battle commander in Korea, not only is mopping up the enemy but he is also mopping up behind U.N. lines.

Ridgway has set up special salvage details for the specific purpose of collecting equipment, clothing, munitions and other supplies discarded or lost temporarily by U.N. troops.

Besides saving millions of dollars, there is also the important factor of keeping this material out of enemy hands. It is common to find dead and captured Communist troops wearing parts of U.S. uniforms and equipped with U.S. weapons. After a recent engagement, three-fourths of a Chinese battalion that was wiped out was found armed with American guns and grenades—apparently all salvaged from battlefields.

In those cases where Bureau authority has been granted to interview individuals who were the subjects of Security Index Cards or who were known to be members of the Communist Party, the question has arisen as to what duty the interviewing agents have to discharge in connection with advising subject of his right to counsel and other initial procedures normally observed in criminal cases. It would seem the two foremost reasons for conducting such interviews are: 1) To obtain information concerning the Communist activities of persons of the subject's acquaintance; and 2) To determine the subject's potentialities as an informant.

These interviews would, of course, deal also with the Communist activities of the subject concerned and in this respect, if the subject is cooperative, it is likely that at a future date the testimony of the interviewing agents might be utilized in a denaturalization, deportation, Smith Act or other case prejudicial to the subject's interests. Should such occur, the manner in which the interview was conducted and the signed statement obtained would be subject to examination by the court.

Upon being advised he does not have to furnish any statement, that any statement furnished may be used against him, and his right to have counsel, it is believed that most subjects would develop an uncooperative attitude, thereby defeating the two major reasons for conducting the interview.

It is requested that the Bureau furnish its policy in this regard in order that future interviews of this nature may be handled accordingly.

You are advised that all interviews conducted by Bureau Special Agents must be handled in such a manner that there will be no basis for an allegation that the constitutional rights of the persons interviewed were violated.

Interviews, such as those referred to in your letter, must be planned in accordance with the information available to you concerning the person to be interviewed and the interviews should be handled by personnel thoroughly experienced in Communist investigations.

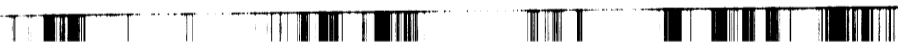
In conducting interviews with members of the Communist Party, or former members, the Bureau desires to point out that it is not mandatory that a signed statement be obtained.

In those instances where from the facts available it is obvious to your Office that prosecution may be expected at a later date you should, of course, handle this type of interview in strict compliance with existing Bureau instructions.

(C) DELINQUENCY IN SECURITY INVESTIGATIONS: The increasing delinquency which has developed with respect to our security investigations since the outbreak of the Korean situation has become a matter of considerable concern to me. International developments dictate that the most important investigative work in the Bureau today is in the security field. Yet, a review of the monthly administrative reports reflects that in most offices it is the most delinquent.

I realize that demands on the field during recent months have been heavy and as part of our over-all program to meet the problems which confront us additional investigative personnel is being obtained as rapidly as possible and efforts are being made to streamline and cut down where possible on our applicant programs. In the meantime, in order to assist you in coping with your increased case load, you have been previously authorized to assign cases to certain approved police agencies. Many of you have failed to utilize this means to best advantage. This indicates a serious lack of planning and initiative on your part which must be promptly corrected by making appropriate assignments to approved police departments.

It should be obvious to you that continual stress must be placed on security investigations and you must take positive action now to meet more adequately the tremendous responsibilities placed upon the Bureau in this field. It has been and will continue to be necessary for the Bureau on occasion to issue instructions regarding expeditious attention to be afforded matters other than security cases. Despite this fact, it is essential that through proper administration, you devise ways and means of bringing your security cases into a current status.

You must immediately carefully review the condition of security investigations in your office and place into effect a program designed to reduce the delinquency in that field. The details of your program must be set forth in a letter submitted to reach the Bureau by April 20, 1951.

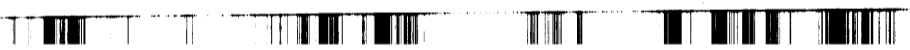

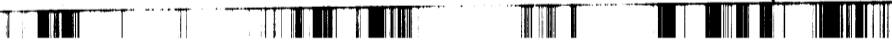

Advice is requested of the Bureau relative to the maintenance of SI Cards on subjects of Chinese racial extraction in the San Francisco Division in view of the following considerations:

1. In implementation of instructions contained in Bureau Bulletin #63, Series 1950, dated 11/16/50, it has been noted in the San Francisco Division that subjects of Chinese racial extraction warranting inclusion in the Security Index are associated through residence, employment or social contact with the close knit society of San Francisco's Chinatown and for the most part are associated directly in pro-Communist activity with one another. In view of the apparent ease with which such subjects may quickly learn of arrests of their associates, many hide themselves among cooperative family members, friends, Tongs, and associations within the confines of San Francisco's Chinatown, and many use the effective cover provided in the passive resistance displayed by most Chinese to fugitive investigations, it is felt that measures should be taken to minimize the amount of time for flight afforded to the particular SI subjects in the event of proposed detention.

Listed below are the SI subjects of Chinese racial extraction in this division at the present time, together with those subjects on whom recommendations for inclusion in the Security Index have been submitted to the Bureau: Further designated are the tabs for DETCOM and CCMSAB pertaining to these subjects.

The most frequent contacts of the New York Office with this squad are through Lieutenant [redacted], Detective [redacted], and Detective [redacted], both of whom are very cooperative.

The entire Special Services Section of the New York Police Department, which includes this section as well as numerous other special sections of the department, is under [redacted] who is likewise very cooperative and has been for several years with the New York Office.

With reference to the program of advising the state authorities of individuals on the security index list who may be working in vital facilities with the state or local authorities, Mr. [redacted] advises they have not as yet furnished any information to the New York authorities; that they have just completed the review of all their files in the security index list and will have approximately 30 recommendations which are now being dictated to submit to the Bureau; that there are approximately 30 working for the board of transportation, two with the Brooklyn Union Gas Company, and one with the bus lines. - GENERAL

PURPOSE:

To obtain your approval for the attached proposed SAC Letter instructing the Field with regard to action to be taken in three phases of security investigations and handling of the Security Index.

BACKGROUNDTransfers of Key Figures and Top Functionaries Between Field Divisions

In the past, when a Key Figure or Top Functionary has transferred from one Field Division to another, he has been deleted from that classification in the old office of origin and at the Bureau. He has not been considered as a Key Figure or Top Functionary in the new office of origin unless the new office of origin has advised the Bureau that he is being so classified in that office. In many instances such cases have reverted to the Security Matter - C classification and have been closed out in the new office.

I believe that a person of such importance should continue to receive such classification in the new office until that office determines through investigation that the subject is no longer of importance in the Communist movement. We can accomplish this by continuing the subject as a Key Figure or Top Functionary in the new office until investigation reflects his position in the Communist movement to no longer be of importance.

Security Index - Tabbing for Detcom and Comsab

In the past, we have been receiving Forms FD-122 at the Bureau designating Security Index subjects for priority apprehension under the Detcom and Comsab classification. When these forms are received they do not, in many instances, reflect the reason for the priority tabbing. This causes considerable supervisory time to be expended in reviewing the case files of the individuals concerned to determine the reason for the priority designation.

I believe it advisable that the Field be instructed to include a brief statement at the bottom of the Form FD-122 as to the reason for the designation of a subject for Detcom and Comsab.

Security Index - Transfers of Security Index
Cards Tabbed Detcom and Comsab

In the past, when the office of origin, in a case where the subject has been tabbed in the Security Index Detcom and Comsab, has been changed, these priority designations have been deleted in the Field and at the Bureau. Those subjects have not been considered for priority apprehension unless the new office of origin has submitted an FD-122 recommended such a designation.

I believe that a person who was considered sufficiently dangerous in the old office of origin to receive priority designation for apprehension should continue to be so designated in the new office of origin at least until the new office has determined that such classification is no longer warranted.

SUGGESTION REGARDING FORM FD-128 AND SECURITY FLASHES

Study - GENERAL

It has been noted that there are a considerable number of subjects moving from one Division to another, necessitating the use of Form FD-128, wherein there also has been placed a Security Flash in the Identification Division.

It is suggested that Form FD-128 be amended to include for notation, when appropriate, information that a Security Flash has been placed by the office surrendering origin. If this were done, this information would be immediately available to the new office of origin, and at the Bureau the FD-128 could be routed to the Identification Division in order for that Division's records to reflect the office currently having the interest and responsibility as office of origin.

This would eliminate the necessity for writing a separate letter for the attention of the Identification Division, with copy to the new office of origin. By being a part of the form itself it is felt that the fact that a security flash has been placed would less likely be overlooked when office of origin is changed in security cases.
