- Actions: JBA AFDCB sent notification letter to Capital Hemp informing them they were being considered to be placed off-limits. Given till 19 Dec to take corrective action.

MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Potomac River Off-Limits Areas

1. Since 1984, the area along the Potomac River that extends from Sycamore Island to Chain Bridge has been officially off-limits to U.S. Army Military District of Washington (MDW) personnel due to the drowning deaths of several Old Guard soldiers in that area.

2. At the time of the soldiers' deaths, the Brookmont Dam, located within the off-limits area, created a hydraulic effect that caused the water to deflect into a circular motion. Anyone or anything caught in this effect was trapped. The soldiers' raft was caught in a strong undertow and overturned. Since that time, the Army Corps of Engineers has spent millions of dollars correcting this problem.

3. The Armed Forces Disciplinary Control Board (AFDCB) recently reviewed this issue. It was noted that the State of Maryland enacted a law stipulating that the only off-limits area (except for boaters wearing approved flotation devices) begins 100 yards upstream from the Brookmont Dam and extends downstream to western Maryland and the District of Columbia boundary line. A recommendation was made by the AFDCB to adopt the same off-limits area as the State of Maryland.

4. This memorandum rescinds the previous order concerning off-limits areas along the Potomac and adopts the off-limits area as governed by Maryland law for MDW personnel.

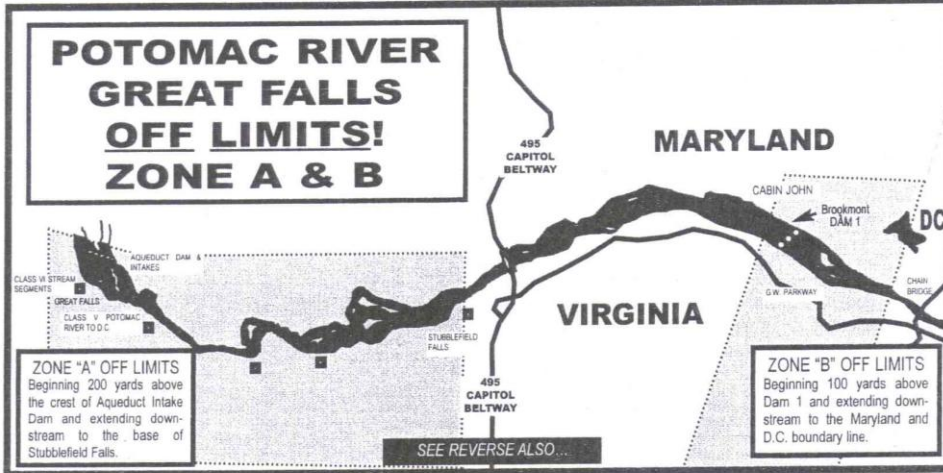
