- Proposals should provide a clear benefit that can be demonstrated via prototype or field test within about 1 year

Broad Agency Announcement Process

- Issued under FAR 35.016 and 6.102(d)(2)(i)
- Does not commit the Government to make an award or pay proposal preparation costs
- Open until September 30, 2010

- Government available to commence evaluations beginning July 6, 2010
- Proposals must be valid for at least 90 days
- Proposals will be evaluated on their own merit according to the criteria stated in the BAA, not against other proposals

Broad Agency Announcement Process

Proposal Preparation Instructions

- Quality is more important than quantity of information
 - Technical volume is limited to 50 pages
 - Charts, diagrams and similar representations count towards the page limit
 - Hyperlinks are not allowed

Instructions, Continued:

- Firm Fixed Price (FFP) contracts preferred
- Offerors must be registered in the Central Contractor Registry (CCR)
- Proposals must be submitted electronically to vai2baa@va.gov

Evidenced Based Practice:

- VA is interested in solutions that will support evidenced based practice with access to treatment algorithms and the expansion of remote assistive technology, regardless of location.
- These efforts will help bridge geographical barriers to allow VA to provide the right treatments in the right places at the right times.

- Portable interfaces to

- Real time bidirectional data exchange
- Interactive programming to user entries
- Wireless communications
- Videoconferencing

- Human factors, ergonomic and usability design

Dynamic Treatment Algorithms:

- VA, DOD, and the private sector have expanded the availability of evidence-based clinical practice guidelines for rehabilitation.
- VA is interested in maximizing utilization of these guidelines through technology.
- Consideration should be given to:
 - provider collaboration and outreach to allow real-time exchange of data between providers working on shared cases,
 - Interactions between patient and multiple providers,
 - and central documentation of results.

Home Monitoring for Severe and Challenging Disabilities:

OUALITY

- Veterans with severe disabilities may benefit from specialist recommendations for home modifications based on continual home monitoring.
- Injuries like Traumatic Brain Injuries and mental health conditions cannot be easily measured with traditional vital statistics.
- Solutions that can track difficult to monitor symptoms of these conditions are of interest.

Symptom-Based Medication Guidance:

- Guidelines for treating mild, moderate, and severe Traumatic Brain Injury (TBI) are evolving thanks to increased research and collaboration.
- A mobile, dynamic, and reactive technology that can put guidelines in the hands of clinicians at the point-of-care could increase the their utilization.
- VA is also interested in a solution that will allow collaboration between providers on complex cases.

Assistive Technology (AT):

OUALITY

- Veterans are frequently provided with assistive technologies such as augmentative communication, specialized mobility, etc.
- Training for these devices occurs at the prescribing clinic but sometimes needs change once the device is used in a home setting.
- VA is interested in solutions to monitor use, provide on-going training, and further evaluate AT needs remotely.
