1. ON 27 OCT 2004, THE US DISTRICT COURT FOR THE DISTRICT OF COLUMBIA PLACED AN INJUNCTION ON MANDATORY ANTHRAX VACCINATIONS

(REFS A AND B). ON 10 DEC 04, THE DEPUTY SECRETARY OF DEFENSE

DETERMINED THERE WAS SIGNIFICANT POTENTIAL FOR AN EMERGENCY INVOLVING AN ATTACK WITH ANTHRAX TO UNITED STATES MILITARY FORCES.

ON 27 JAN 05, THE FDA ISSUED AN EUA FOR PREVENTION OF INHALATION

ANTHRAX (REF C). ON 6 APR 05, THE US DISTRICT COURT FOR THE DISTRICT OF COLUMBIA MODIFIED ITS INJUNCTION AGAINST ANTHRAX VACCINATIONS AND, AS A RESULT, THE SECRETARY OF DEFENSE DIRECTED

THE MILITARY SERVICES TO RESTART THE ANTHRAX VACCINE PROGRAM IN

ACCORDANCE WITH THE GUIDELINES OF THE EUA (REF D) FOR A PERIOD

EXPIRING NLT 27 JUL 05, UNLESS EXPLICITLY EXTENDED.

- 2. AT THIS TIME, ONLY COAST GUARD PERSONNEL ASSIGNED TO SPECIFICALLY DESIGNATED COMMANDS MAY RECEIVE THE ANTHRAX VACCINATION UNDER THE EUA GUIDELINES.
- A. DESIGNATED COMMANDS INCLUDE: COAST GUARD PERSONNEL SERVING IN
- US CENTRAL COMMAND (USCENTCOM) AREA OF RESPONSIBILITY OR US FORCES
- IN KOREA FOR 15 OR MORE CONSECUTIVE DAYS, THE STRIKE TEAMS (PREVIOUSLY DESIGNATED AS SPECIAL MISSION UNITS), AND OTHER UNITS

EXPLICITLY DESIGNATED BY CG-1121.

B. VACCINATIONS FOR PERSONNEL WITH ORDERS TO THESE LOCATIONS OR

UNITS MAY BEGIN UP TO 60 DAYS BEFORE DEPARTURE.

3. IAW REFS C AND D, THE COAST GUARD MAY RESUME ANTHRAX VACCINATIONS FOR PERSONNEL ASSIGNED TO DESIGNATED COMMANDS BUT ONLY

UNDER THE CONDITION THAT PERSONNEL SCHEDULED TO RECEIVE THE ANTHRAX

VACCINATION MAY ACCEPT OR REFUSE THE VACCINATION. PERSONNEL REFUSING THE VACCINATION WILL NOT BE PUNISHED. NO DISCIPLINARY

ACTION OR ADVERSE PERSONNEL ACTION WILL BE TAKEN. PERSONNEL WILL

NOT BE PROCESSED FOR SEPARATION AND THERE WILL BE NO PENALTY OR

LOSS OF ENTITLEMENT FOR REFUSING THE ANTHRAX VACCINATION. PERSONNEL

WHO REFUSE THE ANTHRAX VACCINATION REMAIN DEPLOYABLE.

4. TO ENSURE THE EUA REQUIREMENTS ARE FULFILLED, DISTRIBUTION OF

THE ANTHRAX VACCINE WILL BE LIMITED TO SITES WHERE COMMAND-DESIGNATED OFFICERS AFFIRM THEY HAVE READ THE EUA REOUIREMENTS AND

WILL ENSURE THEY ARE FOLLOWED. IN ORDER TO VACCINATE THOSE ELIGIBLE

PERSONNEL IN 2.A., IT IS ANTICIPATED THAT THE CLINICS AT TRACEN

CAPE MAY, TRACEN PETALUMA, ATC MOBILE AND ISC PORTSMOUTH WILL BE

DESIGNATED AS VACCINATION SITES.

5. EXCEPT AS NOTED IN 2.A. ABOVE, OR UNLESS NOTIFIED BY CG-1121,

ANTHRAX VACCINATIONS ARE STILL UNAUTHORIZED FOR COAST GUARD PERSONNEL. ONLY THOSE UNITS NOTIFIED BY CG-1121 WILL PARTICIPATE IN

THE EUA PROGRAM.
