SUBJECT: Integrated Program Management Report (IPMR) Data Item Description (DID)

Earned Value Management is one of the Department's most powerful program management tools since it integrates the cost, schedule, and technical performance of a program. However, all too often cost and schedule reporting have been analyzed separately by different organizational structures not allowing for the full integration intended by the ANSI/EIA-748 standard and the principals of sound integrated program management.

The attached IPMR DID takes a major step towards improving the integration of cost and schedule reporting by combining the Contract Performance Report (CPR) and Integrated Master Schedule (IMS) into a single integrated report to be consistent with good, disciplined program management. Formats 1-7 of the DID are required for contracts where DFARS 252.234-7002 applies. Format 6 applies to all development, major modification, and low rate initial production efforts whether or not DFARS 252.234-7002 is applicable. The IPMR DID becomes effective for all applicable future contracts that are awarded based on solicitations or requests for proposal issued on or after July 1, 2012.

The attached IPMR DID supersedes the July 2005 CPR DID and the July 2005 IMS DID. It was developed in accordance with MIL-STD-963B Department of Defense Standard Practice Data Item Descriptions to ensure uniform procedures for the preparation of cost and schedule reports throughout the Department.
