SUBJECT: Policy Memorandum #15, Directorate of Family and Morale, Welfare and Recreation (DFMWR) Honorary Membership Policy for Club Meade

1. Reference: Chapter 8-24, AR 215-1, 24 September 2010, Morale, Welfare, and Recreation Activities and Nonappropriated Fund Instrumentalities.
2. The purpose of this memorandum is to provide guidance with respect to honorary membership with Club Meade, Fort George G. Meade.
3. Honorary membership may be extended to the following:
  - a. Recipients of the Medal of Honor, honorably discharged Veterans of the military services with one-hundred percent service connected disability, and their surviving spouse and family members. Dues will not be charged.
  - b. Unremarried surviving spouses of military personnel who died while on Active Duty or in retired status. Dues will not be charged.
  - c. Former POWs and spouses of POWs and service members missing in action. Dues will not be charged.
  - d. Individuals who have distinguished themselves in direct association with or in support of the Army, as determined by the local commander. These may include members of Congress, local or state government officials and civilian community leaders. As determined by the local commander, individuals in this group may or may not be required to pay dues.
4. This policy memorandum supersedes Policy Memorandum #15, Fort George G. Meade Community Operations Division Honorary Membership Policy, 25 October 1998.
