

**Additional Items from Uniform Board #44  
as referenced by ALCOAST 291/11**



**1. The following items were reviewed and held for further review and determination at a later date.**

- A. Request for members that complete Pharmacy School be authorized to wear the Air Force Enlisted Medical Badge.
- B. Uniform change for the President's Hundred Marksmanship Award.
- C. Authorization request to wear the RFMC Badge on the ODU uniform.

**2. The following uniform board items were reviewed and disapproved:**

- A. More guidance on what items are authorized to be carried in the ODU pockets.
- B. Standardize what type and how many electronic devices can be worn while in uniform.
- C. Request to change the color of the Combination Cap Cover for E6 and below.
- D. Recommendation to revamp the whole Service Dress Blue uniform.
- E. Recommendation to change the current Tropical Blue Shirt.
- F. Recommendation to return to the white crew neck undershirt.
- G. CG Fishing Vessel Safety Program request to wear a standard polo shirt for all inspectors.
- H. Recommendation to adopt a CG version of the Air Force Woman Beltless Dress Trousers.
- I. Request to set precedence for the Surfman, Coxswain, and Boat Forces insignias.
- J. Request to redesign the current Cuttermans insignia.
- K. Recommendation to change the current policy of only allowing one embroidered insignia on the ODU.
- L. Recommendation to change the current policy regarding who can wear the Naval Surface Warfare insignia.
- M. Request to create a Boat Crew Coverall modeled after the Air Crew Flight Suit.
- N. Request to authorize a unit t-shirt for periods of warm weather.
- O. Request to standardize light duty shoes.
- P. Several requests to change and or update the current policy regarding hair (ponytails, dread locks, and multiple hair buns).
- Q. Request to have the button holes on the light blue shirts changed.

- R. Recommendation to change the current ODU to something similar to the new Navy uniform.
- S. Recommendation to allow a sew-on past officer device on the ODU uniform for CG Auxiliary.
- T. Request to allow aviation personnel to wear the leather flight jacket in lieu of the Eisenhower jacket. The G-1 leather jacket is still authorized and limited in use by aviation personnel in approved flight status and performing flight duties while wearing the Aviation Flight Suit.
- U. Request that members clothing allowance be given to the UDC.
- V. Bring back the air for Garrison Cap for females.
- W. Recommendation to remove authority to wear two insignias on the Camouflage Utility Uniform.
- X. Request to develop a CG Auxiliary white t-shirt to replace the blue one.
- Y. Recommendation to further regulate what boots can be worn. Due to safety issues commands should be diligent in making sure members boots meet the standards set for in 3.C.10 of REF A.
