NOTE: Data have been revised to reflect 2011 benchmark levels. Estimates subsequent to the current benchmark are preliminary and will be revised when new information becomes available. Areas in the six New England states are Metropolitan New England City and Town Areas (NECTAs), while areas in other states are county-based. Some metropolitan areas lie in two or more states.
