

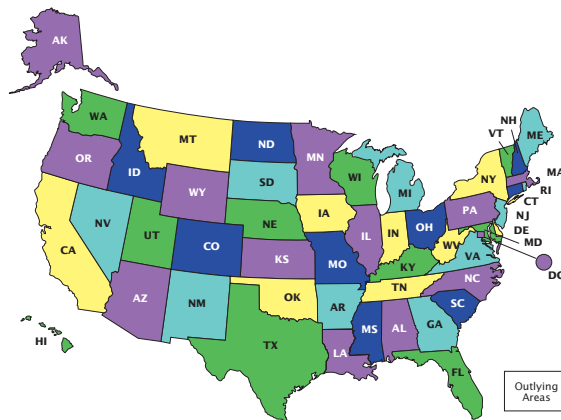
Finding Census Data Locally

State Data Center Program

Most U.S. Census Bureau data are available through the Census Bureau's Internet home page, www.census.gov. In addition, there are numerous outlets locally where the public can view reports, request printouts of tabulations, or otherwise obtain assistance in accessing, understanding, and using Census 2000 information. These local outlets include State Data Centers (SDCs), Census Bureau Regional Offices; public and academic libraries; state, local, and regional agencies; chambers of commerce; and not-for-profit and community organizations.

Census Depository Libraries

The Census Bureau has designated (123) libraries throughout the country as Census Depository Libraries (CDLs). The libraries are located in cities with a population greater than 25,000 and are not in a Metropolitan Statistical Area served by a Federal Depository Library (FDL). Just as the FDLs, the CDLs receive Census Bureau publications, CD-ROMs, and information free of charge and in exchange, provide local, public no-fee access, and assistance in using the information.
