Through a delegation of authority granted by the General Services Administration, the Department of Veterans Affairs (VA) National Acquisition Center (NAC) manages nine (9) Federal Supply Schedule (FSS) programs for all medical related products, services, and pharmaceuticals under FSC class 65, 66 and 621. Contracts awarded under these programs are used by Federal agencies to meet the needs of their customers.

Multiple Award Schedule Contracts

The VA Federal Supply Schedule Program establishes long-term Government-wide contracts awarded to responsible commercial companies at established prices, terms, and conditions. These contracts provide eligible buyers with a simplified process for obtaining more than 1 million commercial supplies and services. By placing orders directly with awarded VA FSS contractors, federal customers are able to obtain virtually any commercially available medical service or supply by choosing among thousands of vendors.
