AN IMPORTANT MESSAGE FROM THE JOINT BASE MYER – HENDERSON HALL SEXUAL ASSAULT RESPONSE COORDINATOR:

Welcome to The National Capital Region, Joint Base Myer - Henderson Hall. Our pledge and obligation is to create a relentless workforce that eradicates Sexual Harassment and Sexual Assault from our community and the Department of Defense. Sexual Harassment and Sexual Assault is taken very seriously and it is critical that we uphold an absolute zero tolerance for this dishonorable behavior/action. If you have been, or know of a Soldier, family member, or DA Civilian who is a victim of Sexual Harassment or Sexual Assault and needs help; please contact your Unit Victim Advocate, Installation Chaplain, SARC, or Crisis Hotline immediately. DO NOT WAIT. You are not alone. Together, we will be the force in the fight! In accordance with the Department of the Army Sexual Harassment Assault Response & Prevention Program, we encourage you to allow your Unit Victim Advocate to support you as necessary. However, it is your right to contact any agency or person listed below. You have two options for reporting Sexual Assault (Restricted and UN restricted). Restricted Reporting allows a service member who has been sexually assaulted to confidentially disclose the details of the assault to the SARC, VA, JAG, Chaplain, or Health Care Provider and to receive medical treatment, counseling, and victim advocacy without triggering the official investigative process. Unrestricted is all of the previous mentioned

services to include notification to the Commander, which will result in a full investigation. <u>It is your option!</u>
