#### The Captain's Corner

#### **Building Updates**

Mr. Brandt, Chief NMC-3 reports that significant progress occurred over the last week. He had the opportunity to take several pictures which he has posted on NMC's public drive. The construction schedule's objective is the completion of the 3rd floor and will work downwards from there. The contractor will be lighting off a generator to get the HVAC system on line so that they can complete finish work, again starting work from the top floor down. As you can see on the posted picture, the outside of the building has transformed its appearance, but is still missing some final touches. Work is also being done on the parking lot and the curbs are about 40% done. After completion of that part, paving of the area is to follow. Mr. Brandt also noted that one critical element is the electrical and phone connections to the building. The contractor is vigorously engaged in completing this task by blasting rocks and clearing the right of way from Route 9 to the building. Last but not least, the furniture installation is slated to begin on 12 November, starting at the top floor and working down. At this point, the contractor is ahead of schedule, even though much needs to be completed.
