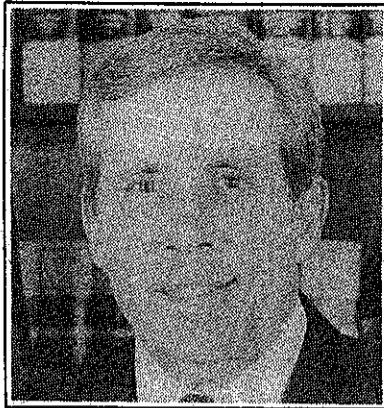

Congressman Wolf's Voting Record

SECOND SESSION, 100th CONGRESS - JANUARY 25-OCTOBER 22, 1988

Dear Friends:

Continuing my practice of making my complete voting record available to the people of the 10th District of Virginia, this report includes the votes I cast for the second session of the 100th Congress. This record has been mailed to 10th District citizens each year since I began serving in the House of Representatives in 1981. Very few members of Congress publish comprehensive voting records, but I believe it is important for you to know how I have voted on all matters coming before Congress.

There were 465 roll call votes during the second session of the 100th Congress, which convened on January 25 and adjourned on October 22, 1988. Of those 465 roll calls, I cast 459 votes for a voting attendance record of 99 percent. The 465 roll calls included 50 procedural votes such as approving the Speaker's journal, quorum calls and motions to adjourn. Because of space limitations, those procedural votes are not listed in this record. To assist you in understanding the terminology used in the legislative process, a glossary of terms used in this report to describe the votes is listed on page 2.

This report is arranged by general subject areas as follow: each vote begins with the roll call number, followed by the number of the bill or

resolution being considered and a short description of the question on which the vote was taken, including amendments, motions and passage. Next my own vote on the measure is listed by a "yes" or "no." The vote of the entire House of Representatives, indicated by "passed" or "failed" and the vote total, follow. The date on which the vote occurred is listed at the end. Votes taken under suspension of the rules are indicated and an explanation of that procedure may be found in the glossary.

As the 101st Bicentennial Congress begins its work, I encourage you to share your views on the important and challenging issues facing our district and the nation. I hope you will find the voting record information helpful and that you will share your comments with me on this report and other matters of interest and concern to you.

(241) H.R. 5026, to appropriate \$189,086,000 in new budget authority and \$125,300,000 in transfer authority for the Labor, Transportation, Justice, Defense and Agriculture departments to cover certain expenses for FY 1988. Yes. Passed 357-54. 7/27/88.

(289) H.Res. 524, rule to consider Senate amendments to H.R. 5026, dire emergency supplemental appropriations for FY 1988. Yes. Passed 274-52. 8/11/88.

(290) H.R. 5026, to agree to the Senate amendments to the bill providing \$672 million in dire emergency supplemental appropriations for FY 1988 for veterans' benefits, and additional funds for welfare assistance, black lung benefits and state unemployment offices. Yes. Passed 270-32. 8/11/88.

(32) S. 2151, to amend the Agricultural Act of 1949 to facilitate participation by voluntary and nonprofit agencies and cooperatives in

(189) H.R. 4784, agriculture appropriations for FY 1989. Motion that the Committee of the Whole rise and report the bill back to the House. No. Passed 310-88. 6/16/88.

(190) H.R. 4784, on passage of the bill to appropriate \$44.1 billion in FY 1989 for the Agriculture Department's agriculture, rural development and nutrition programs, and for several related agencies. Yes. Passed 343-54. 6/16/88.

(246) H.Res. 504, rule to consider H.R. 5015, Drought Assistance Act of 1988. Yes. Passed 345-63. 7/28/88.

(247) H.R. 5015, Drought Assistance Act. Amendment as a substitute to allow a 50-cent price-support increase for dairy farmers—the increase was provided by the committee bill—only for a three-month increase was provided by the committee bill—only for a three month period from April 1 to June 30, 1989. (Note: the original amendment would have deleted the 50-cent price-support increase from the bill). No. Passed 246-155. 7/28/88.

(248) H.R. 5015. Amendment to allow a 50-cent price-support increase for dairy farmers for three months from April 1 to June 30, 1989. Yes. Passed 217-181. 7/28/88.

(398) H.R. 5199, to make non-mailable any plant, fruit, vegetable or other matter, the movement of which in interstate commerce has been prohibited or restricted by the Secretary of Agriculture in order to prevent the dissemination of dangerous plant diseases or pests. Yes. Passed 415-2, under suspension of rules. 10/4/88.

(406) H.R. 5318, to amend the Egg Research and Consumer Information Act to limit the total costs that may be incurred by the Egg Board in collecting producer assessments and having an administrative staff, to scrap egg producer refunds, and to delay any referendum by egg producers on the elimination of such refunds. Yes. Passed 416-2, under suspension of rules. 10/4/88.

(407) H.R. 4724, to direct the Secretary of Agriculture to release a reversionary interest of the U.S. in certain land located in Oktibbeha County, Miss. Yes. Passed 418-1, under suspension of rules. 10/4/88.

(408) H.Res. 564, to concur in the Senate amendments to H.R. 4345, to amend the U.S.

Grain Standards Act to extend, through Sept. 30, 1993, authority to charge and collect inspection and weighing fees. Yes. Passed 417-0, under suspension of rules. 10/4/88.

(418) H.R. 4028, to concur in the Senate amendment to the bill to authorize the Secretary of Agriculture to exchange certain lands in the Targhee National Forest. Yes. Passed 417-0, under suspension of rules. 10/4/88.

(419) H.R. 4354, to concur in the Senate amendment to the bill to authorize the Secretary of Agriculture to exchange certain National Forest System lands in Oklahoma for inclusion in the national wilderness system, and to establish the Winding Stair Mountain National Recreation and Wilderness Area. Yes. Passed 409-9, under suspension of rules. 10/4/88.

(444) S. 1081, to establish a coordinated National Nutrition Monitoring and Related Research Program and a comprehensive plan for the assessment of the nutritional and dietary status of the U.S. population and the nutritional quality of the U.S. food supply. (43) **H.Con.Res. 268.** Amendment as a substitute to freeze all discretionary outlays at FY 1988 level, eliminate all cost-of-living adjustments for entitlement programs, eliminate pay increase for federal employees in FY 1989, and specify a FY 1989 deficit of \$135.7 billion. No. Failed 64-354. 3/23/88.

(44) **H.Con.Res. 268.** Amendment as a substitute to hold discretionary outlays midway between a FY 1988 outlay freeze and levels established by the domestic budget summit, replace the cost-of-living adjustment for non-means tested entitlements with a \$5 per month increase, cap the FY 1989 pay increase for federal and military employees at 2 percent, provide for additional FY 1989 revenues to be derived from a one-year suspension of the indexing of individual income taxes, and specify a FY 1989 deficit of \$112.4 billion. No. Failed 27-394. 3/23/88.

(45) **H.Con.Res. 268.** On passage of the budget resolution to set FY 1989 ceilings of \$1.232 trillion in total new budget authority and \$1.098 trillion in total outlays and set a revenue floor of \$964.1 billion, for a FY 1989 deficit of \$134.1 billion, \$1.9 billion below the revised Gramm-Rudman-Hollings target of \$136 billion. Motion to instruct the House conferees on the FY 1989 budget resolution to negotiate a funding level that emphasizes the high priority of anti-drug programs but that nevertheless complies with discretionary spending caps and the revenue level agreed to in the November 1987 budget summit between the President and the joint leadership of Congress. (158) **H.Con.Res. 268,** to agree to the conference report on the congressional budget for the U.S. government for FYs 1989, 1990, and 1991. Yes. Passed 201-181. 5/26/88.

(265) **H.Res. 507,** rule to consider H.R. 4333, Miscellaneous Revenue Act. Yes. Passed 288-123. 8/4/88.

(266) **H.R. 4333,** to correct technical errors in the 1986 tax act and certain other tax laws, and make other revisions in tax law. Yes. Passed 380-25. 8/4/88.

(463) **H.R. 4333,** to agree to the conference report on the Miscellaneous Revenue Act making technical corrections relating to the Tax Reform Act of 1986. Yes. Passed 358-1, under suspension of rules. (Note: legislation includes provisions of H.R. 4526 [see Roll 279] relating to the legislative taking of 542 additional acres for the Manassas National Battlefield Park.)

BUSINESS & BANKING

(159) **H.R. 1212,** Employee Polygraph Protection Act. To agree to the conference report on the bill to outlaw the use of lie detector tests by private employers to deny any employee or prospective employee employment opportunities; the bill exempts federal, state and local governments, private employers engaged in government intelligence and counterintelligence work, security services, and drug manufacturers and distributors (and includes regulations for use of polygraph examinations with regard to these employees), and allows employers to use polygraphs in ongoing investigations involving economic loss or injury where the employer has reason to suspect the worker or workers involved. Yes. Passed 251-120. 6/1/88.

(218) **H.R. 4174,** to authorize funding levels for Small Business Administration programs for FYs 1989-91, including loan guarantees, direct loans and pollution bonds and the guarantee on surety bonds. Yes. Passed 342-40. 7/6/88.

(228) **H.Res. 491,** rule to consider S. 2527, Plant Closing Notification Act. No. Passed 258-155. 7/13/88.

(229) **S. 2527.** On passage of the bill to require employers of 100 workers or more to notify employees at least 60 days before ordering a plant closing or mass layoff and provide that employees who have not been notified in accordance with the bill may sue the employer in federal court for back pay and related benefits for each day of violation up to 60 days. No. Passed 286-136. 7/13/88.

(238) **S. 328,** to amend the Prompt Payment Act of 1982 (PL 97-177) to ensure timely payment of U.S. obligations to federal contractors and require that federal agencies pay penalties for late payment of bills to federal contractors. Yes. Passed 394-0, under suspension of rules. 7/26/88.

(314) **H.R. 5133,** to increase penalties for insider trading (the purchase or sale of securities while in possession of material information not

available to the general public), impose additional legal restrictions on securities firms, and require greater supervision of employees by securities firms to prevent insider trading. Yes. Passed 410-0, under suspension of rules. 9/14/88.

(381) **H.Con.Res. 351,** to agree to the Senate amendment to the resolution to make technical corrections to the Prompt Payment Act which would impose stiffer penalties on the federal government for non-timely payment of bills to private contractors. Yes. Passed 399-0, under suspension of rules. 10/3/88.

(385) **H.R. 5050,** to foster growth of women-owned small firms by, among other provisions, making it easier for such companies to obtain commercial bank loans. Yes. Passed 389-7, under suspension of rules. 10/3/88.

(386) **S. 437,** to permit firms that have certain capital-improvement loans obtained through the Small Business Administration to pay them back early without incurring large prepayment penalties. Yes. Passed 372-28, under suspension of rules. 10/3/88.

(394) **H.R. 5280,** to authorize the minting of gold and silver coins to commemorate the bicentennial of Congress, with revenue from surcharges on the sale of such coins to be earmarked to reduce the federal deficit. Yes. Passed 411-8, under suspension of rules. 10/4/88.

(436) **S. 2653,** to create a national commission to study the financial crisis in the savings and loan industry and report its analysis of the problem and proposed solutions to Congress and the president by Feb. 1, 1989. Yes. Passed 395-21, under suspension of rules. 10/6/88.

(441) **H.R. 2953,** to amend Title 28, U.S. Code, to permit the U.S. district courts to enjoin, suspend or restrain certain state ad valorem property taxes on interstate gas transmission property. Yes. Failed 219-197, under suspension of rules (2/3 vote required). 10/6/88.

(442) **H.R. 4646,** to require the Federal Savings and Loan Corporation to revoke the charter of the Federal Asset Disposition Association and reform the process for liquidating assets of failed savings institutions. No. Failed 247-130, under suspension of rules (2/3 vote required). 10/12/88.

(451) **H.R. 515,** to agree to the conference report on the bill to require issuers of credit cards to disclose clearly to customers the interest rates, fees, grace periods before interest charges begin to accrue and the method of calculating interest charges. Yes. Passed 342-5. 10/20/88.

(431) **S.J.Res. 364,** to designate Oct. 2-8, 1988, as "National Paralysis Awareness Week." Yes. Passed 413-1, under suspension of rules. 10/6/88.

(445) **H. Res. 574,** to commemorate the successful return to flight by the space shuttle Discovery. Yes. Passed 395-0, under suspension of rules. 10/12/88.

Glossary of Terms Used in Voting Record Report

AMENDMENT—A proposal of a member of Congress to alter the language, provisions or stipulations in a bill or in another amendment. It is usually printed, debated, and voted upon in the same way as a bill.

APPROPRIATIONS BILL—Provides the actual monies approved by authorization bills, but not necessarily the full amount authorized.

AUTHORIZATION BILL—Basic, substantive legislation that establishes or continues the legal operation of a federal program or agency, either indefinitely or for a specific period, or which sanctions a particular type of obligation or expenditure.

BILL—A legislative proposal, designated as H.R. in the House of Representatives and S. in the Senate, followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If enacted by both houses of Congress in the same form and signed by the President, a bill becomes a law.

COMMITTEE OF THE WHOLE—A procedural device designed to expedite the legislative work of the House in which slightly less formal rules for conduct of debate and voting on amendments apply.

CONCURRENT RESOLUTION—A resolution, designated as H.Con.Res. or S.Con.Res., passed by both houses of Congress not requiring or intended for approval by the President and therefore without the force of law. It is often used to express the "sense of Congress" on various foreign policy or domestic issues.

CONFERENCE—A meeting between the representatives of the House and Senate to reconcile differences between the two houses over provisions of a bill passed by both chambers. A majority of the members of the conference from each chamber must agree on the provisions of the bill before it can be considered by either chamber in the form of a "conference report." There it cannot be amended and if not approved, the bill may go back to conference or a new conference must be convened. Bills passed by both houses with only minor differences need not be sent to conference; either chamber may "concur" in the other's amendments, completing action on the legislation.

CONTINUING RESOLUTION—A joint resolution drafted by Congress "continuing appropriations" for specific ongoing activities of a government department or departments when a fiscal year begins and Congress has not yet enacted all of the regular appropriations bills for that year.

HOUSE—The House of Representatives, as distinct from the Senate, although each body is a "house" of Congress.

JOINT RESOLUTION—A resolution, designated H.J.Res. or S.J.Res., which requires the approval of both houses and the signature of the President, just as a bill does, and has the force of law if approved. It is generally limited to special circumstances. A joint resolution is also used to propose amendments to the Constitution. Under that purpose, it does not require a presidential signature and becomes a part of the Constitution when three-fourths of the states ratify it.

PREVIOUS QUESTION—A request for the previous question, or a motion on the previous question in the House brings to a vote the question of whether debate should end and the merits of the pending issue should be voted upon.

RESOLUTION—A simple resolution, designated H.Res. or S.Res., deals with matters entirely within the prerogatives of one house or the other. It requires neither passage by the other chamber nor approval by the President, does not have the force of law and is commonly used for internal business of that house or for expressing views of that house.

RULE—A resolution from the House Rules Committee, which, if adopted by the House, sets the procedures and time limits for debate and voting on a pending bill or resolution.

SUSPENSION OF RULES—Procedure in the House intended for the passage of non-controversial bills under which debate is limited to 40 minutes, no amendments from the floor are permitted, and a two-thirds vote of those members present is required for passage.

(141) H.R. 4587. Amendment to reduce the appropriations for salaries and expenses for the Office of the Speaker by \$300,000, and reduce each of the appropriations for salaries and expenses for the Majority and Minority leaders' and whips' offices by \$60,000. Yes. Failed 175-225. 5/19/88.

(142) H.R. 4587. Amendment to reduce the appropriation for official mail costs by \$20 million. Yes. Failed 168-232. 5/19/88.

(143) H.R. 4587. Amendment to reduce the appropriation for official mail costs by \$10 million. Yes. Failed 190-206. 5/19/88.

(144) H.R. 4587. Amendment to reduce the appropriation for official mail costs by \$5 million. Yes. Passed 206-188. 5/19/88.

(145) H.R. 4587. Amendment to reduce each appropriation in the bill by 1.6 percent. Yes. Failed 184-211. 5/19/88.

(146) H.R. 4587. Amendment to reduce the appropriation for the General Accounting Office by \$8.8 million. Yes. Failed 152-238. 5/19/88.

(147) H.R. 4587. Amendment to prohibit funds from being expended in any workplace that is not free of illegal use or possession of controlled substances which is made known to the federal entity or official to which funds are appropriated. Yes. Passed 286-98. 5/19/88.

(148) H.R. 4587. On passage of the bill to provide \$1.4 billion in FY 1989 for the House of Representatives and other legislative branch activities (excluding Senate funding). Yes. Passed 277-104. 5/19/88.

(274) H.Res. 500, to provide \$350,000 from the contingent funds of the House for further expenses of investigations by the Committee on Standards of Official Conduct in the matter of Speaker Jim Wright. Yes. Passed 408-0. 8/10/88.

(304) Appeal of the ruling of the chair. To rule that it would not be in order to consider a resolution providing for the recitation of the Pledge of Allegiance to the Flag each legislative day in the House of Representatives. No. Passed 226-168. 9/9/88.

(357) H.Res. 531, to provide \$550,000 for further expenses of investigations and studies by the Committee on Standards of Official Conduct in the second session of the 100th Congress. Yes. Passed 412-2. 9/23/88.

(365) H.R. 4587, to agree to the conference report on the bill to appropriate \$1.8 billion in FY 1989 for the legislative branch. Yes. Passed 253-133. 9/29/88.

(388) H.Res. 563, to give the Speaker of the House the authority to consider legislation under suspension of rules any day of the week for the remainder of the 100th Congress. No. Passed 249-160. 10/4/88.

(395) S.Con.Res. 137, to authorize the use of the Capitol Rotunda for a ceremony in honor of John F. Kennedy. Yes. Passed 420-0, under suspension of rules. 10/4/88.

(396) H.Res. 558, to amend the House rules to establish new anti-discrimination protections for House employees. Yes. Passed 408-12, under suspension of rules. 10/4/88.

(399) H.Con.Res. 115, to provide for participation by congressional delegations in an April 1989 ceremony in New York City marking the 200th anniversary of the implementation of the Constitution. Yes. Passed 421-0, under suspension of rules. 10/4/88.

(405) H.R. 5315, to reauthorize the Congressional Award Program to encourage community service among young people. Yes. Passed 417-1, under suspension of rules. 10/4/88.

(440) S. 2350, to clarify the investigatory

powers of Congress. No. Failed 245-172, under suspension of rules (2/3 vote required). 10/6/88.

DEFENSE & VETERANS AFFAIRS

(10) H.R. 1054, to allow members of the armed forces to sue the U.S. for damages for certain injuries caused by improper medical care. Yes. Passed 312-61. 2/17/88.

(55) H.Res. 422, sense of the House resolution to support the INF (Intermediate Nuclear Forces) treaty with the Soviet Union and to provide for the continued security of NATO. Yes. Passed 393-7, under suspension of rules. 4/19/88.

(67) H.R. 435, rule to consider H.R. 4264, Department of Defense authorization for FY 1989. Yes. Passed 343-56. 4/26/88.

(69) H.R. 4264, Department of Defense authorization for FY 1989. Amendment to express the sense of Congress that the Secretary of the Navy should name the next Trident submarine as the U.S.S. Melvin Price. Yes. Passed 407-0. 4/27/88.

(70) H.R. 4264. Amendment to prohibit the use of FY 1989 or prior year funds for Strategic Defense Initiative testing not permitted under the traditional interpretation of the 1972 ABM Treaty, as defined by the 1988 testimony of the Under Secretary of Defense for Acquisition. No. Passed 252-159. 4/27/88.

(71) H.R. 4264. Amendment to limit the number of U.S. multiple warhead ballistic missiles and cruise-missile carrying bombers to the number specified in the SALT II Treaty unless the President certifies that the Soviet Union has exceeded those limits. No. Passed 240-174. 4/27/88.

(72) S. 999, to improve veterans' employment, counseling and job-training services and programs. Yes. Passed 417-0. 4/27/88.

(73) H.R. 2616, to agree to the conference report on the bill to improve and expand veterans' health-care programs. Yes. Passed 416-0. 4/27/88.

(74) H.Res. 436, rule to provide for further consideration of H.R. 4264, Department of Defense authorization for FY 1989. No. Passed 223-183. 4/28/88.

(76) H.R. 4264, Department of Defense authorization for FY 1989. Amendment to provide \$100 million for the development of a ground-based kinetic anti-satellite weapon and prohibit testing of the weapon at altitudes higher than 800 nautical miles during FY 1989, unless the President certified to Congress that the Soviet Union had conducted such a test. Yes. Failed 195-212. 4/28/88.

(77) H.R. 4264. Amendment to permanently ban the testing of the miniature homing vehicle anti-satellite weapon against an object in space unless the President certified to Congress that the Soviet Union had conducted such a test. No. Failed 197-205. 4/28/88.

(78) H.R. 4264. Amendment to express the sense of Congress in support of the Administration's current nuclear testing negotiations. Yes. Passed 399-0. 4/28/88.

(79) H.R. 4264. Amendment to ban nuclear explosive tests with a yield exceeding one kiloton and to ban tests conducted outside designated test areas, as long as the Soviet Union observes the same ban. No. Passed 214-186. 4/28/88.

(81) H.R. 4264. Amendments en bloc consisting of 43 separate amendments. Yes. Passed 367-4. 4/29/88.

(82) H.R. 4264. Amendment to prohibit contracting out any base support function at Air Force Reserve bases to private contractors. No. Failed 131-229. 4/29/88.

(83) H.R. 4264. (181) H.R. 4775, treasury, postal service, general government appropriations for FY 1989. Amendment to exempt from a 4 percent federal pay increase those positions which pay more than \$72,500 annually. No. Passed 230-170. 6/14/88.

(182) H.R. 4775, on passage of the bill to appropriate \$16.1 billion in FY 1989 for the Treasury Department, the U.S. Postal Service, the Executive Office of the President and various independent agencies. Yes. Passed 301-96. 6/14/88.

(194) H.R. 4150, to remove the U.S. Postal Service from the federal budget. Yes. Passed 390-16, under suspension of rules. 6/21/88.

(250) S. 892, to remove the right of reversion

to the United States in lands owned by the Shriners' Hospitals for Crippled Children. Yes. Passed 365-0. 8/2/88.

(292) H.R. 4775, to agree to the conference report to appropriate \$16 billion in FY 1989 for the Treasury Department, the U.S. Postal Service, the Executive Office of the President, and 11 independent agencies, including the Office of Personnel Management. Yes. Passed 371-30. 9/7/88. (Note: the bill provides for a 4.1 percent pay raise for federal government employees - civilian and military - except members of Congress.)

(354) H.Res. 537, rule to consider H.R. 387, Federal Equitable Pay Policy Act. Yes. Passed 297-101. 9/27/88.

(358) H.R. 387, Federal Equitable Pay Policy Act. Amendment to provide for appointment of an additional five members of the commission to study federal equitable pay policies, with one each to be recommended by the secretaries of defense, health and human services, treasury, agriculture and interior. Yes. Failed 159-257. 9/28/88.

(361) H.R. 4720, to include members of the armed forces, civilian employees of the U.S. and their dependents stationed abroad in the decennial census and to define place of residence for the decennial census as "general abode" within the U.S. for a period of six consecutive months or longer. No. Failed 93-317, under suspension of rules. 9/28/88.

(362) H.R. 387, Federal Equitable Pay Policy Act. Amendment to provide for 14 members of the commission to study federal pay policies to be appointed by the President with consultation and recommendation of the majority and minority leaders of the Senate and the speaker and minority leader of the House, as well as certain membership conditions and compensation. No. Failed 115-284. 9/28/88.

(363) H.R. 387, to sustain a point of order against an amendment to include pay structures for congressional employees in the study provided for in the bill. No. Passed 251-150. 9/28/88.

(368) H.R. 387. Amendment to require the commission on federal equitable pay policy to use at least three different consultants to conduct the study provided for in the bill. No. Failed 111-285. 9/29/88.

(369) H.R. 387. Amendment to provide that the commission on federal equitable pay policy review all studies since Jan. 1, 1975, concerning pay scales of federal government employees, with particular attention to those studies involving groups dominated by a particular race, sex, or ethnic origin. No. Failed 106-289. 9/29/88.

(370) H.R. 387. Amendment to provide for advance review by the House Committee on Appropriations and the Congress of funds from the Office of Personnel Management general spending account which would be expended in furtherance of the provisions in the bill. No. Failed 122-273. 9/29/88.

(371) H.R. 387. On passage of the bill to establish a commission to conduct an 18-month study to determine whether the current federal job classification and pay system are designed and administered in accordance with the Civil Rights Act of 1964 and the Fair Labor Standards Act of 1938 (which prohibit discrimination based on sex, race, or national origin) and report its findings and recommendations to the President and Congress. Yes. Passed 302-98. 9/29/88.

(382) S. 496, to agree to the Senate amendment to the House amendment to the bill to establish new safeguards on government use of individuals' personal information. Yes. Passed 393-8, under suspension of rules. 10/3/88.

(383) H.R. 5052, to transfer custody and control of the General Accounting Office headquarters from the General Services Administration to the Comptroller General of the United States. Yes. Passed 400-0, under suspension of rules. 10/3/88.

(397) S. 508, to take the Office of Special Counsel out of the Merit Systems Protection Board and make it an independent agency to protect federal employees who expose waste and mismanagement. Yes. Passed 418-0, under suspension of rules. 10/4/88.

(400) H.R. 4712, to reauthorize for six years the Office of Government Ethics and make the OGE a separate executive agency. Yes. Passed 417-3, under suspension of rules. 10/4/88.

(429) S. 908, to agree to the conference report on the bill to create new inspectors general offices within the Departments of Treasury and Justice and other federal agencies. Yes. Passed 418-0. 10/5/88.

(446) H.R. 5043, to strengthen and clarify current law relating to post-employment restrictions for executive branch personnel and establish new post-employment restrictions for members of Congress and legislative branch staff. Yes. Passed 374-19, under suspension of rules. 10/12/88.

(459) H.Res. 601, rule to provide for agreeing with an amendment to the Senate amendment to H.R. 5043, to impose new lobbying restrictions on former members of Congress, former staff aides, and former high-level officials of the executive branch. Yes. Passed 347-7, under suspension of rules. 10/21/88.
